#### SCHEDULE

1. The operation of regulation 11 of the Media Emergency Regulations, 1988, is hereby suspended.
2. The suspension of the said regulation 11—
  - (a) shall lapse upon the repeal of regulation 1 of these regulations, whereupon the said regulation 11, subject to any amendment thereof, shall again become of force;
  - (b) shall not affect anything done before the suspension under the said regulation 11.
