#### BYLAE A

##### ALGEMENE ADMINISTRATIEWEREGULASIES WYSIGING

###### Woordomskrywing

1. In hierdie Bylae beteken "die Regulasies" die Algemene Administratieweregulasies, 1984, afgekondig by Goewermentskennisgewing R. 2206 van 5 Oktober 1984.

###### Wysiging van regulasie 15 van die Regulasies

2. Regulasie 15 van die Regulasies word hierby gewysig deur in paragraaf (b) van subregulasie (4) die uitdrukking "R5" deur die uitdrukking "R10" te vervang.

#### BYLAE B

##### ELEKTRIESE INSTALLASIEREGULASIES, 1985 WYSIGING

###### Woordomskrywing

1. In hierdie Bylae beteken "die Regulasies" die Elektriese Installasieregulasies, 1985, afgekondig by Goewermentskennisgewing R. 2270 van 11 Oktober 1985.

###### Wysiging van regulasie 10 van die Regulasies

2. Regulasie 10 van die Regulasies word hierby gewysig—

REGULATIONS UNDER THE MACHINERY AND OCCUPATIONAL SAFETY ACT, 1983 (ACT 6 OF 1983)

The Minister of Manpower has under section 35 of the Machinery and Occupational Safety Act, 1983 (Act 6 of 1983), made the regulations in the Schedules.

#### SCHEDULE A

##### GENERAL ADMINISTRATIVE REGULATIONS

###### AMENDMENT

###### Definition

1. In this Schedule "the Regulations" means the General Administrative Regulations, 1984 promulgated by Government Notice R. 2206 of 5 October 1984.

###### Amendment of regulation 15 of the Regulations

2. Regulation 15 of the Regulations is hereby amended by the substitution in subparagraph (b) of subregulation (4) for the expression "R5" of the expression "R10".

#### SCHEDULE B

##### ELECTRICAL INSTALLATION REGULATIONS, 1985

###### AMENDMENT

###### Definition

1. In this Schedule "the Regulations" means the Electrical Installation Regulations, 1985, promulgated by Government Notice R. 2270 of 11 October 1985.

###### Amendment of regulation 10 of the Regulations

2. Regulation 10 of the Regulations is hereby amended—

(a) by the addition of the following words to paragraph (a) of subregulation 1:

"and an amount of R25, payable in the form of uncancelled revenue stamps affixed to the application form"; and

(b) deur die volgende voorbehoudbepaling by subregulasie (2) te voeg:

"Met dien verstande dat die bedrag bedoel in paraaf (a) van subregulasie (1) nie in hierdie geval betaalbaar is nie."

#### **Wysiging van regulasie C. 100 van die Regulasies soos gewysig deur Goewermentskennisgewings R. 109 van 26 Januarie 1973 en R. 1035 van 22 Mei 1981**

Regulasie C. 100 van die Regulasies word hierby gewysig—

(a) deur paragraaf (a) van subregulasie (1) deur die volgende paragraaf te vervang:

"(a) Vir elke voorwaardelike permit of elke registrasiesertifikaat aan hom uitgereik ten opsigte van 'n stoomketel met 'n roosteroppervlak van—

Met dien verstande dat in die geval van 'n stoomketel wat geen standaardroosteroppervlak het nie, behalwe 'n elektries verhitte stoomketel, gelde op ondergenoemde grondslag betaalbaar is:

oor 5 m <sup>2</sup> en tot en met 25 m <sup>2</sup> .....

Met dien verstande voorts dat in die geval van 'n elektries verhitte stoomketel, 'n bedrag van R15 betaalbaar is, en dat waar 'n voorwaardelike permit uitgereik is vir die gebruik van 'n stoomketel, verdere gelde nie betaalbaar is vir die latere uitreiking van 'n registrasiesertifikaat nie";

(b) deur in paragraaf (c) van subregulasie (1) die uitdrukking "R2" deur die uitdrukking "R10" te vervang; en

(c) deur in subregulasie (2) die uitdrukking "R50,00" deur die uitdrukking "'n Bedrag van R100" ter vervang.

(b) by the addition of the following proviso to subregulation (2):

"Provided that the amount referred to in paragraph (a) of subregulation (1) shall not be payable in this case".

#### **Amendment of regulation 15 of the Regulations**

4. Regulation 15 of the Regulations is hereby amended by the substitution in subregulation (4) for the words "a registration fee of R10" of the words "an amount of R25".

#### **SCHEDULE C**

#### **REGULATIONS PROMULGATED BY GOVERNMENT NOTICE R. 292 OF 28 JUNE 1963**

#### **CHAPTER IV OF THE REGULATIONS**

#### **AMENDMENT**

#### **Definition**

1. In this Schedule "the Regulations" means the Regulations promulgated by Government Notice R. 929 of 28 June 1963.

#### **Amendment of regulation C. 100 of the Regulations as amended by Government Notices R. 109 of 26 January 1973 and R. 1035 of 22 May 1981**

2. Regulation C. 100 of the Regulations is hereby amended—

(a) by the substitution for paragraph (a) of subregulation (1) of the following paragraph:

"(a) For each provisional permit or each registration certificate issued to him in respect of a boiler with a grate area of—

up to and including 0,15 m <sup>2</sup> .....
over 0,15 m <sup>2</sup> and up to and including 0,75 m <sup>2</sup> .....
over 0,75 m <sup>2</sup> and up to and including 2,5 m <sup>2</sup> .....
over 2,5 m <sup>2</sup> and up to and including 5 m <sup>2</sup> .....
over 5 m <sup>2</sup> and up to and including 20 m <sup>2</sup> .....
over 20 m <sup>2</sup> .....
50:.....

Provided that in the case of a boiler which has no standard grate area, other than an electrically heated boiler, fees shall be payable on the following basis:

For a boiler with a heating surface of—

R
up to and including 5 m <sup>2</sup> .....
over 5 m <sup>2</sup> and up to and including 25 m <sup>2</sup> .....
over 25 m <sup>2</sup> and up to and including 75 m <sup>2</sup> .....
over 75 m <sup>2</sup> and up to and including 150 m <sup>2</sup> .....
over 150 m <sup>2</sup> and up to and including 600 m <sup>2</sup> .....
over 600 m <sup>2</sup> .....

Provided further that in the case of an electrically heated boiler, a fee of R15 shall be payable, and that where a provisional permit has been issued to permit a boiler to be used, further fees shall not be payable for the subsequent issue of the registration certificate";

(b) by the substitution in paragraph (c) of subregulation (1) for the expression "R2" of the expression "R10"; and

(c) by the substitution in subregulation (2) for the words "A fee of R50,00" of the words "A fee of R100".

**Wysiging van regulasie C. 123 van die Regulasies, soos gewysig deur Goewermentskennisgewing R. 2262 van 4 November 1977**

3. Regulasie C. 123 van die Regulasies word hierby gewysig—

- (a) deur in subregulasie (1) die woorde “R8 (agt rand) plus R1 (een rand) per uittreeplek” deur die woorde “R20 plus R2 per uittreeplek” te vervang.
- (b) deur in subregulasie (2) die woorde “R1 (een rand) vir elke bykomende uittreeplek” deur die woorde “R2 vir elke bykomende uittreeplek” te vervang;
- (c) deur subregulasie (3) te skrap.
- (d) deur in subregulasie (4) die uitdrukking “R10 (tien rand)” deur die uitdrukking “R100” te vervang; en
- (e) deur in subregulasie (5) die uitdrukking “R2 (twee rand)” deur die uitdrukking “R10” te vervang.

- (c) deur in subregulasie (3) die woorde “R10 (tien rand)” deur die uitdrukking “R100” te vervang; en
- (d) deur in subregulasie (4) die woorde “R2 (twee rand)” deur die uitdrukking “R10” te vervang.

**Amendment of regulation C. 123 of the Regulations as amended by Government Notice R. 2262 of 4 November 1977**

3. Regulation C. 123 of the Regulations is hereby amended—

- (a) by the substitution in subregulation (1) for the words “R8 (eight rand) plus R1 (one rand) per landing” of the words “R20 plus R2 per landing”;
- (b) by the substitution in subregulation (2) for the words “R1 (one rand) for each additional landing” of the words “R2 for each additional landing”;
- (c) by the deletion of subregulation (3);
- (d) by the substitution in subregulation (4) for the expression “R10 (ten rand)” of the expression “R100”;
- (e) by the substitution in subregulation (5) for the expression “R2 (two rand)” of the expression “R10”.

**Amendment of regulation C. 164 of the Regulations as amended by Government Notice R. 2262 of 4 November 1977**

4. Regulation C. 164 of the Regulations is hereby amended—

- (a) by the substitution in subregulation (1) for the words “R10 (ten rand)” of the expression “R20”;
- (b) by the deletion of subregulation (2);
- (c) by the substitution in subregulation (3) for the words “R10 (ten rand)” of the expression “R100”; and
- (d) by the substitution in subregulation (4) for the expression “R2 (two rand)” of the expression “R10”;
