WYSIGING VAN GOEWERMENSKENNISGEWING R. 1548 VAN 5 AUGUSTUS 1988.—REGULASIES BETREFFENDE DIE UITBRING VAN VOORAFSTEMME VIR VERKIESING VAN LEDE VAN PLAASLIKE OWERHEIDSLIGGAME

Kragtens artikel 8 van die Wet op Voorafstemme vir Verkiesing van Lede van Plaaslike Owerheidsliggame, 1988 (Wet 94 van 1988), wysig ek, Gerrit van Niekerk Viljoen, Waarnemende Minister van Staatkundige Ontwikkeling en Beplanning, die regulasies afgekondig by Goewermentskennisgewing R. 1548 van 5 Augustus 1988, soos in die Bylae hiervan uiteengesit.

BYLAE

Byvoeging van die volgende regulasie na regulasie 17 van die Bylae by Goewermentskennisgewing R. 1548 van 5 Augustus 1988:

BEKENDMAKING VAN NOMINASIES

“18. (1) 'n Nominasie wat ingevolge artikel 9 van die Wet ontvang is, word, indien die wetgewing van toepassing op die betrokke plaaslike owerheidsliggaam dit vereis, ingevolge sodanige wetgewing op 'n tyd en plek deur die kiesbeampte bepaal, bekendgemaak.

(2) Nie later nie as 14 dae na die dag ingevolge artikel 9 (1) van die Wet bepaal, maak die kiesbeampte ingevolge die wetgewing van toepassing op die betrokke plaaslike owerheidsliggaam bekend—

- watter nominasies verwerp word;
- watter nominasies aanvaar word;
- watter kandidate onbestrede verkies is; of
- ten opsigte van watter kandidate 'n verkiesing gehou sal word.

AMENDMENT OF GOVERNMENT NOTICE R. 1548 OF 5 AUGUST 1988.—REGULATIONS REGARDING THE CASTING OF PRIOR VOTES FOR ELECTION OF MEMBERS OF LOCAL GOVERNMENT BODIES

Under section 8 of the Prior Votes for Election of Members of Local Government Bodies Act, 1988 (Act 94 of 1988), I, Gerrit van Niekerk Viljoen, Acting Minister of Constitutional Development and Planning, hereby amend the regulations promulgated in Government Notice R. 1548 of 5 August 1988, as set out in the Schedule hereto.

SCHEDULE

Insertion of the following regulation after regulation 17 of the Schedule to Government Notice R. 1548 of 5 August 1988:

NOTIFICATION OF NOMINATIONS

“18. (1) Any nomination received in terms of section 9 of the Act, shall, if required by the legislation applicable to the local government body concerned, be made known at a time and place determined by the returning officer in terms of such legislation.

(2) Not later than 14 days after the day determined in section 9 (1) of the Act, the returning officer shall, in terms of the legislation applicable to the local government body concerned, make known—

- which nominations are rejected;
- which nominations are accepted;
- which candidates are elected unopposed; or
- in regard to which candidates an election shall be held.

(3) 'n Kennisgewing wat ingevolge artikel 9 (2) van die Wet gegee word, kan, benewens die dag in artikel 9 (1) van die Wet bedoel, ook al of enige van die volgende inligting vermeld:

(a) Die datum van die verkiesing;

(b) die aantal lede wat verkies moet word;

(c) die datum en tyd waarop, en die plek waar die inligting vermeld in subregulasie (2) bekendgemaak sal word.

(4) 'n Kennisgewing in subregulasie (3) bedoel, vervang enige soortgelyke kennisgewing wat ingevolge die wetgewing van toepassing op die betrokke plaaslike owerheidsliggaam voorgeskryf word.

(5) Indien 'n kennisgewing ingevolge artikel 9 (2) van die Wet, gelees met subregulasie (3), nie die inligting in bedoelde subregulasie (3) (a), (b) of (c) bevat nie, kan die kiesbeampte te eniger tyd 'n afsonderlike kennisgewing ten opsigte van sodanige inligting uitreik.

(3) Any notice given in terms of section 9 (2) of the Act, may, in addition to the day determined in section 9 (1), make mention of any or all of the following information:

(a) The date of the election;

(b) the number of members to be elected;

(c) the date and time upon which and the place where the information contemplated in subregulation (2) shall be made known.

(4) A notice referred to in subregulation (3) shall replace any similar notice prescribed in terms of the legislation applicable to the local government body concerned.

(5) If a notice in terms of section 9 (2) of the Act, read with subregulation (3), does not contain the information referred to in the said subregulation (3) (a), (b) or (c), the returning officer may, at any time, issue a separate notice in regard to such information.
