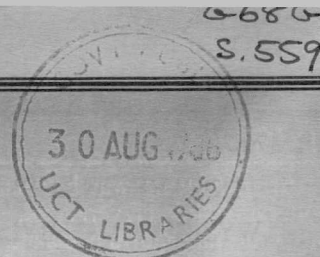

Annotation

Opmerkings.—Deur Opmerkings 7 (c) en (d) deur die volgende te vervang:

- (c) "ingevoer in die hoeveelhede, op die tye, vir die doeleindes en onderworpe aan die voorwaardes wat die Direkteur-generaal: Handel en Nywerheid, op aanbeveling van die Raad van Handel en Nywerheid, by bepaalde permit toelaat nadat bewys voorgelê is dat hierdie goedere kapitaalgoedere of komponente daarvan is wat nie bevredigend plaaslik beskikbaar is nie en—
- (i) wat ingevoer word deur 'n vervaardiger wat teen volle kapasiteit werk;
 - (ii) vir die vestiging van 'n nuwe industrie is; of
 - (iii) wat vir tegnologiese vooruitgang benodig word,
- (d) geklaar ingevoer 'n permit uitgereik deur die Direkteur-generaal: Handel en Nywerheid, op aanbeveling van die Raad van Handel en Nywerheid, vir gebruik by die vervaardiging, verwerking, afwerking, uitrusting of verpakking van goedere uitsluitlik vir uitvoer."

Opmerking.—Opmerking 7 (c) word herskryf ten einde die bedoeling daarvan duideliker te stel terwyl die bewoording van Opmerking 7 (d) in lyn met die Engelse teks gebring word.

Annotation

Notes.—By the substitution for Notes 7 (c) and (d) of the following:

- (c) "imported in such quantities, at such times, for such purposes and subject to such conditions as the Director-General: Trade and Industry, on the recommendation of the Board of Trade and Industry, may allow by specific permit after proof has been furnished that these are capital goods or components thereof which are not satisfactorily available locally and are—
- (i) imported by a manufacturer operating at full capacity;
 - (ii) for the establishment of a new industry; or
 - (iii) required for technology advance,
- (d) cleared in accordance with a permit issued by the Director-General: Trade and Industry, on the recommendation of the Board of Trade and Industry, for use in the manufacture, processing, finishing, equipping or packing of goods exclusively for export."

Note.—Paragraph 7 (c) is amended in order to clarify the intention thereof and the wording of the Afrikaans text is aligned with the English text.
