| "9. Any rate of surcharge specified in this Part in respect of any goods shall not apply to any such goods entered for home consumption before 31 October 1988, in such quantities or of such values as the Director-General: Trade and Industry, on the recommendation of the Board of Trade and Industry, may allow by specific permit provided— (a) satisfactory evidence is submitted that the goods were irrevocably ordered before 15 August 1988; (b) the continued existence of the undertaking is, in the opinion of the Board, in jeopardy; and (c) the application for a permit was in the possession of the Board before 30 September 1988.". | |
