Wysiging van regulasie 1 van Proklamasie R. 99 van 1988

1. Regulasie 1 van die Medianoodregulasies, 1988, word hierby gewysig—

(a) deur die omskrywings van “Direkteur-generaal” en “nuusagentskapsbesigheid” te skrap; en

(b) deur die omskrywing van “Minister” deur die volgende omskrywing te vervang:

“ ‘Minister’ by die toepassing van—

(a) ’n bepaling van regulasie 3 of 9, die Minister van Wet en Orde; of

(b) ’n ander bepaling van hierdie regulasies, die Minister van Binnelandse Sake;”.

PUBLIC SAFETY ACT, 1953.—AMENDMENT OF THE MEDIA EMERGENCY REGULATIONS, 1988

Under the powers vested in me by section 3 of the Public Safety Act, 1953 (Act 3 of 1953), I hereby make the regulations contained in the Schedule.

SCHEDULE

Amendment of regulation 1 of Proclamation R. 99 of 1988

1. Regulation 1 of the Media Emergency Regulations, 1988, is hereby amended—

(a) by the deletion of the definitions of “Director General” and “news agency business”; and

(b) by the substitution for the definition of “Minister” of the following definition:

“ ‘Minister’ for the purpose of the application of—

(a) a provision of regulation 3 or 9, means the Minister of Law and Order; or

(b) any other provision of these regulations, means the Minister of Home Affairs;”.

Repeal of regulation 11 of Proclamation R. 99 of 1988

2. Regulation 11 of the Media Emergency Regulations, 1988, is hereby repealed.

Wysiging van regulasie 12 van Proklamasie R. 99 van 1988

3. Regulasie 12 van die Medianoodregulasies, 1988, word hierby gewysig—

- (a) deur paragraaf (a) van subregulasie (1) deur die volgende paragraaf te vervang:

“(a) opsetlik ’n bepaling van regulasie 2 (1), 3 (4) of (5), 4 (1) of (2) of 5 of ’n bepaling van ’n bevel kragtens regulasie 6 (1), 7 (3) of (9) of 8 oortree;” en

- (b) deur subregulasie (2) deur die volgende subregulasie te vervang:

“(2) ’n Persoon wat hetsy opsetlik of nalatig versuim om aan ’n bevel kragtens regulasie 10 (1) te voldoen, is aan ’n misdryf skuldig en by skuldigbevinding strafbaar met ’n boete van hoogstens R500.”.

4. Proklamasie R. 125 van 28 Julie 1988 word hierby herroep.

5. Hierdie regulasies heet die Mediawysigingsnoodregulasies, 1988.

Amendment of regulation 12 of Proclamation R. 99 of 1988

3. Regulation 12 of the Media Emergency Regulations, 1988, is hereby amended—

- (a) by the substitution for paragraph (a) of subregulation (1) of the following paragraph:

“(a) wilfully contravenes a provision of regulation 2 (1), 3 (4) or (5), 4 (1) or (2) or 5 or a provision of an order under regulation 6 (1), 7 (3) or (9) or 8;” and

- (b) by the substitution for subregulation (2) of the following subregulation:

“(2) Any person who either wilfully or negligently fails to comply with an order under regulation 10 (1), shall be guilty of an offence and on conviction be liable to a fine not exceeding R500.”.

Repeal of Proclamation R. 125 of 1988

4. Proclamation R. 125 of 28 July 1988 is hereby repealed.

Short title

5. These regulations shall be called the Media Amendment Emergency Regulations, 1988.
