SCHEDULE

Notes.—By the substitution for Note 9 of the following:

“9. Any rate of surcharge specified in this Part in respect of any goods shall not apply to any such goods imported in such quantities or of such values as the Director-General: Trade and Industry, on the recommendation of the Board of Trade and Industry, may allow by specific permit provided—

- (a) satisfactory evidence is submitted that the goods were irrevocably ordered before 15 August 1988;
- (b) the continued existence of the undertaking is, in the opinion of the Board, in jeopardy; and
- (c) the application for a permit was in the possession of the Board before 30 September 1988”.

BYLAE

Opmerkings.—Deur Opmerking 9 deur die volgende te vervang:

“9. Enige skaal van bobelasting in hierdie Deel vermeld ten opsigte van enige goedere is nie van toepassing op sodanige goedere ingevoer in die hoeveelhede of met die waardes wat die Direkteur-generaal: Handel en Nywerheid, op aanbeveling van die Raad van Handel en Nywerheid, by bepaalde permit toelaat nie mits—

- (a) bevredigende bewys voorgelê word dat die goedere onherroeplik voor 15 Augustus 1988 bestel is;
- (b) die voortbestaan van die onderneming, volgens die Raad se mening, in gevaar is; en
- (c) die aansoek om 'n permit voor 30 September 1988 in die Raad se besit was”.
