IMPORT CONTROL

I, Theodorus Gerhardus Alant, in my capacity as Deputy Minister of Economic Affairs and Technology, acting on behalf of and on assignment by the Minister of Economic Affairs and Technology, in terms of section 2 of the Import and Export Control Act, 1963 (Act 45 of 1963)—

(i) hereby prescribe that—

(a) goods described in Schedule I shall not be imported into the Republic except by virtue of an import permit issued in terms of section 2 of the said Import and Export Control Act, 1963;

(b) all second-hand or used goods, including waste and scrap of whatever nature, shall not be imported into the Republic of South Africa except by virtue of an import permit issued in terms of section 2 of the said Import and Export Control Act, 1963, and in which such goods are specifically described;

(c) no goods from Sweden shall be imported into the Republic of South Africa except by virtue of an import permit issued in terms of section 2 of the said Import and Export Control Act, 1963, which specifically authorises such import from Sweden;

(d) no goods from Zimbabwe shall be imported into the Republic of South Africa except by virtue of an import permit issued in terms of section 2 of the said Import and Export Control Act, 1963, which specifically authorises such import from Zimbabwe.

(ii) hereby determine that, notwithstanding the provisions of paragraph (i) above, no import permit shall be necessary for the importation into the Republic of South Africa of the following goods:

(a) Goods landed for transit through the Republic;

INVOERBEHEER

Ek, Theodorus Gerhardus Alant, in my hoedanigheid as Adjunk-minister van Ekonomiese Sake en Tegnologie, en handelende namens en in opdrag van die Minister van Ekonomiese Sake en Tegnologie, kragtens artikel 2 van die Wet op In- en Uitvoerbeheer, 1963 (Wet 45 van 1963)—

(i) skryf hierby voor dat—

(a) goedere beskryf in Bylae I, nie in die Republiek ingevoer mag word nie, behalwe uit hoofde van 'n invoerpermit uitgereik ingevolge artikel 2 van genoemde Wet op In- en Uitvoerbeheer, 1963;

(b) alle tweedehandse of gebruikte goedere, insluitende oorskiet- en afvalmateriaal van watter aard ookal, nie in die Republiek van Suid-Afrika ingevoer mag word nie, behalwe uit hoofde van 'n invoerpermit waarin sodanige goedere spesifiek beskryf word en uitgereik ingevolge artikel 2 van genoemde Wet op In- en Uitvoerbeheer, 1963;

(c) geen goedere vanaf Swede in die Republiek van Suid-Afrika ingevoer mag word nie, behalwe uit hoofde van 'n invoerpermit uitgereik ingevolge artikel 2 van genoemde Wet op In- en Uitvoerbeheer, 1963, wat spesifiek sodanige invoer vanaf Swede magtig;

(d) geen goedere vanaf Zimbabwe in die Republiek van Suid-Afrika ingevoer mag word nie, behalwe uit hoofde van 'n invoerpermit uitgereik ingevolge artikel 2 van genoemde Wet op In- en Uitvoerbeheer, 1963, wat spesifiek sodanige invoer vanaf Zimbabwe magtig.

(ii) bepaal hierby dat nieteenstaande die bepalings van paragraaf (i) hierbo, geen invoerpermit nodig is vir die invoer van die volgende goedere in die Republiek van Suid-Afrika nie:

(a) Goedere wat vir deurvoer deur die Republiek geland word;

(b) goods (excluding weapons and ammunition and motor vehicles) imported as household or personal effects for the personal use of a South African citizen returning to the Republic after an absence of longer than six months or by a person entering the Republic for purposes of either permanent or temporary residence;

(c) goods (excluding weapons and ammunition) sent as a bona fide gift for the personal use of the importer or his family by any other person, the free on board value of which does not exceed R200;

(d) samples of no commercial value or samples sent free of charge to the importer by any other person, the free on board value of which does not exceed R500;

(e) goods imported from Bophuthatswana, Botswana, Ciskei, Lesotho, Malawi, Swaziland, Transkei or Venda that are cultivated, produced or manufactured in the said countries, except unrefined or refined sugar (Customs Tariff Item ex 17.01) imported from Swaziland and tea in bulk or retail-packed (Customs Tariff Item ex. 09.02) imported from Malawi;

(f) (a) new spares, subassemblies and materials imported as original equipment for the manufacturing of motor vehicles; spares and subassemblies imported as spare parts for the maintenance of motor vehicles;

(b) all other new spares for all goods which are not subject to import control;

(g) goods imported into the Republic for repair or maintenance and, after such repair or maintenance, exported to the consigner concerned;

(h) goods exported from the Republic for repair or maintenance and returned to the original exporter in the Republic;

(i) empty containers originally containing goods exported from the Republic and returned to the original exporter in the Republic;

(j) goods (excluding weapons and ammunition) that are the property of a resident of the Republic who is returning to the Republic after an absence of not less than 48 hours and that are required for his personal use or that of his family, provided that the total value thereof does not exceed R2 000 and that the goods are brought in with him on such return;

(k) printed bona fide advertising matter sent free of charge to the importer by any other person;

(l) used Army, Navy and Airforce uniform overcoats;

(m) State importations in terms of Item 401 of Schedule 4 of the Customs and Excise Act, 1964 (Act 91 of 1964);

(n) goods imported by heads of State, diplomatic and other foreign representatives in terms of Item 406 of Schedule 4 of the Customs and Excise Act, 1964 (Act 91 of 1964);

(iii) hereby determine that an import permit, except for the conditions specified in the permit, shall be subject to the following conditions:

(a) That only goods of the class and kind specified in the permit may be imported;

(b) goedere (uitgesonderd wapens en ammunisie en motorvoertuie) was as huishoudelike of persoonlike besittings vir persoonlike gebruik ingevoer word deur 'n Suid-Afrikaanse burger wat na 'n afwesigheid van langer as ses maande na die Republiek terugkeer of deur iemand wat die Republiek binnekom met die doel om hom blywend daarin te vestig of om tydelike daarin te vervoer;

(c) goedere (uitgesonderd wapens en ammunisie) as 'n bona fide geskenk vir die persoonlike gebruik van die invoerder of sy gesin deur iemand anders afgestuur, met 'n vry aan bord waarde van hoogstens R200;

(d) monsters wat geen handelswaarde het nie of monsters wat deur iemand anders gratis aan die invoerder gestuur is, met 'n vry aan bord waarde van hoogstens R500;

(e) goedere wat uit Bophuthatswana, Botswana, Ciskei, Lesotho, Malawi, Swaziland, Transkei of Venda ingevoer word en in genoemde lande gekweek, geproduseer of vervaardig is, uitgesonderd ongeraffineerde of geraffineerde suiker (Doeanetariefitem ex 1701.) uit Swaziland ingevoer en tee in grootmaat of in kleinhandelverpakings (Doeanetariefitem ex 09.02) uit Malawi ingevoer;

(f) (a) nuwe onderdele, subsamestelle en materiale ingevoer as oorspronklike toerusting vir die vervaardiging van motorvoertuie; onderdele en subsamestelle vir die instandhouding van motorvoertuie;

(b) alle ander nuwe onderdele vir alle goedere wat nie aan invoerbeheer onderhewig is nie;

(g) goedere wat vir herstel of instandhouding in die Republiek ingevoer word en na sodanige herstel of instandhouding na die betrokke afsender uitgevoer word;

(h) goedere wat vir herstel of instandhouding uit die Republiek uitgevoer is en na die oorspronklike uitvoerder in die Republiek teruggestuur word;

(i) leë houers wat oorspronklik goedere bevat het en wat uit die Republiek uitgevoer is en na die oorspronklike uitvoerder in die Republiek teruggestuur word;

(j) goedere (uitgesonderd wapens en ammunisie) wat die eiendom is van 'n inwoner van die Republiek, wat na 'n afwesigheid van minstens 48 uur na die Republiek terugkeer, en wat vir sy persoonlike gebruik of die gebruik van sy gesin nodig is, mits die totale waarde daarvan nie 'n bedrag van R2 000 oorskry nie en die goedere by bedoelde terugkeer saam met hom ingebring word;

(k) gedrukte bona fide-advertensiemateriaal wat gratis aan die invoerder deur iemand anders afgestuur is;

(l) gebruikte Leër-, Vloot- en Lugmaguniform-oorjasse;

(m) Staatsinvoere ingevolge Item 401 van Bylae 4 van die Doeane- en Aksynswet, 1964 (Wet 91 van 1964);

(n) goedere deur Staatshoofde, diplomatieke- en ander buitelandse verteenwoordigers ingevoer ingevolge Item 406 van Bylae 4 van die Doeane- en Aksynswet, 1964 (Wet 91 van 1964).

(iii) bepaal hierby dat 'n invoerpermit, behoudens die voorwaardes in die permit vermeld, onderworpe is aan die volgende voorwaardes:

(a) Dat slegs goedere van die klas of soort vermeld in die permit ingevoer kan word;

- (b) that the permit may not in any manner be transferred by the holder thereof to any other person;
- (c) that the permit shall be valid from the date of issue until 31 December of that year.
- (iv) hereby determine that—

(a) goods referred to in paragraph (i) above shall not be shipped unless the importer is in possession of an appropriate, valid import permit;

(b) goods referred to in paragraph (i) above that arrive at ports in the Republic and for which the importer cannot produce a valid import permit shall be deemed to have been imported in contravention of the Import and Export Control Act, 1963;

(v) hereby determine that nothing in this notice shall absolve an importer from the obligation of also complying with the provisions of other legislation relating to the importation of goods into the Republic of South Africa;

(vi) hereby withdraw Government Notice R. 1163 of 30 May 1985, as amended; and

(vii) hereby determine that this notice shall come into operation on 1 January 1989.
