EDUCATION AND TRAINING ACT, 1979
(ACT 90 OF 1979)

AMENDMENT OF REGULATIONS REGARDING THE CONTROL OF MONEYS WHICH ARE COLLECTED FOR OR IN RESPECT OF A STATE SCHOOL, A COMMUNITY SCHOOL OR A STATE-AIDED SCHOOL

The Minister of Education and Development Aid has, under section 44 of the Education and Training Act, 1979 (Act 90 of 1979), made the regulations in the Schedule.

SCHEDULE

1. In this Schedule, "the Regulations" shall mean the regulations published under Government Notice R. 830 of 30 April 1982.

2. Regulation 1 of the Regulations is hereby amended by the insertion after the definition of "circuit inspector" of the following definition:

"'regional director' shall mean an officer of the Department who is in control of education in any region determined by the Minister in terms of section 2 (2) of the Act;".

3. Regulation 3 of the Regulations is hereby amended—

(a) by the substitution in subregulation (2) for the words "contributions" and "Director-General" of the words "amounts of the contributions" and "regional director concerned" respectively; and

(b) by the insertion after subregulation (2) of the following subregulation:

"(2A) If the school committee wishes to increase an amount determined in terms of subregulation (2) it shall submit the proposed amount, together with an exposition of the reasons therefor and the purposes for which the additional money will be used, to the regional director concerned for approval.".

WYSIGING VAN REGULASIES BETREFFENDE DIE BEHEER OOR GELD WAT VIR OF MET BETREKKING TOT 'N STAATSKOOL, 'N GEMEENSKAPSKOOL OF 'N STAATSONDERSTEUNDE SKOOL INGESAMEL WORD

Die Minister van Onderwys en Ontwikkelingshulp het kragtens artikel 44 van die Wet op Onderwys en Opleiding, 1979 (Wet 90 van 1979), die regulasies in die Bylae uitgevaardig.

BYLAE

1. In hierdie Bylae beteken, "die Regulasies" die Regulasies aangekondig deur Goewermentskennisgewing R. 830 van 30 April 1982.

2. Regulasie 1 van die Regulasies word hierby gewysig deur die volgende omskrywing by te voeg:

"'streekdirekteur' 'n beampie in die Departement wat in beheer is van onderwys in 'n streek wat ingevolge artikel 2 (2) van die Wet deur die Minister bepaal is;".

3. Regulasie 3 van die Regulasies word hierby gewysig—

(a) deur in subregulasie (2) die woord "Direkteurgeneraal" deur die woorde "betrokke streekdirekteur" te vervang; en

(b) deur die volgende subregulasie na subregulasie (2) in te voeg:

"(2A) Indien die skoolkomitee 'n bedrag bepaal ingevolge subregulasie (2) wil verhoog, moet hy die voorgestelde bedrag tesame met 'n uiteensetting van die redes daarvoor en die doeleindes waarvoor die bykomende geldte aangewend gaan word, vir goedkeuring aan die betrokke streekdirekteur voorlê.".

4. Regulation 4 of the Regulations is hereby amended—

(a) by the substitution for subregulation (22) of the following subregulation:

“(22) Debts incurred contrary to the provisions of these regulations shall not be charged against the school fund, and school committee members who, according to the minutes, voted in favour of the resolution to incur such debt shall be jointly and severally liable therefor.”;

(b) by the insertion after subregulation (22) of the following subregulation:

“(22A) The Department shall not be liable for any debt incurred by the school committee in terms of or contrary to the provisions of these regulations.”; and

(c) by the insertion after subregulation (29) of the following subregulation:

“(29A) After the estimates referred to in subregulation (28) have been approved, the school committee may not incur any debt for which no provision has been made in the estimates, unless it can be settled out of savings.”.

4. Regulasie 4 van die Regulasies word hierby gewysig—

(a) deur subregulasie (22) deur die volgende subregulasie te vervang:

“(22) Skuld wat teenstrydig met die bepalings van hierdie regulasies aangegaan is, mag nie teen die skoolfonds in berekening gebring word nie, en skoolkomiteelede wat volgens die notule gestem het ten gunste van die besluit om sodanige skuld aan te gaan, is gesamentlik en afsonderlik daarvoor aanspreeklik.”;

(b) deur die volgende subregulasie na subregulasie (22) in te voeg:

“(22A) Die Departement is nie aanspreeklik nie vir enige skuld wat die skoolkomitee ingevolge of in stryd met die bepalings van hierdie regulasies aangaan.”; en

(c) deur die volgende subregulasie na subregulasie (29) in te voeg:

“(29A) Nadat die begroting bedoel in subregulasie (28) goedgekeur is, mag die skoolkomitee geen skuld waarvoor daar nie in die begroting voorsiening gemaak is nie, aangaan nie, tensy dit uit besparings vereffen kan word.”.

SCHEDULE**AMENDMENT OF THE COMPULSORY SPECIFICATION FOR PERSONAL FLOTATION AIDS**

Subsection 1.1: Delete the existing subsection and substitute the following:

1.1 This specification covers the requirements for personal flotation aids.

Subsection 1.2: Add the following new subsection:

1.2 All personal flotation aids shall comply with the relevant requirements of this specification.

Section 2: Delete the existing definitions for "fotation aid", "life-jacket", "life-preserver" and "swimming aid" and substitute the following new definitions in the correct alphabetical positions:

Personal flotation aid: Any article worn on the body of a person and taken onto or into water by such person on the reasonable assumption that it will assist that person to remain afloat.

Life-jacket: A life-preserver that complies with the buoyancy, performance and marking requirements of the SOLAS Convention of 1974.

Life-preserver: A personal flotation aid that complies with the requirements of Section 4 and the relevant requirements of Section 5 of this specification, is intended to maintain a wearer in a safe floating position and is intended for use in waters where early rescue can be expected.

Swimming aid: A personal flotation aid that complies with the requirements of Section 3 and the relevant requirements of Section 5 of this specification and that is intended to assist a person in learning to swim.

BYLAE**WYSIGING VAN DIE VERPLIGTE SPESIFIKASIE VIR PERSOONLIKE DRYFHULPMIDDELS**

Onderafdeling 1.1: Skrap die bestaande onderafdeling en vervang dit deur die volgende:

1.1 Hierdie spesifikasie dek die vereistes vir persoonlike dryfhulpmiddels.

Onderafdeling 1.2: Voeg die volgende nuwe onderafdeling by:

1.2 Alle persoonlike dryfhulpmiddels moet aan die toepaslike vereistes van hierdie spesifikasie voldoen.

Afdeling 2: Skrap die bestaande woordbepalings vir "Dryfhulpmiddel", "Reddingsbaadjie", "Reddingstuig" en "Swemhulpmiddel" en vervang dit deur die volgende nuwe woordbepalings in die korrekte alfabetiese posisie:

Persoonlike dryfhulpmiddel: 'n Artikel wat 'n persoon aan sy lyf dra en wat deur dié persoon op of in die water geneem word in die redelike veronderstelling dat dit hom sal help om te bly dryf.

Reddingsbaadjie: 'n Reddingstuig wat aan die vereistes vir dryfvermoë, prestasie en merke van die SOLAS-konvensie van 1974 voldoen.

Reddingstuig: 'n Persoonlike dryfhulpmiddel wat aan die vereistes van afdeling 4 en die toepaslike vereistes van afdeling 5 van hierdie spesifikasie voldoen, wat bedoel is om 'n draer in 'n veilige dryfposisie te hou, en wat bedoel is vir gebruik in water waar spoedige hulp verwag kan word.

Swemhulpmiddel: 'n Persoonlike dryfhulpmiddel wat aan die vereistes van afdeling 3 en die toepaslike vereistes van afdeling 5 van hierdie spesifikasie voldoen en wat bedoel is om 'n persoon te help om te leer swem.
