PETROLEUM PRODUCTS ACT, 1977

REGULATIONS UNDER THE PETROLEUM PRODUCTS ACT, 1977

On behalf of and on assignment by the Minister of Economic Affairs and Technology, I, George Shepstone Bartlett, Deputy Minister of Economic Affairs and Technology, hereby under section 2 (1) (c) of the Petroleum Products Act, 1977 (Act 120 of 1977), make the regulations set out in the Schedule.

SCHEDULE

PRICES AT WHICH PETROL MAY BE SOLD BY RESELLERS IN SOUTH WEST AFRICA, CAPRIVIZIPFEL AND WALVIS BAY

Definitions

1. In these Regulations—

- 1.1 "petrol" includes any mixture of petrol with any other substance, which mixture can be used as fuel for the operation of a spark ignition engine;
- 1.2 "reseller" means any person who, whether he has a petrol pump in operation in terms of an arrangement with a wholesale distributor or not, acquires petrol directly from a wholesale distributor and sells it to any other person in the course of or as part of the activities of a business carried on by him, but does not include any such person in relation to petrol which he so sells in terms of an agreement with a wholesale distributor only in quantities of not less than 200 litres at a time;
- 1.3 "the Act" means the Petroleum Products Act, 1977 (Act 120 of 1977);
- 1.4 "wholesale distributor" means any of the following companies:

(b) He shall have been trained for a period of at least four years of which the first three years will be in order to attain the National Diploma in Medical Orthotics and Prosthetics and the fourth year will be an internship during which the holder of the National Diploma will undergo practical training of a minimum of 1 200 hours at a unit approved by the council.

Persons who were registered as medical mechanics and surgical appliance makers under the provisions of Government Notices 2041 of 30 September 1949, 667 of 22 March 1951, as amended, or R. 1712 of 30 October 1964, or as medical technicians under the provisions of Government Notice R. 3211 of 5 September 1969, shall be deemed to be registered under these rules as medical orthotists and prosthetists.

3. Where, in the case of an application for registration, the qualification on which the application is based has not already been approved by the council, the applicant shall be required to cause the Professional Board for Medical Orthotists and Prosthetists and the council to be furnished with authoritative information for such qualifications, whereupon if such standard of training is considered satisfactory by the council, such qualification may be recognised.
