#### ESTABLISHMENT OF THE LOCAL COUNCIL OF CONSTANTIA VALLEY

I, Abraham Adriaan Venter, Minister of Local Government and Housing, acting under section 2, read with section 6 of the Local Councils Act (House of Assembly), 1987 (Act 94 of 1987), hereby—

(a) establish with effect from 2 March 1989 a local council to be known as the Local Council of Constantia Valley for the area as defined in Schedule 2 hereof;

(b) determine that the said local council shall consist of 12 (twelve) members; and

(c) appoint the members of the said local council as mentioned in Schedule 1 hereof for a period of 18 months.
