#### MEAT SCHEME.—AMENDMENT

**MEAT SCHEME.—CONTROL OVER THE INTRODUCTION OR RECEIPT OF SLAUGHTER ANIMALS, MEAT OR MEAT PRODUCTS, THE ACQUISITION OR SALE OF SLAUGHTER ANIMALS OR THE SLAUGHTERING OF SLAUGHTER ANIMALS IN CONTROLLED AREAS—AMENDMENT**

I, Jacob Johannes Greyling Wentzel, Minister of Agriculture, hereby make known in terms of section 79 of the Marketing Act, 1968 (Act No. 59 of 1968) that—

(a) the Meat Board referred to in section 6 of the Meat Scheme published by Government Notice No. R. 2641 of 1988, has under section 48 of the said Scheme further amended Government Notice No. R. 2330 of 20 December 1968, as amended, to the extent set out in the Schedule; and

(b) the said amendment has been approved by me and shall come into operation on the date of publication hereof.
