MARKETING ACT, 1968 (ACT NO. 59 OF 1968)

BANANA SCHEME.—LEVY AND SPECIAL LEVY—AMENDMENT

I, Jacob Johannes Greyling Wentzel, Minister of Agriculture, hereby make known in terms of section 79 of the Marketing Act, 1968 (Act No. 59 of 1968), that—

(a) the Banana Board referred to in section 6 of the Banana Scheme published by Proclamation No. R. 109 of 1976, as amended, has under section 23 of the said Scheme amended the Schedule to Government Notice No. R. 43 of 15 January 1988 to the extent set out in the Schedule hereto; and

(b) the said amendment has been approved by me and shall come into operation on 1 July 1989.

SCHEDULE

Clause 3 of the Schedule to Government Notice No. R. 43 of 15 January 1988 is hereby amended by the substitution for paragraph (b) thereof of the following paragraph:

"(b) *Special levy*: 1,05 cent per 20 kg container of bananas, plus 2,25 percent of the gross selling price realised by the Board for the bananas concerned."
