WINTER CEREAL SCHEME.—SPECIAL LEVY ON WHITE BREAD FLOUR, BROWN BREAD MEAL AND WHOLE-WHEAT MEAL IN STOCK AT COMMERCIAL BREAD BAKERS ON 31 OCTOBER 1989

I, Jacob de Villiers, Minister of Agriculture, hereby make known in terms of section 79 of the Marketing Act, 1968 (Act No. 59 of 1968), that—

- the Wheat Board referred to in section 6 of the Winter Cereal Scheme published by Proclamation No. R. 162 of 1974, as amended, has under section 25 of the said Scheme imposed the special levy set out in the Schedule;
- the said special levy has been approved by me and shall come into operation on 1 November 1989; and
- Government Notice No. R. 1396 of 30 June 1989 is repealed with effect from the said date of commencement.

SCHEDULE

Definitions

1. Any word or expression in this Schedule to which a meaning has been assigned in the Scheme shall have that meaning and, unless the context otherwise indicates—

"brown bread meal", "white bread flour" and "whole-wheat meal" shall have the meanings assigned thereto in the regulations published by Government Notice No. R. 1981 of 30 September 1977, as amended;

"commercial bread baker" means a person registered by the Board under section 36 of the Scheme to deal in the course of trade with white bread, brown bread or whole-wheat bread; and

 - (a) in the case of white bread flour, be R124,01 per ton;
 - (b) in the case of brown bread meal, be R112,18 per ton; and
 - (c) in the case of whole-wheat meal, be R101,56 per ton.

Spesiale heffing op wintergraanprodukte

Special levy on winter cereal

3. (1) (a) A special levy is hereby imposed on winter cereal of the classes and grades specified in column 1 of Table 1 that, in the case of wheat, is sold by the Board for milling purposes to persons registered by the Board under section 36 of the Scheme as commercial millers.

(b) The amount of the special levy referred to in paragraph (a) shall be as specified in column 3 of Table 1 opposite the respective classes and grades of winter cereal.

(2) (a) A special levy is hereby imposed on winter cereal of the classes and grades specified in column 1 of Table 1, that is sold to the Board.

(b) The amount of the special levy referred to in paragraph (a) shall be as specified in column 4 of Table 1 opposite the respective classes and grades of winter cereal.

Special levy on winter cereal products

4. (1) A special levy is hereby imposed on winter cereal products of the kinds specified in column 1 of Table 2, that are sold by persons who are registered under section 36 of the Scheme as commercial millers.

(2) The amount of the special levy referred to in subclause (1) shall be as specified in column 2 of Table 2 opposite the respective kinds of winter cereal products.


