AND TIME OF PAYMENT OF LEVIES ON POTATOES**

The Minister of Agriculture has under section 89 of the Marketing Act, 1968 (Act No. 59 of 1968) —

- (a) made the regulations in the Schedule; and
- (b) repealed Government Notice No. R. 1372 of 13 August 1971.

SCHEDULE**Definitions**

1. Any word or expression in this Schedule to which a meaning has been assigned in the Scheme shall have that meaning, and "the Scheme" means the Potato Scheme published by Government Notice No. R. 2400 of 25 November 1988, as amended.

Manner in which levies have to be paid

2. (1) An amount that is payable in respect of a levy and a special levy which were imposed on table potatoes and seed potatoes under section 27 of the Scheme shall be paid by bank-guaranteed cheque, postal order or money order issued in favour of the Board.

(2) Such cheque, postal order or money order shall —

(a) be accompanied by the applicable return required by the Board under section 37 of the Scheme;

(b) when forwarded by post, be addressed to the Potato Board, Private Bag X135, Pretoria, 0001; and

(c) wanneer per hand ingedien, afgelewer word by die kantoor van die Aartappelraad, Belvederestraat 529, Arcadia, Pretoria.

(3) Die bedrag van so 'n tjek, posorder of poswissel moet in ooreenstemming wees met die bedrag soos bereken in die toepaslike opgawe in subklousule (2) (a) bedoel.

(4) Posgeld op en afleweringskoste van elke sodanige tjek, posorder en poswissel moet deur die afsender daarvan vooruitbetaal word.

Tyd van betaling van heffings

3. 'n Tjek, posorder of poswissel in klousule 2 bedoel, moet die Raad bereik voor of op die tiende dag van die maand volgende op die maand waarin die aartappels waarop dit betrekking het, aangekoop, verkoop, vir verkoop ingebring of verwerk is deur die persoon deur wie die betrokke heffing en spesiale heffing betaalbaar is.

Misdrywe en strawwe

4. Iemand wat 'n bepaling van hierdie regulasies oortree of versuim om daaraan te voldoen, is aan 'n misdryf skuldig en by skuldigbevinding strafbaar met 'n boete van hoogstens R5 000.

Time of payment of levies

A cheque, postal order or money order referred to in clause 2 shall reach the Board on or before the tenth day of the month following the month in which the potatoes to which it relates, were purchased, sold, introduced for sale or processed by the person by whom the relevant levy and special levy are payable.

Offences and penalties

4. Any person who contravenes or fails to comply with a provision of these regulations shall be guilty of an offence and liable on conviction to a fine not exceeding R5 000.

3. The provisions of paragraph 2 of this Schedule shall be deemed to have come into operation on 31 March 1986.

**AMENDMENT OF THE TELECOMMUNICATION
REGULATIONS**

The Minister of Mineral and Energy Affairs and Public Enterprises has under section 119A (1) (g) of the Post Office Act, 1958 (Act No. 44 of 1958), made the regulations in the Schedule.

SCHEDULE

1. In this Schedule, unless the context otherwise indicates, "the Regulations" means the Telecommunication Regulations published under Government Notice No. R. 1191 of 1 July 1977, as amended by Government Notices Nos. R. 2000 of 30 September 1977, R. 2119 of 21 October 1977, R. 13 of 5 January 1979, R. 2329 of 19 October 1979, R. 903 of 24 April 1981, R. 2841 of 31 December 1981, R. 365 of 26 February 1982, R. 2417 of 12 November 1982, R. 367 of 18 February 1983, R. 740 of 15 April 1983, R. 2790 of 23 December 1983, R. 740 of 13 April 1984, R. 983 of 18 May 1984, R. 333 of 28 February 1986, R. 506 of 21 March 1986, R. 1410 of 4 July 1986, R. 2263 of 31 October 1986, R. 1193 of 29 May 1987, R. 1760 of 21 August 1987, R. 1762 of 21 August 1987, R. 350 of 4 March 1988, R. 517 of 25 March 1988, R. 518 of 25 March 1988, R. 1437 of 22 July 1988 and R. 178 of 10 February 1989.

2. Regulation A.1.12 of the Regulations is hereby amended by the substitution for paragraph (1) of the following paragraph:

(1) There are no restrictions on transmissions in the same exchange system but where more than one manual exchange is involved during a transmission, transmissions will be accepted at clients' own risk.
