

AMENDMENT OF THE FIRST SCHEDULE TO THE SUPREME COURT ACT, 1959 (ACT NO. 59 OF 1959)

Under section 6 (4) of the Supreme Court Act, 1959 (Act No. 59 of 1959), I, Hendrik Jacobus Coetsee, Minister of Justice, hereby amend, with effect from 1 January 1990, the third column of the First Schedule to the said Act—

- (i) by the insertion of the expression "Joubertina," after the expression "Humansdorp," in the description of the area of jurisdiction of the Eastern Cape Division of the Supreme Court of South Africa; and
- (ii) by the insertion of the expression ", Joubertina," after the expression "Humansdorp" in the description of the area of jurisdiction of the South-Eastern Cape Local Division of the Supreme Court of South Africa.
