Hierby word vir algemene inligting bekendgemaak dat die Staatspresident kragtens artikel 35 (1) (l) van die Staatsdienswet, 1984 (Wet No. 111 van 1984), die ondergemelde regulasies uitgevaardig het:

Die Staatsdiensregulasies gepubliseer by Goewermenskennisgewing No. 2047 van 11 Desember 1959, soos gewysig, word hierby verder gewysig deur subregulasie (c) in regulasie J2.1 soos volg aan te vul:

“(c) 'n Beampte mag nie terselfdertyd lid van meer as een erkende personeelvereniging wees nie tensy daar omstandighede ontstaan wat 'n afwyking van hierdie bepaling ten opsigte van die lede van 'n spesifieke personeelvereniging regverdig, in welke geval die Kommissie sodanige afwyking moet aanbeveel.”.

For general information it is hereby notified that the State President has, under the powers vested in him by section 35 (1) (l) of the Public Service Act, 1984 (Act No. 111 of 1984), made the following regulations:

The Public Service Regulations, published under Government Notice No. 2047 of 11 December 1959, as amended, are hereby further amended by supplementing subregulation (c) in regulation J2.1 as follows:

“(c) An officer may not at the same time be a member of more than one recognised staff association unless circumstances arise which justify a departure from this provision with regard to the members of a specific staff association, in which case the Commission shall recommend such a departure.”.
