DOEANE- EN AKSYNSWET, 1964

WYSIGING VAN REGULASIES (No. MR/80)

Kragtens artikel 120 (1) (e) van die Doeane- en Aksynswet, 1964, word die regulasies gepubliseer by Goewermentskennisgewing No. R. 1770 van 5 Oktober 1973 gewysig deur na regulasie 3.09.01 die volgende in te voeg:

"3.09.02 Goedere in die gemeenskaplike doeanegebied en die Republiek van Namibië geproduceer of vervaardig en enige ingevoerde, synbare of brandstofheffingoedere wat in die gemeenskaplike doeanegebied of die Republiek van Namibië behoorlik geklaar is kan tussen die Republiek van Namibië en die gemeenskaplike doeanegebied verwyder word sonder om klaring kragtens artikels 38 en 39 te maak."

Opmerking. — Die uitwerking van hierdie wysiging is dat goedere wat tussen die Republiek van Namibië en die gemeenskaplike doeanegebied verwyder word, nie vir doeane- en aksynsdoeleindes hoeft geklaar te word nie.

CUSTOMS AND EXCISE ACT, 1964

AMENDMENT OF REGULATIONS (No. MR/80)

Under section 120 (1) (e) of the Customs and Excise Act, 1964, the regulations published in Government Notice No. R. 1770 of 5 October 1973 are amended by the insertion after regulation 3.09.01 of the following:

"3.09.02 Goods produced or manufactured in the common customs area and the Republic of Namibia and any imported, excisable or fuel levy goods which have been duly entered in the common customs area or the Republic of Namibia may be removed between the Republic of Namibia and the common customs area without making entry in terms of sections 38 and 39."

Note. — The effect of this amendment is that goods removed between the Republic of Namibia and the common customs area need not be entered for customs and excise purposes.
