Kragtens artikel 10 (1) van die Wet op Sekuriteitsbeamptes, 1987 (Wet No. 92 van 1987), bepaal ek, Adriaan Johannes Vlok, Minister van Wet en Orde, hierby 11 Oktober 1990 as die datum beoog in genoemde artikel, vanaf welke datum ingevolge daardie artikel geen persoon 'n sekuriteitsdiens bedoel in artikel 1 van genoemde Wet mag lewer nie tensy hy, en indien hy 'n maatskappy of 'n beslote korporasie is, hy en elke direkteur van die maatskappy of hy en elke lid van die beslote korporasie, by die Raad vir Sekuriteitsbeamptes as 'n sekuriteitsbeampte geregistreer is, en geen werkneem van 'n persoon wat 'n sekuriteitsdiens lewer, mag toelaat dat hy in die loop van sy diens vir die lewering van 'n sekuriteitsdiens gebruik word nie tensy hy by die Raad vir Sekuriteitsbeamptes as 'n sekuriteitsbeampte geregistreer is.

SECURITY OFFICERS ACT, 1987

PERSONS PROHIBITED FROM PERFORMING CERTAIN ACTS UNLESS REGISTERED AS SECURITY OFFICERS

Under section 10 (1) of the Security Officers Act, 1987 (Act No. 92 of 1987), I, Adriaan Johannes Vlok, Minister of Law and Order, hereby determine 11 October 1990 as the date contemplated in the said section, from which date in terms of that section no person shall render a security service referred to in section 1 of the said Act unless he, and if such person is a company or a close corporation, it and every director of the company or it and every member of the close corporation, are registered with the Security Officers' Board as a security officer, and no employee of a person rendering a security service shall allow that he be used in the course of his employment for the rendering of a security service unless he is registered with the Security Officers' Board as a security officer.

REGULASIES BETREFFENDE AANSOEK OM REGISTRASIE AS 'N SEKURITEITSBEAMPTE, 'N REGISTER VIR SEKURITEITSBEAMPTES, NAAMSVERANDERING EN REGISTRASIESERTIFIKATE VAN SEKURITEITSBEAMPTES, PROSEDURE BETREFFENDE VERANDERING VAN INLIGTING AAN DIE RAAD VIR SEKURITEITSBEAMPTES VERSKAF, BETALING VAN JAARDELDE EN ANDER VOORGESKREWE GELDE ASOKOOG DIE WYSE VAN APPEL NA DIE MINISTER VAN WET EN ORDE TEEN BESLUITE VAN DIE RAAD

Die Minister van Wet en Orde het, na oorlegpleging met die Raad vir Sekuriteitsbeamptes, kragtens artikel 32 (1) van die Wet op Sekuriteitsbeamptes, 1987 (Wet No. 92 van 1987), die regulasies in die Bylae uitgevaardig.

BYLAE**Woordomskrywing**

1. In hierdie Bylae beteken "die Wet" die Wet op Sekuriteitsbeamptes, 1987 (Wet No. 92 van 1987), en het enige woord of uitdrukking waaraan 'n betekenis in die Wet toegeken is, daardie betekenis en, tensy uit die samehang anders blyk, beteken—

"polisiebeampte" 'n lid van die Mag soos om-skryf in artikel 1 van die Polisiewet, 1958 (Wet No. 7 van 1958);

"Registrateur van die Raad" die Registrateur aangestel deur die Raad kragtens artikel 3 (d) of iemand wat wettiglik in daardie hoedanigheid waarneem;

"voorgeskrewe gelde" die gelde in regulasie 9 bedoel.

Aansoek om registrasie as 'n sekuriteitsbeampte

2. 'n Aansoek om registrasie as 'n sekuriteitsbeampte ingevolge artikel 11 van die Wet word by die Raad gedoen en word voorgelê aan die Registrateur van die Raad op die vorm wat in Aanhangsel A uitengesit word, en gaan vergesel van die voorgeskrewe gelde asook 'n duidelike en volledige stel vingeraf-drukke bedoel in artikel 11 (1) (a) van die Wet, welke vingerafdrukke op vorm SAP 91 (a) deur of in die teenwoordigheid van 'n polisiebeampte geneem moet word.

Register vir sekuriteitsbeamptes

3. 'n Register vir sekuriteitsbeamptes wat vir doel-eindes van artikel 13 van die Wet deur die Raad gehou word, bevat behoudens die bepalings van artikel 13 van die Wet die volgende besonderhede:

- (a) Die nommer van die registrasiesertifikaat wat uitgereik is deur die Raad ingevolge artikel 14 van die Wet en die nommer wat deur die Raad aan die sekuriteitsbeampte toegeken is;
- (b) die datum van die registrasiesertifikaat bedoel in paragraaf (a);
- (c) die woonadres en besigheidsadres (besig-heidsstraatadres en besigheidsposadres) van die sekuriteitsbeampte;
- (d) die identiteitsnommer, geboortedatum en nasionaliteit van die sekuriteitsbeampte indien die sekuriteitsbeampte 'n natuurlike persoon is;

SECURITY OFFICERS' BOARD

REGULATIONS REGARDING APPLICATION FOR REGISTRATION AS A SECURITY OFFICER, A REGISTER FOR SECURITY OFFICERS, CHANGE OF NAME AND REGISTRATION CERTIFICATES, PROCEDURE REGARDING THE CHANGE OF INFORMATION SUBMITTED TO THE SECURITY OFFICERS' BOARD, PAYMENT OF ANNUAL FEES AND OTHER PRESCRIBED FEES AS WELL AS THE MANNER OF APPEAL TO THE MINISTER OF LAW AND ORDER AGAINST DECISIONS OF THE BOARD

The Minister of Law and Order has, after consultation with the Security Officers' Board, under section 32 (1) of the Security Officers Act, 1987 (Act No. 92 of 1987), made the regulations in the Schedule.

SCHEDULE**Definitions**

1. In this Schedule "the Act" means the Security Officers Act, 1987 (Act No. 92 of 1987), and any word or expression to which a meaning has been assigned in the Act shall bear such meaning and, unless the context indicates otherwise—

"police official" means any member of the Force as defined in section 1 of the Police Act, 1958 (Act No. 7 of 1958);

"prescribed fees" means the fees referred to in regulation 9;

"Registrar of the Board" means the Registrar appointed by the Board under section 3 (d) or a person lawfully acting in that capacity.

Application for registration as a security officer

2. An application for registration as a security officer in terms of section 11 of the Act shall be made to the Board and shall be submitted to the Registrar of the Board on the form set out in Annexure A, and shall be accompanied by the prescribed fees as well as a clear and complete set of fingerprints referred to in section 11 (1) (a) of the Act, which fingerprints shall be taken by or in the presence of a police official on form SAP 91 (a).

Register of security officers

3. A register of security officers which for the purposes of section 13 of the Act is kept by the Board, shall subject to the provisions of section 13 of the Act include the following particulars:

(a) The number of the registration certificate issued by the Board in terms of section 14 of the Act, as well as the number allotted to the security officer by the Board;

(b) the date of the registration certificate referred to in paragraph (a);

(c) the residential and business address (business street address and business postal address) of the security officer;

(d) the identity number, date of birth and nationality of the security officer if the security officer is a natural person;

(e) die besonderhede van die sekuriteitsdiens wat deur die sekuriteitsbeampte gelewer word asook die kategorie van sekuriteitsbeamptes waarin die sekuriteitsbeampte geklassifiseer word;

(f) die naam van die maatskappy of beslote korporasie indien die maatskappy of beslote korporasie 'n sekuriteitsdiens lewer, asook die naam van elke direkteur van sodanige maatskappy en elke lid van sodanige beslote korporasie;

(g) die naam van die werkewer van 'n sekuriteitsbeampte indien 'n sekuriteitsbeampte in die loop van sy diens deur die werkewer vir die levering van 'n sekuriteitsdiens gebruik word;

(h) besonderhede van enige skuldigbevinding aan onbehoorlike gedrag ingevolge artikel 20 van die Wet of skuldigbevinding aan 'n misdryf vermeld in die Bylae by die Wet of skuldigbevinding aan 'n misdryf ingevolge artikel 35 van die Wet.

Aansoek om naamsverandering van 'n sekuriteitsbeampte

4. 'n Aansoek om 'n persoon wat as sekuriteitsbeampte geregistreer is se naam in die register te verander, word by die Raad gedoen en word voorgelê aan die Registrateur van die Raad en gaan vergesel van die volgende:

(a) Die huweliksertikaat van 'n vroulike sekuriteitsbeampte of 'n kopie daarvan deur 'n kommissaris van ede gewaarmerk;

(b) skriftelike bewys van 'n naamsverandering kragtens die Wet op Vreemdelinge, 1937 (Wet No. 1 van 1937);

(c) in die geval van 'n maatskappy of beslote korporasie, skriftelike bewys van sodanige naamsverandering.

Registrasiesertikaat

5. (1) Die Raad moet vir die doeleindes van artikel 14 van die Wet 'n registrasiesertikaat uitrek aan elke persoon wat as 'n sekuriteitsbeampte geregistreer is op die vorm wat in Aanhangsel B uiteengesit word en wat onderteken moet word deur die Registrateur van die Raad.

(2) Die Raad kan op aansoek van 'n persoon wat as 'n sekuriteitsbeampte geregistreer is 'n nuwe registrasiesertikaat aan sodanige sekuriteitsbeampte uitrek indien die Raad oortuig is dat die oorspronklike registrasiesertikaat vernietig is of verlore geraak het en nie gevind kan word nie.

(3) Nadat 'n naamsverandering van 'n persoon wat as 'n sekuriteitsbeampte geregistreer is in die register aangebring is, kan die Raad die oorspronklike registrasiesertikaat vervang deur 'n nuwe registrasiesertikaat.

Verandering betreffende inligting aan die Raad verskaf

6. (1) 'n Persoon wat as 'n sekuriteitsbeampte geregistreer is moet die Raad binne 14 dae skriftelik in kennis stel van enige verandering met betrekking tot inligting wat aan die Raad verskaf is gedurende die aansoek om registrasie as 'n sekuriteitsbeampte, en indien sodanige verandering betrekking het op die naam van 'n sekuriteitsbeampte, word 'n aansoek om 'n naamsverandering ingevolge regulasie 4 onverwyld by die Raad gedoen.

(2) Iemand wat 'n bepaling van subregulasie (1) oortree of versuum om daaraan te voldoen, is skuldig aan 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van hoogstens R300 of met gevangenisstraf vir 'n tydperk van hoogstens drie maande.

(e) the particulars of the security services rendered by the security officer as well as the category of security officers into which the security officer is classified;

(f) the name of the company or close corporation if the company or close corporation renders a security service, as well as the name of every director of such company and every member of such close corporation;

(g) the name of the employer of a security officer if a security officer is used in the course of his employment by the employer for the rendering of a security service;

(h) particulars of any conviction of improper conduct in terms of section 20 of the Act or conviction of an offence specified in the Schedule to the Act or conviction of an offence in terms of section 35 of the Act.

Application for change of name of a security officer

4. An application to change the name of a person registered as a security officer on the register shall be made to the Board and shall be submitted to the Registrar of the Board and shall be accompanied by the following:

(a) The marriage certificate of a female security officer or a copy thereof certified by a commissioner of oaths;

(b) written proof of the change of name in terms of the Aliens Act, 1937 (Act No. 1 of 1937);

(c) in case of a company or close corporation, written proof of such change of name.

Registration certificate

5. (1) The Board shall, for the purposes of section 14 of the Act, issue to each person registered as a security officer a registration certificate on the form set out in Annexure B and which shall be signed by the Registrar of the Board.

(2) The Board may, on application of a person registered as a security officer, issue a new registration certificate to such security officer if the Board is satisfied that the original registration certificate has been lost or destroyed and cannot be found.

(d) After effecting a change of name of a person registered as a security officer in the register, the Board may replace the original registration certificate with a new registration certificate.

Change with regard to information submitted to the Board

6. (1) A person registered as a security officer shall inform the Board in writing within 14 days of any change with regard to information submitted to the Board during the application for registration as a security officer, and if such change relates to the name of a security officer, an application for the change of name shall forthwith be made to the Board in terms of regulation 4.

(2) Any person who contravenes or fails to comply with a provision of subregulation (1) shall be guilty of an offence and shall on conviction be liable to a fine not exceeding R300 or to imprisonment for a period not exceeding three months.

Betaling van jaargelde

7. (1) Elke sekuriteitsbeampte wat op 1 Januarie van elke jaar geregistreer is, moet die voorgeskrewe gelde aan die Raad betaal.

(2) Die voorgeskrewe gelde bedoel in subregulasie (1) is verskuldig en betaalbaar op die datum daarin vermeld en moet betaal word voor 31 Maart van elke jaar.

8. (1) 'n Sekuriteitsbeampte wie se naam na 1 Januarie van 'n jaar in die register ingeskryf is se voorgeskrewe gelde word *pro rata* verminder ooreenkomsdig die getal volle maande wat in daardie jaar verloop het voor die datum waarop sy naam aldus ingeskryf is.

(2) Die voorgeskrewe gelde bedoel in subregulasie (1) moet binne drie maande na bedoelde datum waarop die naam ingeskryf word, betaal word.

Voorgeskrewe gelde

9. Die gelde betaalbaar ingevolge hierdie regulasies, is soos volg:

(a) Aansoek om registrasie as 'n sekuriteitsbeampte vir die doeleindes van regulaasie 2: **R35**.

(b) Betaling van jaargelde vir die doeleindes van regulaasie 7 (1): **R70**.

Wyse van appèl na die Minister teen sekere besluite van die Raad kragtens artikel 21 van die Wet

10. (1) Iemand wat ingevolge die bepalings van artikel 21 (1) van die Wet by die Minister appèl wil aanteken teen 'n besluit bedoel in paragraaf (a), (b) of (c) van artikel 21 (1) moet by skriftelike kennisgewing op die Minister beteken teen sodanige besluit appelleer, en moet—

(a) in die kennisgewing die gronde vir appèl en enige argumente en betoë wat ter stawing van die gronde aangevoer word, volledig uiteensit;

(b) 'n juiste kopie van die kennisgewing op die voorsitter van die Raad beteken; en

(c) skriftelike bewys aan die Minister voorlê van die betekening van die kopie bedoel in paragraaf (b),

en vir die doeleindes van hierdie regulaasie geskied betekening deur sodanige skriftelike kennisgewing of kopie persoonlik aan die Minister of die voorsitter van die Raad, na gelang van die geval, te oorhandig of per geregistreerde pos aan die Minister of sodanige voorsitter te stuur.

(2) Die Kommissaris of 'n offisier van die Suid-Afrikaanse Polisie deur die Kommissaris aangewys, stel die betrokke appellant en die Raad onverwyld in kennis van die beslissing van die Minister ingevolge artikel 21 (3) van die Wet.

Payment of annual fees

7. (1) Every security officer who is registered on 1 January of every year shall pay the prescribed fees to the Board.

(2) The prescribed fees referred to in subregulation (1) are due and payable on the date mentioned therein and shall be paid before 31 March of every year.

8. (1) The prescribed fees of a security officer whose name is entered in the register after 1 January of a year shall be decreased on a *pro rata* basis according to the number of full months which have elapsed in that year prior to the date on which his name was so entered.

(2) The prescribed fees mentioned in subregulation (1) shall be paid within three months of the said date on which the name was entered.

Prescribed fees

9. The fees payable in terms of these regulations shall be as follows:

(a) Application for registration as a security officer for the purposes of regulation 2: **R35**.

(b) Payment of annual fees for the purposes of regulation 7 (1): **R70**.

Manner of appeal to the Minister against certain decisions of the Board in terms of section 21 of the Act

10. (1) Any person who wishes to appeal to the Minister in terms of section 21 (1) against a decision referred to in paragraph (a), (b) or (c) of section 21 (1), shall by notice in writing served on the Minister appeal against such decision, and shall—

(a) set out fully and clearly in the notice the grounds of appeal and any arguments and representations which may be advanced in support of the grounds;

(b) serve a true copy of the notice on the chairman of the Board;

(c) submit to the Minister written proof of the service of the copy referred to in paragraph (b),

and for the purposes of this regulation service shall be effected by handing such written notice or copy thereof to the Minister or the chairman of the Board, as the case may be, personally or sending it by registered post to the Minister or such chairman.

(2) The Commissioner or a commissioned officer of the South African Police designated by the Commissioner shall forthwith inform the appellant concerned and the Board of the decision of the Minister in terms of section 21 (3) of the Act.
