CITRUS SCHEME.—LEVY AND SPECIAL
LEVY—AMENDMENT

I, Jacob de Villiers, Minister of Agriculture, hereby make known in terms of section 79 of the Marketing Act, 1968 (Act No. 59 of 1968), that—

(a) the Citrus Board referred to in section 6 of the Citrus Scheme published by Proclamation No. R. 2 of 1979, as amended, has under sections 20 and 21 of the said Scheme amended the Schedule to Government Notice No. R. 1978 of 15 September 1989, to the extent set out in the Schedule hereto; and

SCHEDULE

Definition

1. In this Schedule "the Notice" means Government Notice No. R. 1978 of 15 September 1989.

Amendment of clause 3 of the Notice

2. Clause 3 of the Notice is hereby amended by the deletion of subclause (2) (b).

Substitution of the Table in the Notice

3. The following Table is hereby substituted for the Table in the Notice:

(b) the said amendment has been approved by me and shall come into operation on the date of publication hereof.
