MAGISTRATES' COURTS.—AMENDMENT OF  
THE RULES OF COURT

The Rules Board for Courts of Law has, under section 6 of the Rules Board for Courts of Law Act, 1985 (Act No. 107 of 1985), read with section 10 of the Enforcement of Foreign Civil Judgments Act, 1988 (Act No. 32 of 1988), with the approval of the Minister of Justice, made the rules in the Schedule.

"43A Afdwinging van Buitelandse Siviele Vonnis . . . — —".

**Wysiging van die INHOUDSOPGAWE (ALFABETIES) van die Reëls**

3. Die INHOUDSOPGAWE (ALFABETIES) van die Reëls word hierby gewysig deur die volgende uitdrukking na die uitdrukking "Aansoek om Deurhaling, Eksepsies en . . ." in te voeg:

"Afdwinging van Buitelandse Siviele Vonnis . . . 43A — —".

**Invoeging van reël 43A in die Reëls**

4. Die Reëls word hierby gewysig deur die volgende reël na reël 43 in te voeg:

**"REËL 43A****Afdwinging van Buitelandse Siviele Vonnis**

43A. (1) Wanneer 'n gewaarmerkte afskrif van 'n vonnis bedoel in artikel 3 (1) van die Wet op die Afdwinging van Buitelandse Siviele Vonnis, 1988 (Wet No. 32 van 1988), by 'n klerk van die hof in die Republiek ingedien word, regstreer sodanige klerk van die hof daardie vonnis deur dit te nommer met 'n volgnommer vir die jaar waarin dit ingedien word en deur die besonderhede ten opsigte van die vonnis bedoel in paragrawe (a), (b) en (c) van genoemde artikel 3 (1) op die saakomslag aan te teken.

(2) Die vonnisskuldeiser moet, tesame met die gewaarmerkte afskrif van 'n vonnis bedoel in subreël (1)—

(a) 'n beëdigde verklaring gedoen deur homself of deur iemand anders wat ondergenoemde feite kan bevestig, indien—

(i) waarin die bedrag rente verskuldig, die toepaslike rentekoers en die wyse waarop die bedrag rente bereken is, vermeld word; en

2. The TABLE OF CONTENTS AND COMPARATIVE TABLE OF NUMBERS OF NEW RULES AND CORRESPONDING NUMBERS OF PREVIOUS RULES of the Rules is hereby amended by the insertion of the following expression after the expression "43 Execution against Immovable Property . . .":

"43A Enforcement of Foreign Civil Judgments . . . — —".

**Amendment of the INDEX (ALPHABETICAL) of the Rules**

3. The INDEX (ALPHABETICAL) of the Rules is hereby amended by the insertion of the following expression after the expression "Endorsement of Summons . . .":

"Enforcement of Foreign Civil Judgments . . . 43A — —".

**Insertion of rule 43A in the Rules**

4. The Rules are hereby amended by the insertion of the following rule after rule 43:

**"RULE 43A****Enforcement of Foreign Civil Judgments**

43A. (1) Whenever a certified copy of a judgment referred to in section 3 (1) of the Enforcement of Foreign Civil Judgments Act, 1988 (Act No. 32 of 1988), is filed with a clerk of the court in the Republic, such clerk of the court shall register that judgment by numbering it with a consecutive number for the year during which it is filed and by noting the particulars in respect of the judgment referred to in paragraphs (a), (b) and (c) of the said section 3 (1) on the case cover.

(2) The judgment creditor shall, together with the certified copy of a judgment referred to in subrule (1)—

(a) file an affidavit made by himself or by somebody else who can confirm the undermentioned facts—

(i) stating the amount of interest due, the appropriate rate of interest and how the amount of interest has been calculated; and

Hierdie reëls tree op 8 September 1990 in werking.</p>	<p>(ii) stating whether any amount has been paid by the judgment debtor since judgment, and, if so, whether such amount has been deducted from the capital amount of the judgment debt or from the interest or costs, as the case may be; and</p> <p>(b) if any amount payable under the judgment is expressed in a currency other than the currency of the Republic, file a certificate issued by a banking institution registered in terms of section 4 of the Banks Act, 1965 (Act No. 23 of 1965), stating the rate of exchange prevailing at the date of the judgment.</p> <p>(3) A notice issued in terms of section 3 (2) of the Enforcement of Foreign Civil Judgments Act, 1988 (Act No. 32 of 1988), shall contain—</p> <ul style="list-style-type: none"> <li>(a) the consecutive number referred to in subrule (1);</li> <li>(b) the date on which the judgment was registered;</li> <li>(c) the balance of the amount payable under the judgment;</li> <li>(d) the taxed costs awarded by the court of the designated country;</li> <li>(e) the interest, if any, which by the law or by order of the court of the designated country concerned is due on the amount payable under the judgment up to the time of registration of the judgment;</li> <li>(f) the reasonable costs of and incidental to the registration of the judgment, including the costs of obtaining a certified copy of the judgment;</li> <li>(g) the names of the parties concerned; and</li> <li>(h) the name of the court where the judgment was given.”.</li> </ul> <p>5. These rules shall come into operation on 8 September 1990.</p>
