GEKONSOLIDEERDE PADVERKEERS- REGULASIES. — WYSIGING

Die Minister van Vervoer en van Openbare Werke en Grondsake, handelende kragtens artikel 132 van die Padverkeerswet, 1989 (Wet No. 29 van 1989), het die regulasies in die Bylae uitgevaardig.

BYLAE

Woordomskrywing

1. In hierdie Bylae beteken "die Regulasies" die regulasies gepubliseer by Goewermenskennisgewing No. R. 910 van 26 April 1990 soos gewysig by Goewermenskennisgewing No. R. 1312 van 13 Junie 1990.

Wysiging van Regulasie 26 van die Regulasies

2. Regulasie 26 van die Regulasies word hiermee gewysig deur—

(a) paragraaf (a) van subregulasie (2) van die Engelse weergawe met die volgende paragraaf te vervang:

"(a) if the applicant is a motor dealer who requires a series of blank temporary permits, by applying to the appropriate registering authority on a form similar to the prescribed form as shown in Appendix 2 to Part One of Schedule 4, and on production of the identity document of such motor dealer and for this purpose the said registering authority may issue a series of blank temporary permits on a form similar to the prescribed form as shown in Appendix 2 to Part One of Schedule 4: Provided that the registering authority may, at any time after reasonable notice to such dealer, order that all unused temporary permits be returned, or the said dealer may return such permits without any amount being refundable;" en

ROAD TRAFFIC ACT, 1989
(ACT No. 29 OF 1989)

CONSOLIDATED ROAD TRAFFIC REGULATIONS. — AMENDMENT

The Minister of Transport and of Public Works and Land Affairs, acting in terms of section 132 of the Road Traffic Act, 1989 (Act No. 29 of 1989), promulgated the regulations in this Schedule.

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the regulations published by Government Notice No. R. 910 of 26 April 1990 as amended by Government Notice No. R. 1312 of 13 June 1990.

Amendment of Regulation 26 of the Regulations

2. Regulation 26 of the Regulations is hereby amended by—

(a) the substitution for paragraph (a) of subregulation (2) of the following paragraph:

"(a) if the applicant is a motor dealer who requires a series of blank temporary permits, by applying to the appropriate registering authority on a form similar to the prescribed form as shown in Appendix 2 to Part One of Schedule 4, and on production of the identity document of such motor dealer and for this purpose the said registering authority may issue a series of blank temporary permits on a form similar to the prescribed form as shown in Appendix 2 to Part One of Schedule 4: Provided that the registering authority may, at any time after reasonable notice to such dealer, order that all unused temporary permits be returned, or the said dealer may return such permits without any amount being refundable;" and

(b) paragraaf (c) van subregulasie (2) met die volgende paragraaf te vervang:

“(c) waar ’n motorvoertuig van ’n motorhandelaar verkry word en die permit ’n tydelike permit is, by daardie handelaar wat die permit en teenblad behoorlik voltooi, die permit uitreik en die teenblad behou: Met dien verstande dat die handelaar binne sewe dae na die datum van uitreiking van die laaste permit in ’n reeks in paragraaf (a) beoog al die teenblaaie van die reeks aan die toepaslike registrasie-owerheid oorhandig.”.

Wysiging van Regulasie 44 van die Regulasies

3. Regulasie 44 van die Regulasies word hiermee gewysig deur die skraping van item (179).

Wysiging van Regulasie 59 van die Regulasies

4. Regulasie 59 van die Regulasies word hiermee gewysig deur paragraaf (a) van subregulasie (1) met die volgende paragraaf te vervang:

“(a) (i) binne 21 dae van die datum in regulasie 58 (a) of (b) genoem, gedoen word; of”.

Wysiging van Regulasie 239 van die Regulasies

5. Regulasie 239 van die Regulasies word hiermee gewysig deur—

(a) die vervanging van paragraaf (b) (vi) van subregulasie (3) deur die volgende paragraaf:

“(vi) voor 31 Desember 1985, met betrekking tot ’n swaar motorvoertuig, synde—

(aa) ’n motorvoertuig anders as ’n bus of goederevoertuig, waarvan die tarra 9 000 kilogram oorskry maar nie 16 000 kilogram nie;

(bb) ’n bus of goederevoertuig waarvan die bruto voertuigmassa 9 000 kilogram oorskry maar nie 16 000 kilogram nie; of

(cc) ’n gelede motorvoertuig, waarvan die bruto voertuigmassa van die trekvoertuig waarvan nie 16 000 kilogram oorskry nie,

magtig ook die bestuurder van ’n voertuig waarvoor ’n kode 13-lisensie soos in subregulasie (1) beoog, vereis word; of”;

(b) die vervanging van paragraaf (b) (vii) van subregulasie (3) van die Engelse weergawe deur die volgende paragraaf:

“(vii) prior to 31 December 1985, in respect of an extra heavy motor vehicle, being—

(aa) a motor vehicle other than a bus or goods vehicle, the tare of which exceeds 16 000 kilograms; or

(bb) a bus or a goods vehicle the gross vehicle mass of which exceeds 16 000 kilograms,

shall also authorize the driving of a vehicle for which a code 14 licence as contemplated in subregulation (1) is required.”; en

(c) paragraaf (b) van subregulasie (4) met die volgende paragraaf te vervang:

“(b) ’n Leerlinglisensie ten opsigte van ’n motorfiets sonder syspan verleen nie aan die houder daarvan die reg om sodanige motorfiets op ’n openbare pad te bestuur terwyl ’n ander persoon vervoer word nie; en”.

(b) the substitution for paragraph (c) of subregulation (2) of the following paragraph:

“(c) if a motor vehicle is obtained from a motor dealer and the permit is a temporary permit, from that dealer who shall duly complete the permit and counterfoil, issue the permit and retain the counterfoil: Provided that the dealer shall return all counterfoils of a series as contemplated in paragraph (a) to the registering authority within seven days after the issue of the last permit in such series.”.

Amendment of Regulation 44 of the Regulations

3. Regulation 44 of the Regulations is hereby amended by the deletion of item (179).

Amendment of Regulation 59 of the Regulations

4. Regulation 59 of the Regulations is hereby amended by the substitution for paragraph (a) of subregulation (1) of the following paragraph:

“(a) (i) be made within 21 days of the date referred to in regulation 58 (a) or (b); or”.

Amendment of Regulation 239 of the Regulations

5. Regulation 239 of the Regulations is hereby amended by—

(a) the substitution for paragraph (b) (vi) of subregulation (3) of the following paragraph:

“(vi) prior to 31 December 1985, in respect of a heavy motor vehicle, being—

(aa) a motor vehicle, other than a bus or goods vehicle, the tare of which exceeds 9 000 kilograms but does not exceed 16 000 kilograms;

(bb) a bus or goods vehicle the gross vehicle mass of which exceeds 9 000 kilograms but does not exceed 16 000 kilograms; or

(cc) an articulated motor vehicle, the gross vehicle mass of the drawing vehicle of which does not exceed 16 000 kilograms,

shall also authorize the driving of a motor vehicle for which a code 13 licence, as contemplated in subregulation (1) is required; or”;

(b) the substitution for paragraph (b) (vii) of subregulation (3) of the following paragraph:

“(vii) prior to 31 December 1985, in respect of an extra heavy motor vehicle, being—

(aa) a motor vehicle other than a bus or goods vehicle, the tare of which exceeds 16 000 kilograms; or

(bb) a bus or a goods vehicle the gross vehicle mass of which exceeds 16 000 kilograms,

shall also authorize the driving of a vehicle for which a code 14 licence as contemplated in subregulation (1) is required.”; and

(c) the substitution for paragraph (b) of subregulation (4) of the following paragraph:

“(b) a learner’s licence, in respect of a motor cycle without side-car, shall not authorize the holder thereof to drive such motor cycle on a public road while carrying another person; and”.

Wysiging van Regulasie 242 van die Regulasies

6. Regulasie 242 van die Regulasies word hiermee gewysig deur die vervanging van subregulasie (3) deur die volgende subregulasie:

“(3) ’n Aansoek om ’n leerlinglisensie ingevolge artikel 29 (1) van die Wet word by die Staatsdepartement waar die aansoeker in diens is, gedoen.”.

Wysiging van Regulasie 244 van die Regulasies

7. Regulasie 244 van die Regulasies word hiermee gewysig deur die bestaande regulasie wat subregulasie (1) word en die invoeging na subregulasie (1) van die volgende subregulasie:

“(2) In die geval van ’n aansoek om ’n leerlinglisensie ingevolge artikel 29 (1) van die Wet, sal die bepalings van subartikels (4) en (5) van artikel 23 van die Wet *mutatis mutandis* geld: Met dien verstande dat geen gelde vir die uitreiking van so ’n leerlinglisensie betaal word nie.”.

Wysiging van Regulasie 245 van die Regulasies

8. Regulasie 245 van die Regulasies word hiermee gewysig deur—

(a) die vervanging van paragraaf (a) (ii) van subregulasie (3) deur die volgende paragraaf:

“(ii) ’n amptelike brief van die betrokke Staatsdepartement wat—

(aa) sertifiseer dat die lisensie wat deur die aansoeker gehou word geldig is; en

(bb) die ekwivalent kategorie van sodanige lisensie aandui soos bedoel in regulasie 239; en

(cc) enige voorwaardes en beperkings aandui van sodanige lisensie.”;

(b) die vervanging van paragraaf (b) van subregulasie (3) deur die volgende paragraaf:

“(b) By ontvangs van ’n aansoek in paragraaf (a) beoog, moet ’n toetsbeampde vir bestuurderslisensie na betaling van die voorgeskrewe gelde soos bedoel in item 4 van Bylae 1 en indien hy tevrede is dat die dokumente in paragraaf (a) (i) en (ii) geldig is en betrekking het op die kategorie bestuurderslisensie waarvoor sodanige applikant aansoek gedoen het, optree ingevolge regulasie 247: Met dien verstande dat die lisensie deur die Staatsdepartement uitgereik nie gekanselleer word nie.”; en

(c) subregulasie (4) met die volgende subregulasie te vervang:

“(4) ’n Aansoek om ’n bestuurderslisensie ingevolge artikel 29 (1) van die Wet word gedoen by die Staatsdepartement waar die aansoeker in diens is.”

Wysiging van Regulasie 246 van die Regulasies

9. Regulasie 246 van die Regulasies word hiermee gewysig deur die invoeging na subregulasie (2) van die volgende subregulasie:

“(3) Die toetsbeampde vir bestuurderslisensies moet in navolging van paragraaf (2) (e) in die geval van ’n aansoeker om ’n kode 08 bestuurderslisensie, sodanige aansoeker toets in ooreenstemming met die K53 Praktiese toets vir voertuig bestuurders Volume 1—Ligtemotorvoertuie soos gepubliseer deur die Nasionale Verkeersveiligheidsraad.”.

Amendment of Regulation 242 of the Regulations

6. Regulation 242 of the Regulations is hereby amended by the substitution for subregulation (3) of the following subregulation:

“(3) An application for a learner's licence in terms of section 29 (1) of the Act shall be made to the department of State where the applicant is employed.”.

Amendment of Regulation 244 of the Regulations

7. Regulation 244 of the Regulations is hereby amended by the existing regulation becoming subregulation (1) and the insertion after subregulation (1) of the following subregulation:

“(2) In the case of an application for a learner's licence in terms of section 29 (1) of the Act, the provisions of subsections (4) and (5) of section 23 of the Act shall apply *mutatis mutandis*: Provided that no fee for the issue of a learner's licence shall be paid.”.

Amendment of Regulation 245 of the Regulations

8. Regulation 245 of the Regulations is hereby amended by—

(a) the substitution for paragraph (a) (ii) of subregulation (3) of the following paragraph:

“(ii) an official letter from the department of State concerned—

(aa) certifying that the licence held by the applicant is valid;

(bb) indicating the equivalent category of such licence, as contemplated in regulation 239; and

(cc) indicating any conditions and limitations relating to such licence.”;

(b) the substitution for paragraph (b) of subregulation (3) of the following paragraph:

“(b) Upon receipt of an application contemplated in paragraph (a), an examiner for drivers' licences shall upon payment of the fee prescribed in item 4 of Schedule 1, if satisfied that the documents contemplated in paragraphs (a) (i) and (ii) are valid and relate to the category of driver's licence for which such applicant applied, act in terms of regulation 247: Provided that the licence issued by the department of State shall not be cancelled.”; and

(c) the substitution for subregulation (4) of the following subregulation:

(4) An application for a driver's licence in terms of section 29 (1) of the Act shall be made to the department of State where the applicant is employed.”.

Amendment of Regulation 246 of the Regulations

9. Regulation 246 of the Regulations is hereby amended by the insertion after subregulation (2) of the following subregulation:

“(3) The examiner for driver's licences shall in complying with paragraph (2) (e), in the case of an applicant for a code 08 driver's licence, test such applicant in accordance with the K53 Practical driving test for motor vehicle drivers, Volume 1—Light Motor Vehicles, as published by the National Road Safety Council.”.

Wysiging van Regulasie 247 van die Regulasies

10. Regulasie 247 van die Regulasies word hiermee gewysig deur die huidige regulasie wat subregulasie (1) word en die invoeging van die volgende subregulasies na subregulasie (1):

“(2) ’n Lisensie in artikel 29 (1) van die Wet beoog word deur ’n gemagtigde persoon uitgereik in ooreenstemming met subartikel (7) van artikel 24 van die Wet.

(3) By ontvangs van ’n bestuurderslisensie en identiteitsdokument bedoel in subregulasie (2), moet die Direkteur-generaal van Binnelandse Sake handel ingevolge subartikel (8) van artikel 24 van die Wet.”.

Wysiging van Regulasie 250 van die Regulasies

11. Regulasie 250 van die Regulasies word hiermee gewysig deur—

(a) die vervanging van subregulasie (7) deur die volgende subregulasie:

“(7) Waar die Administrateur nie die aansoek ingevolge subregulasie (6) weier nie, laat die Direkteur-generaal: Provinsiale Administrasie die aansoeker, by ’n plek en deur ’n bevoegde persoon deur hom aangewys, ondervra en toets ten einde ’n verslag op die vorm, deur die Administrateur bepaal, oor die bevoegdheid van die aansoeker om as ’n instrukteur op te tree, te verkry: Met dien verstande dat indien die aansoeker—

(a) aansoek doen om in die gebied van meer as een registrasie-owerheid as ’n instrukteur op te tree en die aansoeker vir die gebied van ten minste een registrasie-owerheid aldus ondervra en getoets word, die Administrateur ten opsigte van die ander registrasie-owerhede van enige verdere ondervraging en toets kan afsien;

(b) aansoek doen om ’n instrukteursertifikaat te hernuwe, die Administrateur van sodanige ondervraging en toets kan afsien.”; en

(b) die skraping van subregulasie (20).

Wysiging van Regulasie 251 van die Regulasies

12. Regulasie 251 van die Regulasies word hiermee gewysig deur—

(a) paragraaf (a) van subregulasie (2) met die volgende paragraaf te vervang:

“(a) ten opsigte van ’n motorvoertuig wat persone of goedere teen vergoeding vervoer en ’n teëspoedwa, wat die eiendom is van ’n Staatsdepartement, ’n Provinsiale Administrasie, of die Administrasie van Suidwes-Afrika, of enige plaaslike owerheid;” en

(b) na paragraaf (d) van subregulasie (2) die volgende paragrawe in te voeg:

“(e) op ’n persoon wat ’n lykswa bestuur;

(f) op ’n persoon wat ’n ambulans bestuur;

(g) op ’n persoon wat ’n motorvoertuig wat die eiendom van ’n plaaslike owerheid is en wat nie ’n minibus of ’n bus is nie bestuur; en

(h) op ’n persoon wat ’n motorvoertuig wat skoolkinders vervoer, wat nie ’n minibus of ’n bus is nie bestuur.”.

Amendment of Regulation 247 of the Regulations

10. Regulation 247 of the Regulations is hereby amended by the existing regulation becoming subregulation (1) and the insertion after subregulation (1) of the following subregulations:

“(2) A licence contemplated in section 29 (1) of the Act shall be issued by an authorized person in accordance with subsection (7) of section 24 of the Act.

(3) Upon receipt of a driver's licence and identity document referred to in subregulation (2), the Director-General of Home Affairs shall act in accordance with subsection (8) of section 24 of the Act.”.

Amendment of Regulation 250 of the Regulations

11. Regulation 250 of the Regulations is hereby amended by—

(a) the substitution for subregulation (7) of the following subregulation:

“(7) Where the Administrator does not refuse the application in terms of subregulation (6), the Director-General: Provincial Administration shall cause the applicant to be examined and tested at a place and by a competent person designated by him, in order to obtain a report on the form determined by the Administrator on the competence of the applicant to act as an instructor: Provided that if the applicant—

(a) applies to act as an instructor in the area of more than one registering authority and the applicant is so examined and tested for the area of at least one registering authority, the Administrator may in respect of the other registering authorities dispense with any further examination and test;

(b) applies to renew an instructor's certificate, the Administrator may dispense with such examination and test.”; and

(b) the deletion of subregulation (20).

Amendment of Regulation 251 of the Regulations

12. Regulation 251 of the Regulations is hereby amended by—

(a) the substitution for paragraph (a) of subregulation (2) of the following paragraph:

“(a) in respect of a motor vehicle conveying persons or goods for reward and a breakdown vehicle, owned by a department of State, Provincial Administration, the Administration of South West Africa or a local authority;” and

(b) the insertion after paragraph (d) of subregulation (2) of the following paragraphs:

“(e) to a person driving a hearse;

(f) to a person driving an ambulance;

(g) to a person driving a motor vehicle owned by a local authority which is not a mini-bus or a bus; and

(h) to a person driving a motor vehicle which is used for the conveyance of school children and which is not a mini-bus or a bus.”.

Wysiging van Regulasie 267 van die Regulasies

13. Regulasie 267 van die Regulasies word hiermee gewysig deur—

(a) Subregulasie (1) met die volgende subregulasie te vervang:

“(1) Niemand mag ’n motorvoertuig wat persone of goedere teen vergoeding vervoer of ’n teëspoedwa op ’n openbare pad gebruik nie—

(a) tensy daar ten opsigte van sodanige voertuig ’n geskikheidsertifikaat van krag is; en

(b) behalwe ooreenkomstig die bepalings en voorwaardes van sodanige sertifikaat.”; en

(b) die volgende subregulasie na subregulasie (3) in te voeg:

“(4) Die bepalings van subregulasie (1) is nie van toepassing op die volgende voertuie nie:

(a) ’n lykswa;

(b) ’n ambulans;

(c) ’n motorvoertuig van ’n plaaslike owerheid wat nie ’n minibus of ’n bus is nie; en

(d) ’n voertuig wat skoolkinders vervoer wat nie ’n minibus of ’n bus is nie.”.

Wysiging van Regulasie 268 van die Regulasies

14. Regulasie 268 van die Regulasies word hiermee gewysig deur—

(a) paragraaf (b) van subregulasie (1) deur die volgende paragraaf te vervang:

“(b) by enige registrasie-owerheid wat die Direkteur-generaal: Provinsiale Administrasie betrokke toelaat;”; en

(b) paragraaf (c) van subregulasie (1) deur die volgende paragraaf te vervang:

“(c) indien sodanige voertuig geag word in die Republiek geregistreer te wees deurdat die registrasie daarvan elders uitgevoer is, by enige registrasie-owerheid; of”; en

(c) die invoeging van die volgende paragraaf na paragraaf (c) van subregulasie (1):

“(d) indien sodanige voertuig in ’n provinsie geregistreer is, anders as die provinsie waar aansoek gedoen word om ’n geskikheidsertifikaat, by enige registrasie-owerheid.”.

Wysiging van Regulasie 273 van die Regulasies

15. Regulasie 273 van die Regulasies word hiermee gewysig deur die uitdrukking “geskikheidsertifikaat” in paragraaf (a) van subregulasie (1) te vervang met die uitdrukking “geskikheidsertifikaatskyf.”.

Wysiging van Regulasie 281 van die Regulasies

16. Regulasie 281 van die Regulasies word hiermee gewysig deur—

(a) subregulasie (3) met die volgende subregulasie te vervang:

“(3) Waar ’n motorvoertuig in ooreenstemming met ’n kennisgewing in subregulasie (1) beoog, ondersoek is en padwaardig bevind word, moet die betrokke toetsstasie—

(a) daardie kennisgewing kanselleer;

(b) enige klaringsbewys, geskikheidsertifikaat of geskikheidsertifikaatskyf wat ingevolge subregulasie (1) verwyder is, aan die persoon wat daarop geregtig is, terugbesorg;

Amendment of Regulation 267 of the Regulations

13. Regulation 267 of the Regulations is hereby amended by—

(a) the substitution for subregulation (1) of the following subregulation:

“(1) No person shall operate on a public road a motor vehicle conveying persons or goods for reward or a breakdown vehicle—

(a) unless there is in force in respect of such vehicle a certificate of fitness; and

(b) except in accordance with the terms and conditions of such certificate.”; and

(b) the insertion after subregulation (3) of the following subregulation:

“(4) The provisions of subregulation (1) shall not apply to the following motor vehicles:

(a) a hearse;

(b) an ambulance;

(c) a motor vehicle owned by a local authority which is not a mini-bus or bus; and

(d) a motor vehicle which is used for the conveyance of school children which is not a mini-bus or a bus.”.

Amendment of Regulation 268 of the Regulations

14. Regulation 268 of the Regulations is hereby amended by—

(a) the substitution for paragraph (b) of subregulation (1) of the following paragraph:

“(b) to any such registering authority as the Director-General: Provincial Administration concerned may allow;”; and

(b) the substitution for paragraph (c) of subregulation (1) of the following paragraph:

“(c) if such vehicle is deemed to be registered in the Republic by virtue of the registration thereof having been effected elsewhere, to any registering authority; or”; and

(c) the insertion after paragraph (c) of subregulation (1) of the following paragraph:

“(d) if such vehicle is registered in a province other than the province in which the application for a certificate of fitness is made, to any registering authority.”.

Amendment of Regulation 273 of the Regulations

15. Regulation 273 of the Regulations is hereby amended by the substitution of paragraph (a) of subregulation (1) in the Afrikaans version of the expression “geskikheidsertifikaat” for the expression “geskikheidsertifikaatskyf.”.

Amendment of Regulation 281 of the Regulations

16. Regulation 281 of the Regulations is hereby amended by—

(a) the substitution for subregulation (3) of the following subregulation:

“(3) Where a motor vehicle has been examined in accordance with a notice contemplated in regulation 280 and is found to be roadworthy, the testing station concerned shall—

(a) cancel that notice;

(b) return any clearance certificate, and certificate of fitness or certificate of fitness disc removed in terms of subregulation (1), to the person entitled thereto;

(c) indien die geskikheidsertifikaat of geskikheidsertifikaatskyf vernietig is, 'n duplikaat geskikheidsertifikaatskyf ten opsigte van sodanige voertuig in ooreenstemming met die bepalings van die Wet uitreik." en

(b) subregulasie (4) met die volgende subregulasie te vervang:

"(4) Die eerste ondersoek van 'n motorvoertuig in ooreenstemming met 'n kennisgewing in regulasie 280 beoog, moet kosteloos gedoen word, maar vir elke daaropvolgende ondersoek moet die eienaar van sodanige motorvoertuig aan die betrokke toetsstasie die toepaslike gelde vir 'n aansoek om 'n padwaardigheidsertifikaat soos in Bylae 1 beoog, betaal."

Wysiging van Regulasie 282 van die Regulasies

17. Regulasie 282 van die Regulasies word hiermee gewysig deur die vervanging van subregulasie (2) deur die volgende subregulasie:

(c) if the certificate of fitness or certificate of fitness disc has been destroyed, issue a duplicate certificate of fitness disc in respect of such vehicle in accordance with the provisions of these regulations." and

(b) the substitution for subregulation (4) of the following subregulation:

"(4) The first examination of a motor vehicle in accordance with a notice contemplated in regulation 280 shall be done free of charge, but for every subsequent examination the owner of such motor vehicle shall pay to the testing station concerned the appropriate fees for the application for a roadworthy certificate provided for in Schedule 1."

Amendment of Regulation 282 of the Regulations

"(2) No person shall operate on a public road a motorcycle, a motorcycle with side car, a motor tricycle or motor quadracycle, unless the head lamp of such vehicle is lighted at all times: Provided that the provisions of this subregulation shall not apply to a motor cycle, motor cycle with side car, motor tricycle or motor quadracycle manufactured before 31 December 1960 which is used during the period from sunrise to sunset."
