Opmerkings.—1. Die uitwerking van die wysiging is dat die invoer van alle goedere wat verbou, geproduseer of vervaardig is in die Republiek Malawi, vrygestel is van betaling van bobelasting, met terugwerkende krag tot 20 Junie 1990.

2. Die opmerking met betrekking tot goedere ingevoer vanaf Zimbabwe word duideliker gestel.

Notes: By the substitution for Note 7 (f) of the following:

“(f) grown, produced or manufactured—

(i) in the Republic of Malawi; or

(ii) in Zimbabwe and which are specified in the Trade Agreement between the Republic of South Africa and Southern Rhodesia,”

Notes.—1. The effect of the amendment is that the importation of all goods grown, produced or manufactured in the Republic of Malawi, is exempted from payment of surcharge, with retrospective effect to 20 June 1990.

2. The note in respect of goods imported from Zimbabwe is more clearly stated.
