Wysiging van regulasie 15 (2) van die Regulasies

2. Regulasie 15 (2) van die Regulasies word hierby
gewysig deur subregulasie (2) van regulasie 15 deur die
volgende subregulasie te vervang:

"(2) By aansoek om die heruitreiking van 'n
identiteitsdokument bedoel in subregulasie (1), is
'n bedrag van R3,00 deur die aansoeker betaal-
baar, behalwe indien 'n eerste of 'n verdere
bestuurderslisensie verkry is."

AMENDMENT OF REGULATIONS IN TERMS OF
THE IDENTIFICATION ACT, 1986 (ACT No. 72
OF 1986)

The Minister of Home Affairs has, in terms of sec-
tion 20 of the Identification Act, 1986 (Act No. 72 of
1986), made the regulations set out in the Schedule
hereto.

SCHEDULE

Definition

1. In this Schedule "the Regulations" shall mean the
regulations published by Government Notice No.
R. 1558 of 25 July 1986.

Amendment of regulation 15 (2) of the Regulations

2. Regulation 15 (2) of the Regulations is hereby
amended by the substitution for subregulation (2) of
regulation 15 of the following subregulation:

"(2) On application for the reissue of an identity
document referred to in subregulation (1), an
amount of R3,00 is payable by the applicant, ex-
cept if a first or a further driver's licence has been
obtained."

tion Act, 1963 (Act No. 81 of 1963), made the regula-
tions set out in the Schedule hereto.

1. In hierdie Bylae beteken "die Regulasies" die regulasies afgekondig by Goewermentskennisgewing No. R. 2206 van 24 Oktober 1986.

Wysiging van regulasie 26 van die Regulasies

2. Regulasie 26 van die Regulasies word hierby deur die volgende regulasie vervang:

"26. (1) Die uitreiking van sertifikate geskied ooreenkomstig die voorskrifte van die Direkteur-generaal en op die vorms ingevolge regulasie 2 (d) deur hom voorgeskryf.

(2) 'n Bedrag van R8,00 is by aansoek deur die applikant betaalbaar vir uitreiking van 'n volledige geboortesertifikaat, of 'n volledige huweliksertifikaat, of 'n volledige sterftesertifikaat, of 'n reproduksie van die betrokke register."

SCHEDULE**Definition**

1. In this Schedule "the Regulations" shall mean the regulations published by Government Notice No. R. 2206 of 24 October 1986.

Amendment of regulation 26 of the Regulations

2. The following regulation is hereby substituted for regulation 26 of the Regulations:

"26. (1) The issue of certificates shall be done in accordance with the directions of the Director-General and on the forms issued and prescribed by him in terms of regulation 2 (d).

(2) An amount of R8,00 is payable on application by the applicant for the issue of a full birth certificate, or a full marriage certificate, or a full death certificate, or a reproduction of the relevant register."
