(i) for the purposes of this paragraph, the expression "ordinary employee" shall mean the employee who performs the particular class of work in the employer's full-time employment and to whom the lowest wage for that class of work is being paid;

(ii) where the employer requires the casual employee—

(aa) to perform the work of a class of employee for whom a wage on a rising scale is prescribed, the expression "hourly wage" shall mean the hourly wage prescribed for a qualified employee of that class;

(ab) to work for a period of less than four hours a day, he shall be deemed to have worked for four hours."; and

(2) for the amounts "R2,50" and "50 cents" in subclause (5) substitute the amounts "R3,00" and "60 cents", respectively.

2. In clause 5, substitute the following for subclause (7) (a):

"(a) This clause shall not be applicable to an employee if and for so long as such an employee regularly receives an annual wage of not less than the remuneration for the area in which he is employed as specified in an existing exemption published in terms of section 34 (1) of the Basic Conditions of Employment Act, 1983 (Act 3 of 1983)".

"(4) Where the holder of a certificate of competency issued prior to the entry into force of these regulations has served for at least three years within the preceding seven years in a certificated capacity but is prohibited from employment in that capacity owing to the tonnage or power of the ship exceeding the applicable tonnage or power limitation, such certificate may be endorsed to the effect that it entitles the holder to act in the appropriate capacity on a ship having an appropriately greater tonnage or power."

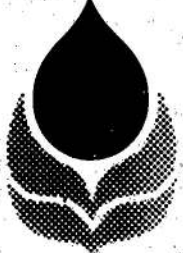
