#### LUCERNE SEED SCHEME.— AMENDMENT

It is hereby notified for general information that the Minister of Agriculture has under section 9 (1), as applied by section 15 (3), of the Marketing Act, 1968 (Act No. 59 of 1968), after consultation with the National Marketing Council, provisionally approved the proposed amendment set out in the Schedule hereto, to the Lucerne Seed Scheme published by Proclamation No. R. 30 of 1963, as amended.

The purpose of the proposed amendment is to switch the one channel marketing system for lucerne seed over to a minimum price system.

Persons having an interest in the lucerne seed industry are hereby in terms of section 9 (2) (b) of the said Act invited to lodge any objections to or representations concerning the said proposed amendment in writing to the Director-General, Department of Agriculture, Dirk Uys Building, Hamilton Street, Arcadia, Pretoria, 0083, or Private Bag X250, Pretoria, 0001, within four weeks from the date of publication of this notice.
