REGULATIONS UNDER THE ARMS AND AMMUNITION ACT, 1969 (ACT No. 75 OF 1969).—AMENDMENT OF GOVERNMENT NOTICE No. R. 1474 OF 1971

By virtue of section 43 (1) of the Arms and Ammunition Act, 1969 (Act No. 75 of 1969), I, Adriaan Johannes Vlok, Minister of Law and Order, hereby amend the regulations promulgated by Government Notice No. R. 1474 of 27 August 1971, as amended, in accordance with the accompanying Schedule, with effect from 5 October 1990.
