AMENDMENT OF THE REGULATIONS MADE  
UNDER THE REFERENDUMS ACT, 1983

The Minister of Home Affairs has, under the powers vested in him by section 4 of the Referendums Act, 1983 (Act 108 of 1983), made the regulations set out in the Schedule.

#### SCHEDULE

#### Definitions

1. In these regulations "the Regulations" shall mean the regulations published by Government Notice No. R. 742 of 29 February 1992, as amended by the regulations published by Government Notice No. R. 807 of 6 March 1992, and Government Notice No. R. 827 of 10 March 1992.

#### Amendment of regulation 12 of the Regulations

2. Regulation 12 of the Regulations is hereby amended by the substitution in subparagraph (ii) of paragraph (a) of subregulation (2) for the expression "11 and 12 March 1992" of the expression "11, 12 and 13 March 1992".
