WITHDRAWAL OF NOTICE UNDER THE PUBLIC SAFETY ACT, 1953

Under the powers vested in me by section 5A of the Public Safety Act, No. 3 of 1953, I, Hermanus Jacobus Kriel, Minister of Law and Order, hereby withdraw, with effect from 6 July 1993, the declaration of the areas mentioned in the Schedule, which areas was declared by Government Notice No. R. 64 of 8 January 1993 to be unrest areas and which declaration was extended on 7 April 1993 by Government Notice No. R. 624.

SCHEDULE

The Magisterial District of Estcourt/Winterton, including the area known as Wembezi, as demarcated and described in Government Notice No. 3564 of 24 October 1969.

The Magisterial District of Mooi River, including the area known as Bruntville, as demarcated and described in Government Notice No. 1209 of 16 August 1957.
