Woordomskrywing

AMENDMENT OF CONSOLIDATED
ROAD TRAFFIC REGULATIONS

By virtue of the powers vested in me by section 132 of the Road Traffic Act, 1989 (Act No. 29 of 1989), I have made the regulations set out in the Schedule hereto.

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the Road Traffic Regulations published by Government Notice No. R. 910 of 26 April 1990, as amended by Government Notice Nos. R. 1312 of 13 June 1990, R. 1954 of 17 August 1990, R. 2066 of 31 August 1990, R. 2982 of 14 December 1990, R. 125 of 14 February 1991, R. 1059 of 4 June 1991, R. 2694 of 15 November 1991, R. 1695 of 15 June 1992, R. 2803 of 1 October 1992, R. 2895 of 8 October 1992, R. 3172 of 20 November 1992, R. 766 of 30 April 1993 and R. 1214 of 1 July 1993.

Vervanging van regulasie 185 van die Regulasies

2. Regulasie 185 van die Regulasies word deur die volgende regulasie vervang:

"Bykomende vereiste vir registrasie van 'n motorvoertuig verkry as gevolg van herinbesitname deur titelhouer

185. 'n Aansoek om die registrasie van 'n motorvoertuig bedoel in regulasie 179(d), gaan bykomend tot die vereistes en dokumente bedoel in regulasie 181, vergesel van 'n gesertifiseerde afskrif van -

- (a) die hofbevel; of
- (b) die vrywillige-oorgawe-dokumentasie: Met dien verstande dat 'n beëdigde verklaring gemaak deur die titelhouer van daardie motorvoertuig wat die omstandighede waaronder die voertuig herinbesit geneem is verduidelik, voorgelê kan word in die geval waar die vrywillige-oorgawe-dokumentasie nie verkry kan word nie,

as bewys van die titelhouer se reg om sodanige motorvoertuig herinbesit te neem."

Kort titel en inwerkingtreding

3. Hierdie regulasies is die dertiende wysiging van die Padverkeersregulasies gepubliseer by Goewernmentskennisgewing No. R 910 van 26 April 1990 en tree in werking op die datum van publikasie van hierdie regulasies.

Substitution of regulation 185 of the Regulations

2. Regulation 185 of the Regulations is substituted by the following regulation:

"Additional requirement for registration of motor vehicle acquired as a result of repossession by title holder

185. An application for the registration of a motor vehicle referred to in regulation 179(d) shall, in addition to the requirements and documents referred to in regulation 181, be accompanied by a certified copy of -

- (a) the court order; or
- (b) the voluntary surrender documentation: Provided that an affidavit made by the title holder of that motor vehicle explaining the circumstances under which the vehicle was repossessed may be submitted in the case where the voluntary surrender documentation cannot be obtained,

as proof of the right of the title holder to repossess such motor vehicle."

Short title and commencement

3. These regulations are the thirteenth amendment of the Road Traffic Regulations, published by Government Notice No. R 910 of 26 April 1990 and shall come into operation on the date of publication of these regulations.
