PROCLAMATION

APPLICATION OF THE UPGRADING OF LAND TENURE RIGHTS ACT, 1991, AND THE LESS FORMAL TOWNSHIP ESTABLISHMENT ACT, 1991, IN KANGWANE

Under the powers vested in me by—

- (a) section 25 (1) of the Upgrading of Land Tenure Rights Act, 1991 (Act No. 112 of 1991); and
- (b) section 28 (1) of the Less Formal Township Establishment Act, 1991 (Act No. 113 of 1991),

I hereby declare the said Acts to be applicable with effect from 1 January 1994 in the area in respect of which the KaNgwane Legislative Assembly was declared a self-governing territory by Proclamation No. R. 148 of 1984.
