WITHDRAWAL OF NOTICE UNDER THE PUBLIC SAFETY ACT, 1953

Under the powers vested in me by section 5A of the Public Safety Act, No. 3 of 1953, I, Hermanus Jacobus Kriel, Minister of Law and Order, hereby withdraw, with effect from 14 March 1994, the declaration of the areas mentioned in the Schedule, which areas were declared by Government Notice No. R. 526 of 11 March 1994 to be unrest areas.
