WYSIGING VAN REGULASIES

BYLAE

Woordomskrywing

1. In hierdie regulasies beteken "die Regulasies" die regulasies afgekondig by Goewermentskennisgewing No. R. 361 van 11 Maart 1994.

Wysiging van regulasie 23 van die Regulasies

2. Regulasie 23 van die Regulasies word hierby gewysig—

- (a) deur in paragraaf (g) van subregulasie (1) die uitdrukking "R894" deur die uitdrukking "R895" te vervang;
- (b) deur in subparagraaf (iii) van paragraaf (h) van subregulasie (1) die uitdrukking "R46 812" deur die uitdrukking "R48 420" te vervang; en
- (c) deur in subparagraaf (iv) van paragraaf (h) van subregulasie (1) die uitdrukking "R108 075" deur die uitdrukking "R126 411" te vervang.

Wysiging van regulasie 49 van die Regulasies

3. Regulasie 49 van die Regulasies word hierby gewysig deur in paragraaf (a) van subregulasie (1) die uitdrukkings "R86,00", "R3,60" en "R26,50" deur onderskeidelik die uitdrukkings "R94,50", "R3,93" en "R29,00" te vervang.

AMENDMENT OF REGULATIONS

The Minister of Justice has, under section 16 of the Magistrates Act, 1993 (Act No. 90 of 1993), made the regulations in the Schedule.

SCHEDULE

Definitions

1. In these regulations "the Regulations" means the regulations published by Government Notice No. R. 361 of 11 March 1994.

Amendment of regulation 23 of the Regulations

2. Regulation 23 of the Regulations is hereby amended—

- (a) by the substitution in paragraph (g) of subregulation (1) for the expression "R894" of the expression "R895";
- (b) by the substitution in subparagraph (iii) of paragraph (h) of subregulation (1) for the expression "R46 812" of the expression "R48 420"; and
- (c) by the substitution in subparagraph (iv) of paragraph (h) of subregulation (1) for the expression "R108 075" of the expression "R126 411".

Amendment of regulation 49 of the Regulations

3. Regulation 49 of the Regulations is hereby amended by the substitution in paragraph (a) of subregulation (1) for the expressions "R86,00", "R3,60" and "R26,50" of the expressions "R94,50", "R3,93" and "R29,00", respectively.
