KOMMISSIE VAN ONDERSOEK NA VEILIGHEID EN GESONDHEID IN DIE MYNBEDRYF

1. Hierby word vir algemene inligting bekendgemaak dat dit die Staatspresident behaag het om sy Edele Regter Ramon Nigel Leon as Voorsitter en Professore Miklos Deszo Gyorgy Salamon, Albert William Davies en John Carol Anthony Davies as lede van 'n Kommissie van Onderzoek na Veiligheid en Gesondheid in die Mynbedryf aan te stel.
2. Die Kommissie se opdrag is soos volg:
 - (i) Om alle aspekte van die regsbepalings in verband met veiligheid en gesondheid in die mynbedryf soos omskryf in die Mineralewet, 1991 (Wet No. 50 van 1991), te ondersoek.
 - (ii) Om in die lig van heersende omstandighede in die bedryf en internasionale standaarde aanbevelings oor verbeterings aan die bestaande wette en die implementering daarvan aan die Staatspresident te doen.
3. 'n Persoon wat getuienis aan die Kommissie wil voorlê by wyse van memorandum of mondeling, word hiermee uitgenooi om voor 15 Junie 1994 aan Die Sekretaris, Kommissie van Onderzoek na Veiligheid en Gesondheid in die Mynbedryf, Privaatsak X59, Pretoria, 0001, te skryf.

It is hereby notified for general information that the State President has been pleased to appoint the Honourable Mr Justice Ramon Nigel Leon as Chairman and Professors Miklos Deszo Gyorgy Salamon, Albert William Davies and John Carol Anthony Davies as members of a Commission of Enquiry into Safety and Health in the Mining Industry.
2. The Commission's terms of reference are as follows:
 - (i) To investigate all aspects of the legal regulation of health and safety in the mining industry as defined in the Minerals Act, 1991 (Act No. 50 of 1991).
 - (ii) To make recommendations to the State President on improvements to the existing regulations and the implementation thereof in the light of circumstances prevailing in the industry and international standards.
