WYSIGING VAN REGULASIES OP WAPENS EN
AMMUNISIE, 1994

Die Adjunkminister van Wet en Orde, handelende namens en in opdrag van die Minister van Wet en Orde, het, kragtens artikel 43 van die Wet op Wapens en Ammunition, 1969 (Wet No. 75 van 1969), die regulasies in die Bylae uitgevaardig.

BYLAE

Woordbepaling

1. In hierdie Bylae beteken "die Regulasies" die Regulasies op Wapens en Ammunition gepubliseer by Goewermentskennisgewing No. R. 787 van 22 April 1994.

Wysiging van regulasie 8 van die Regulasies

2. Regulasie 8 van die Regulasies word hereby gewysig deur in subparagraph (i) (ee) van paragraaf (d) van subregulasie (2) die syfer "10", deur die woord "agt" te vervang.

Wysiging van regulasie 27 van die Regulasies

3. Regulasie 27 van die Regulasies word hereby gewysig deur die regulasie deur die volgende regulasie te vervang:

"Aansoek om verklaring tot bona fide-jagter en bona fide-sportman

27. Die bepalings van regulasies 20, 21, 22, 23 en 24 is, met die uitsondering van subregulasie (2) (e) van regulasie 20, welke subregulasie nie op jagters van toepassing is nie, *mutatis mutandis* van toepassing ten opsigte van jagters en sportmanne."

ARMS AND AMMUNITION ACT, 1969
(ACT No. 75 OF 1969)

AMENDMENT OF ARMS AND AMMUNITION
REGULATIONS, 1994

The Deputy Minister of Law and Order, acting on behalf of and on assignment by the Minister of Law and Order, has, under section 43 of the Arms and Ammunition Act, 1969 (Act No. 75 of 1969), made the regulations in the Schedule.

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the Arms and Ammunition Regulations published by Government Notice No. R. 787 of 22 April 1994.

Amendment of regulation 8 of the Regulations

2. Regulation 8 of the Regulations is hereby amended by the substitution in subparagraph (i) (ee) of paragraph (d) of subregulation (2) for the word "ten", of the word "eight".

Amendment of regulation 27 of the Regulations

3. Regulation 27 of the Regulations is hereby amended by the substitution for the regulation of the following regulation:

"Application for declaration as bona fide hunter and bona fide sportsman

27. The provisions of regulations 20, 21, 22, 23 and 24 shall, with the exception of subregulation (2) (e) of regulation 20, which subregulation shall not apply to hunters, apply *mutatis mutandis* in respect of hunters and sportsmen."

Wysiging van regulasie 28 van die Regulasies

4. Regulasie 28 van die Regulasies word hierby gewysig—

- (a) deur paragraaf (d) van subregulasie (2) te skrap; en
- (b) deur in paragraaf (e) van subregulasie (2) die woorde "ten minste" na die uitdrukking "moet voorsien wees van" in te voeg.

Wysiging van regulasie 29 van die Regulasies

5. Regulasie 29 van die Regulasies word hierby gewysig deur in paragraaf (f) van die regulasie die woorde "tien", waar dit voorkom, deur die woorde "agt" te vervang.

Wysiging van regulasie 30 van die Regulasies

6. Regulasie 30 van die Regulasies word hierby gewysig—

- (a) deur paragraaf (d) van regulasie 30 te skrap; en
- (b) deur die woorde "en" aan die einde van paragraaf (e) te skrap en deur die volgende paragraaf van paragraaf (f) van die regulasie by te voeg:
 - "(g) waar dit in 'n voertuig van die betrokke applikant geïnstalleer is, ook voldoen aan die bepalings van subregulasie 3 (b) van regulasie 28."

Inwerkingtreding

7. Regulasie 4, 5 en 6 tree in werking op 1 Julie 1994.

Amendment of regulation 28 of the Regulations

4. Regulation 28 of the Regulations is hereby amended—

- (a) by the deletion of paragraph (d) of subregulation (2); and
- (b) by the insertion in paragraph (e) of subregulation (2) of the words "at least" after the expression "shall be equipped with".

Amendment of regulation 29 of the Regulations

5. Regulation 29 of the Regulations is hereby amended by the substitution in paragraph (f) of the regulation for the word "ten", of the word "eight".

Amendment of regulation 30 of the Regulations

6. Regulation 30 of the Regulations is hereby amended—

- (a) by the deletion of paragraph (d) of regulation 30; and
 - (b) by the deletion of the word "and" at the end of paragraph (e) and by the addition after paragraph (f) of the regulation of the following paragraph:
- "(g) where it is installed in a vehicle of the applicant concerned, also comply with the provisions of subregulation (3) (b) of regulation 28."

Coming into operation

7. Regulations 4, 5 and 6 shall come into operation on 1 July 1994.
