#### WYSIGING VAN REGULASIES

Die Adjunkminister van Finansies, handelende namens en in opdrag van die Minister van Finansies, het kragtens artikel 37 van die Wet op Beheer van Finansiële Markte, 1989 (Wet No. 55 van 1989), die regulasies in die Bylae uitgevaardig.

#### BYLAE

#### Omskrywing

1. In hierdie Bylae beteken "die Regulasies" die regulasies gepubliseer by Goewermentskennisgewing No. R. 1885 van 10 Augustus 1990, soos gewysig deur Goewermentskennisgewing No. R. 1652 van 3 September 1993 en Goewermentskennisgewing No. R. 2451 van 24 Desember 1993.

#### Vervanging van regulasie 10

2. Regulasie 10 van die Regulasies word hierby deur die volgende regulasie vervang:

#### "Publikasie van Reëls"

10. (1) Die reëls van 'n beurs, met inbegrip van enige toevoeging daarby of wysiging daarvan en enige reël beoog in artikel 17 (4) van die Wet, word binne 10 dae na die skriftelike goedkeuring daarvan deur die Registrateur kragtens artikel 17 (3) van die Wet of die finale opstelling en ondertekening daarvan deur die Registrateur kragtens en ooreenkomsdig artikel 17 (4) van die Wet, na gelang van die geval, gepubliseer deur die verskaffing van 'n kopie daarvan op gesag van die uitvoerende komitee van die beurs aan alle lede van die beurs.

FINANCIAL MARKETS CONTROL ACT, 1989

#### AMENDMENT OF REGULATIONS

The Deputy Minister of Finance, acting on behalf of and on assignment by the Minister of Finance, has under section 37 of the Financial Markets Control Act, 1989 (Act No. 55 of 1989), made the regulations set out in the Schedule.

## SCHEDULE

#### Definition

1. In this Schedule "the Regulations" means the regulations published by Government Notice No. R. 1885 of 10 August 1990, as amended by Government Notice No. R. 1652 of 3 September 1993 and Government Notice No. R. 2451 of 24 December 1993.

#### Substitution of regulation 10

2. The following regulation is hereby substituted for regulation 10 of the Regulations:

#### "Publication of rules"

10. (1) The rules of an exchange, including any addition thereto or amendments thereof and any rule contemplated in section 17 (4), shall be published within 10 days of the written approval thereof by the Registrar under section 17 (3) of the Act, or the final drafting and signing thereof by the Registrar under and in accordance with the provisions of section 17 (4) of the Act, as the case may be, by the furnishing of copies thereof under authority of the executive committee of the exchange to all members of the exchange.

(2) (a) Kopieë van sodanige reëls moet op gesag van so 'n uitvoerende komitee of die Registrateur voorsien word aan elke ander lid van die publiek wat daarom aansoek doen by die amptelike kantoor van die betrokke beurs of die Registrateur, na gelang van die geval.

(b) Met ingang van die datum van inwerkingtreding van hierdie regulasie is die adresse van die amptelike kantore bedoel in paragraaf (a), die volgende:

- (i) SAFEX, Sentraalstraat 105, Houghton Estate, 2198; Posbus 4406, Johannesburg, 2000;
- (ii) Die Registrateur van Finansiële Markte, p.a. die Raad op Finansiële Dienste, Rigelpark, Rigelalaan-Suid 446, Erasmusrand, 0181; Privaatsak X238, Pretoria, 0001.”.

(2) (a) Copies of any such rules shall under authority of such executive committee or of the Registrar be furnished to any other member of the public who applies for a copy at the official office of the exchange concerned or the Registrar, as the case may be.

(b) The addresses of the official offices referred to in paragraph (a) shall as from the date of coming into operation of this regulation be as follows:

- (i) SAFEX, 105 Central Street, Houghton Estate, 2198; P.O. Box 4406, Johannesburg, 2000;
- (ii) The Registrar of Financial Markets, c/o the Financial Services Board, Rigelpark, 446 Rigel Avenue South, Erasmusrand, 0181; Private Bag X238, Pretoria, 0001.”.
