TYDELIKE OPDRAG VAN DIE ADMINISTRASIE VAN SEKERE WETTE AAN 'N TOEPASLIKE GESAG BINNE DIE REGSBEVOEGDHEID VAN DIE NASIONALE REGERING INGEVOLGE ARTIKEL 235 (9) VAN DIE GRONDWET VAN DIE REPUBLIEK VAN SUID-AFRIKA, 1993

Kragtens artikel 235 (9) van die Grondwet van die Republiek van Suid-Afrika, 1993 (Wet No. 200 van 1993), dra ek hierby in die algemeen die administrasie van al die wette bedoel in artikel 235 (6) (b) van die Grondwet met betrekking tot alle aangeleenthede wat val binne 'n funksionele terrein vermeld in die eerste kolom van die Bylae, op aan die toepaslike gesag daarteenoor in die tweede kolom vermeld.

Die opdrag van die administrasie van 'n wet ingevolge hierdie Proklamasie bly met betrekking tot 'n provinsie van krag totdat die administrasie van so 'n wet of gedeeltes van so 'n wet kragtens artikel 235 (8) van die Grondwet opgedra word aan 'n bevoegde gesag binne die regsbevoegdheid van die regering van daardie provinsie.

TEMPORARY ASSIGNMENT OF THE ADMINISTRATION OF CERTAIN LAWS TO APPROPRIATE AUTHORITIES WITHIN THE JURISDICTION OF THE NATIONAL GOVERNMENT IN TERMS OF SECTION 235 (9) OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1993

Under section 235 (9) of the Constitution of the Republic of South Africa, 1993 (Act No. 200 of 1993), I hereby assign generally the administration of all the laws referred to in section 235 (6) (b) of the Constitution with regard to all matters falling within a functional area mentioned in the first column of the Schedule, to the appropriate authority mentioned opposite thereto in the second column.

The assignment of a law in terms of this Proclamation shall in respect of a province remain in force until the administration of such law or part of such law is assigned under section 235 (8) of the Constitution to a competent authority within the jurisdiction of the government of that province.
