Die Minister van Vervoer het kragtens artikel 132 van die Padverkeerswet, 1989 (Wet No. 29 van 1989), die regulasies in die Bylae hiervan uitgevaardig.

Woordomskrywing

AMENDMENT OF THE
ROAD TRAFFIC REGULATIONS

The Minister of Transport has under section 132 of the Road Traffic Act, 1989 (Act No. 29 of 1989), made the regulations contained in the Schedule hereto.

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the Road Traffic Regulations published by Government Notice No. R. 910 of 26 April 1990, as amended by Government Notices Nos. R. 1312 of 13 June 1990, R. 1954 of 17 August 1990, R. 2066 of 31 August 1990, R. 2982 of 14 December 1990, R. 125 of 14 February 1991, R. 1059 of 4 June 1991, R. 2694 of 15 November 1991, R. 1695 of 15 June 1992, R. 2803 of 1 October 1992, R. 2895 of 8 October 1992, R. 3172 of 20 November 1992, R. 766 of 30 April 1993, R. 1214 of 1 July 1993, R. 1767 of 20 September 1993, R. 1878 of 18 October 1993, R. 2448 of 24 December 1993, R. 792 of 29 April 1994 and R. 1048 of 3 June 1994.

Wysiging van regulasie 409 van die Regulasies

2. Regulasie 409 van die Regulasies word hierby gewysig—

- (a) deur paragraaf (a) in subregulasie (6) deur die volgende paragraaf te vervang:

“(a) vir rooi, oranje, geel, groen, blou, pers, wit en bruin truikaatsende materiaal en vir rooi, oranje, geel, groen, blou, pers, wit, grys, swart en bruin verf, die truikaatskoëffisient, die kleur, luminansiefaktor en spieëlglaans, na gelang van die geval, voor verwerking, van die Standaardspesifikasie vir Padtekens: SABS 1519-1990 en die woorde “truikaatskoëffisient”, “kleur”, “luminansiefaktor”, “spieëlglaans” en “verwerking”, dra dieselfde betekenis as wat in daardie spesifikasie daaraan geheg word;” en

- (b) deur die volgende subregulasie na subregulasie (11) in te voeg:

“(12) Truikaatsende materiaal in subregulasie 6 (a) bedoel, moet ’n permanente merk dra wat die klas en die vervaardiger van sodanige materiaal aandui.”.

3. Hierdie regulasies is die agtiende wysiging van die Padverkeersregulasies gepubliseer by Goewermentskennisgewing No. R. 910 van 26 April 1990 en tree in werking op **8 Junie 1994**.

Amendment of regulation 409 of the Regulations

2. Regulation 409 of the Regulations is hereby amended—

- (a) by the substitution in subregulation (6) for paragraph (a) of the following paragraph:

“(a) for red, orange, yellow, green, blue, purple, white and brown retro-reflective material and for red, orange, yellow, green, blue, purple, white, grey, black and brown paint, the coefficient of retro-reflection, the colour, luminance factor and specular gloss, as the case may be, prior to weathering, of the Standard Specification for Road Signs: SABS 1519-1990 and the words “coefficient of retro-reflection”, “colour”, “luminance factor”, “specular gloss” and “weathering”, shall bear the same meaning as assigned thereto by such specification;” and

- (b) by the insertion after subregulation (11) of the following subregulation:

“(12) Retro-reflective material referred to in subregulation 6 (a) shall bear a permanent mark to identify the class and the manufacturer of such material.”.

3. These regulations are the eighteenth amendment of the Road Traffic Regulations published by Government Notice No. R. 910 of 26 April 1990 and shall come into operation on **8 June 1994**.
