AGRICULTURAL PESTS ACT, 1983
(ACT No. 36 OF 1983)

CONTROL MEASURES: AMENDMENT*

I, André Isak van Niekerk, Minister of Agriculture, acting under section 6 of the Agricultural Pests Act, 1983 (Act No. 36 of 1983) —

- hereby prescribe the control measures set out in the Schedule; and
- determine that these control measures shall come into operation on 10 August 1994.

* To make provision that the Sugar-cane variety N25 be released to be kept, planted or cultivated without the authorisation of a permit.

SCHEDULE

Definitions

- In this Schedule "the Control Measures" means the control measures published by Government Notice No. R. 110 of 27 January 1984, as amended by Government Notices Nos. R. 909 of 4 May 1984, R. 1770 of 17 August 1984, R. 845 of 12 April 1985, R. 1518 of 12 July 1985, R. 1442 of 11 July 1986, R. 87 of 22 January 1988, R. 1349 of 8 July 1988, R. 1954 of 30 September 1988, R. 2416 of 19 October 1990, R. 18 of 4 January 1991, R. 2840 of 29 November 1991, R. 2269 of 14 August 1992, R. 2876 of 16 October 1992, R. 1560 of 20 August 1993 and R. 451 of 11 March 1994.

Vervanging van subparagraph (2) van paragraaf 3 van die Beheermaatreëls

3. Subparagraaf (2) van paragraaf 3 van die Beheermaatreëls word hiermee deur die volgende subparagraph vervang:

"3. (2) Geen grondgebruiker mag sonder die magtiging van 'n permit, bedoel in artikel 6 (3) (b) van die Wet, enige suikerrietplant (*Saccharum officinarum*) in die Republiek van Suid-Afrika hou, plant of kweek nie, uitgesonderd die variëteite aangedui in Tabel 4.".

Vervanging van Tabel 4 van die Beheermaatreëls

4. Tabel 4 van die Beheermaatreëls word hiermee deur die volgende Tabel vervang:

Substitution of subparagraph (2) of paragraph 3 of the Control Measures

3. The following subparagraph is hereby substituted for subparagraph (2) of paragraph 3 of the Control Measures:

"3. (2) No user of land shall keep, plant or cultivate any sugar-cane plant (*Saccharum officinarum*) in the Republic of South Africa without the authorisation of the permit referred to in paragraph 6 (3) (b) of the Act, excluding the varieties indicated in Table 4.".

Substitution of Table 4 of the Control Measures

4. The following Table is hereby substituted for Table 4 of the Control Measures:

Variëteite Suikerriet (*Saccharum officinarum*) vrygestel van 'n permit vir die hou, plant of kweek daarvan in die Republiek van Suid-Afrika/Varieties Sugar-cane (*Saccharum officinarum*) exempted from a permit for the keeping, planting or cultivation thereof in the Republic of South Africa.
