COMMITTEE OF PRINCIPALS: REQUIREMENTS AND CONDITIONS FOR MATRICULATION ENDORSEMENT AND THE ISSUING OF CERTIFICATES OF EXEMPTION

The Committee of Principals has, with the approval of the Minister of Education, in terms of section 7 (1) (d) and (e) and (3) of the Universities Act, 1955 (Act No. 61 of 1955), prescribed the standards and conditions for the endorsement of senior certificates and the issuing of certificates of exemption from the matriculation endorsement as set out in the Schedule.

KOMITEE VAN HOOFDE: VEREISTES EN VOORWAARDES VIR Matrikulasie-ENDOSSEMENT EN DIE UITREIKING VAN VRYSTELLINGSERTIFI-KATE

Die Komitee van Hoofde het, met die goedkeuring van die Minister van Onderwys, ingevolge die bepalings van artikel 7 (1) (d) en (e) en (3) van die Wet op Universiteite, 1955 (Wet No. 61 van 1955), die vereistes en voorwaardes vir die endossering van senior sertifikate en die uitreiking van sertifikate vir vrystelling van die matrikulasie-endossement voorgeskryf soos in die Bylae uiteengesit.

## SCHEDULE

### DEFINITIONS

1. In this Schedule, any word or expression to which a meaning has been assigned by the Act, bears that meaning and unless the context otherwise indicates—

**"Advanced Level equivalence"** means a language subject passed in a foreign examination evaluated by the Committee of Principals to be equivalent to an Advanced Level first language subject;

**"Advanced Level subject"** means a subject passed at a specific level as prescribed for the examinations of the examining bodies mentioned in Annexure I;

**"certificate of conditional exemption"** means a certificate issued by the Committee of Principals in terms of the provisions of section 7 (1) (e) and (3) of the Act, admitting a candidate for a limited period to bachelor's degree study at a South African university, subject to specified conditions;

**"Council"** means the council as defined in section 1 of the South African Certification Council Act, 1986 (Act No. 85 of 1986);

**"endorse"** means the effecting of an endorsement by the Council that a senior certificate candidate has satisfied the requirements for matriculation endorsement in terms of the provisions of section 7 (1) (d) of the Act;

**"exile"** means a South African citizen who was not schooled in the Republic of South Africa as a result of his or her residence or the residence of his or her parent or parents in a foreign country and who can submit evidence to that effect issued by the United Nations High Commissioner for Refugees (UNHCR), which evidence is acceptable to the Committee of Principals;

**"full-time candidate"** means a candidate attending a school, that has been approved by an education department, on a full-time basis;

**"HIGCSE level subject"** means a subject offered for and passed with a symbol of 1, 2 or 3 in the Higher International General Certificate of Secondary Education examination conducted by the University of Cambridge Local Examinations Syndicate;

**"Higher Grade subject"** means a subject offered and passed on the Higher Grade in a senior certificate examination recognised by the Council;

**"IGCSE level subject"** means a subject offered for and passed with a symbol of A, B or C in the International General Certificate of Secondary Education examination conducted by the University of Cambridge Local Examinations Syndicate;

**"immigrant"** means—

- (a) a foreigner who has immigrated to the Republic of South Africa;
- (b) any South African citizen or the child of a South African citizen who, in the opinion of the Committee of Principals, was unable to continue his or her studies in either English or Afrikaans on account of his or her residence or the residence of his or her parent or parents in a foreign country; or
- (c) any foreigner's child who is studying in the Republic of South Africa;

**"instructional offering"** means a course or a number of courses passed at a university in accordance with the provisions of the Act and the prescriptions for university subsidy formulae';

**"M Level subject"** means a subject offered for and passed at a specific level prescribed for the examinations of the Associated Examining Board mentioned in Annexure I;

**BYLAE****WOORDOMSKRYWING**

1. In hierdie Bylae het 'n woord of uitdrukking waaraan daar in die Wet 'n betekenis geheg is, daardie betekenis en, tensy uit die samehang anders blyk, beteken—

**"Advanced Level-ekwivalensie"** dat 'n taalvak waarin in 'n vreemde eksamen geslaag is, deur die Komitee van Hoofde geeevalueer is as ekwivalent aan 'n Advanced Level-eerste-taalvak;

**"Advanced Level-vak"** 'n vak waarin geslaag is op 'n bepaalde vlak soos voorgeskryf vir die eksamens van die eksamineringsinstansies vermeld in Aanhanga I;

**"deeltydse kandidaat"** 'n kandidaat wat weens omstandighede buite sy of haar beheer nie in staat is om 'n skool wat deur 'n onderwysdepartement erken word heetlyds by te woon nie;

**"die Wet"** die Wet op Universiteite, 1955 (Wet No. 61 van 1955), soos gewysig;

**"een volle krediet van onderrigaanbiedinge"** 'n kombinasie van onderrigaanbiedinge waaraan 'n gematrikuleerde kandidaat moet voldoen vir 'n voltooide eerste jaar soos voorgeskryf vir die graad waarvoor hy of sy geregistreer is;

**"endosseer"** die aanbring van 'n endossement deur die Raad dat 'n seniorcertifikaatkandidaat voldoen het aan die matrikulasie-endosseringsvereistes ingevolge artikel 7 (1) (d) van die Wet;

**"erkende eksamen"** 'n seniorcertifikaateksamen deur die Raad erken, of 'n ander eksamen deur die Komitee van Hoofde erken, vir toelating tot baccalaureusgraadstudie aan 'n Suid-Afrikaanse universiteit op grond van voltooide kwalifikasies of vakke waarin geslaag is op 'n standaard wat vir die Komitee van Hoofde aanvaarbaar is;

**"heetydse kandidaat"** 'n kandidaat wat 'n skool, goedgekeur deur 'n onderwysdepartement, heetlyds bywoon;

**"HIGCSE-vlak vak"** 'n vak aangebied vir en waarin geslaag met 'n 1-, 2- of 3-simbool in die Higher International General Certificate of Secondary Education-eksamen van die University of Cambridge Local Examinations Syndicate;

**"Hoër Graadvak"** 'n vak aangebied vir en waarin geslaag op die Hoër Graad in 'n senior certifikaateksamen wat deur die Raad erken word;

**"IGCSE-vlak vak"** 'n vak aangebied vir en waarin geslaag met 'n A-, B- of C-simbool in die International General Certificate of Secondary Education-eksamen van die University of Cambridge Local Examinations Syndicate;

**"immigrant"—**

- (a) 'n buitelaander wat na die Republiek van Suid-Afrika geïmmigreer het;
- (b) 'n Suid-Afrikaanse burger of die kind van 'n Suid-Afrikaanse burger wat volgens die sienswyse van die Komitee van Hoofde nie in staat was om sy of haar studie in óf Engels óf Afrikaans voort te sit nie as gevolg van sy of haar verblyf of die verblyf van sy of haar ouer of ouers in die buiteland; of
- (c) 'n buitelaander se kind wat in die Republiek van Suid-Afrika studeer;

**"M Level-vak"** 'n vak aangebied vir en waarin geslaag op 'n bepaalde vlak voorgeskryf vir die eksamen van die Associated Examining Board vermeld in Aanhanga I;

**"matrikulasie-eksamen"** die matrikulasie-eksamen van die universiteite afgeneem deur die Matrikulasierraad voor 4 September 1992;

**"matriculation examination"** means the matriculation examination of the universities conducted by the Matriculation Board prior to 4 September 1992;

**"matriculation exemption"** means exemption from the matriculation examination conducted by the Matriculation Board prior to 4 September 1992;

**"N5 standard"** means the standard achieved in a technical subject at the National Certificate: N5 level passed at a South African technical college;

**"one full credit of instructional offerings"** means a set of instructional offerings which must be met by a matriculated candidate for a completed first year as prescribed for the degree for which he or she is registered;

**"Ordinary Level subject"** means any subject offered for and passed with a symbol of A, B or C at the Ordinary Level, the General Certificate of Secondary Education (GCSE) level or the International General Certificate of Secondary Education (IGCSE) level prescribed for the examinations conducted by the examining bodies mentioned in Annexure I;

**"part-time candidate"** means a candidate who owing the circumstances beyond his or her control is not in a position to attend a school approved by an education department on a full-time basis;

**"pass in a subject"** means obtaining a standard of at least 33½ per cent of the maximum marks in Afrikaans Second Language Higher Grade, English Second Language Higher Grade and all subjects on the Standard Grade and at least 40 per cent of the maximum marks in all other subjects on the Higher Grade: Provided that the candidate has not been found guilty of any irregularity in the conducting of the relevant examination and that he or she did not gain any unlawful advantage before, on or after the date on and time at which the examination concerned was conducted:

**"Principal Level subject"** means a subject offered for and passed in the Higher School Certificate examination previously conducted by the University of Cambridge Local Examinations Syndicate;

**"recognised examinations"** means a senior certificate examination recognised by the Council, or another examination recognised by the Committee of Principals, for the purposes of admission to bachelor's degree study at a South African university by virtue of completed qualifications or subjects passed at a standard acceptable to the Committee of Principals;

**"senior certificate"** means a school-leaving certificate with pass marks in at least five Higher Grade or five Standard Grade subjects or a combination of five Higher Grade and Standard Grade subjects, approved by the Committee of Principals and issued by the Council, or an equivalent certificate issued prior to the commencement of section 9 of the South African Certification Council Act, 1986 (Act No. 85 of 1986): Provided that Functional Mathematics Standard Grade and Functional Physical Science Standard Grade are not recognised as approved subjects;

**"Standard Grade subject"** means a subject offered and passed on the Standard Grade, with the exception of Functional Mathematics Standard Grade and Functional Physical Science Standard Grade, in a senior certificate examination recognised by the Council;

**"subject"** means a senior certificate instructional offering at a level acceptable to the Committee of Principals;

**"subminimum in a subject"** means the standard of at least 20 per cent in the sixth subject on the Higher Grade or Standard Grade obtained by a candidate who has passed only five subjects for a senior certificate;

**"Subsidiary level subject"** means a subject offered for and passed at a specific level prescribed for the examinations of the examining bodies mentioned in Annexure I;

**"matrikulasievrystelling"** vrystelling van die matrikulasie-eksamen afgeneem deur die Matrikulasieraad voor 4 September 1992;

**"N5-peil"** die standaard behaal in 'n tegniese vak voorgeskryf vir 'n Nasionale Sertifikaat: N5 waarin aan 'n Suid-Afrikaanse tegniese kollege geslaag is;

**"onderrigaanbieding"** 'n kursus of aantal kursusse waarin geslaag by 'n universiteit ooreenkomsdig die bepalings van die Wet en voorskrifte vir die subsidieformules vir universiteite;

**"Ordinary Level-vak"** 'n vak aangebied vir en waarin geslaag met 'n A-, B- of C-simbool op die Ordinary Level-vlak, General Certificate of Secondary Education (GCSE)-vlak of International General Certificate of Secondary Education (IGCSE)-vlak, soos voorgeskryf vir die eksamens afgeneem deur die eksamineringsinstansies vermeld in Aanhanga I;

**"Principal Level-vak"** 'n vak aangebied vir en waarin geslaag in die Higher School Certificate-eksamen wat voorheen deur die University of Cambridge Local Examinations Syndicate afgeneem is;

**"Raad"** die raad soos omskryf in artikel 1 van die Wet op die Suid-Afrikaanse Sertifiseringsraad, 1986 (Wet No. 85 van 1986);

**"senior sertifikaat"** 'n skooleindsertifikaat met slaagpunte in minstens vyf Hoër Graad- of vyf Standaardgraadvakke of 'n kombinasie van vyf Hoër Graad- en Standaardgraadvakke, soos goedgekeur deur die Komitee van Hoofde en uitgereik deur die Raad, of 'n gelykwaardige sertifikaat uitgereik voor die inwerkingtreding van artikel 9 van die Wet op die Suid-Afrikaanse Sertifiseringsraad, 1986 (Wet No. 85 van 1986): Met dien verstande dat Funksionele Natuur en Skeikunde Standaardgraad en Funksionele Wiskunde Standaardgraad nie as goedgekeurde vakke erken word nie;

**"slaag in 'n vak"** die standaard van minstens  $33\frac{1}{3}$  persent van die maksimum punte behaal in Afrikaans Tweede Taal Hoër Graad, Engels Tweede Taal Hoër Graad en alle vakke op Standaardgraad en minstens 40 persent van die maksimum punte behaal in alle ander vakke op die Hoër Graad: Met dien verstande dat die kandidaat hom of haar nie by die afneem van die betrokke eksamen skuldig gemaak het aan enige onreëlmataigheid nie en dat die kandidaat geen onregmatige voordeel bekom het voor, op of na die datum en tyd waarop die betrokke eksamen afgeneem is nie;

**"Standaardgraadvak"** 'n vak aangebied vir en waarin geslaag op die Standaardgraad, uitgesonderd Funksionele Natuur- en Skeikunde Standaardgraad en Funksionele Wiskunde Standaardgraad, in 'n senior sertifikaateksamen wat deur die Raad erken word;

**"subminimum in 'n vak"** die standaard van minstens 20 persent in die sesde vak op Hoër Graad of Standaardgraad behaal deur 'n kandidaat wat in slegs vyf vakke vir 'n senior sertifikaat geslaag het;

**"Subsidiary Level-vak"** 'n vak aangebied vir en waarin geslaag op 'n bepaalde vlak voorgeskryf vir die eksamens van die eksamineringsinstansies vermeld in Aanhanga I;

**"subsidie"** 'n subsidie wat kragtens artikel 25 van die Wet aan 'n universiteit toegeken word;

**"T2-peil"** die standaard behaal in 'n tegniese vak op Nasionale Hoër Sertifikaatvlak waarin aan 'n Suid-Afrikaanse technikon geslaag is;

**"uitgewekene"** 'n Suid-Afrikaanse burger wat nie in die Republiek van Suid-Afrika geskool is nie as gevolg van sy of haar verblyf of die verblyf van sy of haar ouer of ouers in die buiteland en wat bewys daarvan uitgereik deur die United Nations High Commissioner for Refugees (UNHCR) kan lewer, welke bewys vir die Komitee van Hoofde aanyaarbaar is;

**"subsidy"** means a subsidy granted to a university in terms of section 25 of the Act;

**"T2 standard"** means the standard achieved in a technical subject at the National Higher Certificate level passed at a South African technikon;

**"the Act"** means the Universities Act, 1955 (Act No. 61 of 1955), as amended.

    - (ii) Afrikaans First or Second Language Higher Grade if English had been passed for the purposes of subparagraph (i) or English First or Second Language Higher Grade if Afrikaans had been passed for the purposes of subparagraph (i);
  - (e) among the five subjects passed included at least one subject from each of four different groups or two subjects from Group C or Group E mentioned in paragraph 2 and one subject from each of two other groups;

  - (iii) a candidate may not offer a language on both First Language as well as Second Language or both First Language as well as Third Language level;
  - (iv) in regard to the following groups of subjects, a candidate may not offer more than one language from the same group:
    - (aa) Xhosa, Swazi or Zulu;
    - (bb) Northern Sotho, Southern Sotho or Tswana; and

  - (vii) a candidate offering Accounting Higher Grade, Computer Studies Higher Grade or Technical Drawing Higher Grade for the purposes of paragraph 3 (f) shall pass in Mathematics on at least the Standard Grade;

- (x) English or Afrikaans Second Language Higher Grade shall not be recognised as a Higher Grade subject for the purposes of paragraph 3 (f), except as provided by proviso (v);
- (xi) Additional Mathematics Higher Grade shall be offered only in a combination of seven or more subjects including Mathematics Higher Grade and shall not be recognised for the purposes of paragraph 3 (f);
- (xii) the subject Geography, which is included in more than one group, shall not be recognised under more than one group for the purposes of paragraph 3 (a), (e) and (f);

Subject to provisos (i), (ii), (iii), (iv), (vi), (vii), (ix), (x), (xi), (xii) and (xiii) of paragraph 3 (g) and the provisions of paragraph 6, a senior certificate issued to an immigrant shall be endorsed by the Council, provided he or she was an immigrant who attended a school on a full-time basis and who arrived in South Africa not more than five years previously, calculated from the first day of January following the date of his or her first school attendance in South Africa, and who at one and the same sitting—
- (a) offered for the examination not less than six subjects from Groups A to F mentioned in paragraph 2, but including at least one subject from each of four different groups;
  - (b) passed in at least five subjects;
  - (c) obtained the minimum aggregate prescribed by paragraph 6;
  - (d) among the five subjects passed, included at least one subject from each of four different groups, or two subjects from Group C or Group E mentioned in paragraph 2 and one subject from each of two other groups;
  - (e) passed in at least three subjects on the Higher Grade, of which, subject to the provisions of paragraph (f), one shall be English or Afrikaans First Language Higher Grade and the other two, subject to provisos (vi), (vii), (viii), (ix), (x), (xi), (xii) and (xiii) to paragraph 3 (g), shall be selected from two of the Groups B, C, D, E and F mentioned in paragraph 2;
  - (f) passed in—
    - (i) either English or Afrikaans First Language Higher Grade; and

- (ii) Afrikaans First or Second Language Higher Grade if English had been passed for the purposes of subparagraph (i), or in English First or Second Language Higher Grade if Afrikaans had been passed for the purposes of subparagraph (i), or in another language selected from Group D mentioned in paragraph 2:

Provided that—

- (aa) in the case of a German speaking immigrant, a pass in German First Language Higher Grade shall be accepted in lieu of a pass in a First Language Higher Grade from Group A mentioned in paragraph 2 and such immigrant shall also pass in English or Afrikaans on at least the First Language Standard Grade or Second Language Higher Grade level;
- (bb) a pass in an immigrant's mother tongue on the Advanced Level for an examination conducted by an examining body mentioned in Annexure I may be offered in lieu of English or Afrikaans First or Second Language Higher Grade as a subject from Group A mentioned in paragraph 2, provided such an immigrant also passes in English or Afrikaans First Language Higher Grade or Standard Grade or Second Language Higher Grade;
- (cc) an Advanced Level first language subject passed in an examination sitting conducted six months before, concurrently with or six months after the senior certificate examination sitting shall be regarded as having been passed at one examination sitting: Provided further that the last date of examination shall determine the date of issue of the certificate in terms of paragraph 9;
- (dd) an immigrant who originates from a country where English is an official language may, besides English First Language Higher Grade, offer Afrikaans Second Language Standard Grade as a recognised subject from Group A mentioned in paragraph 2 for the purposes of paragraph 4 (a) and that if such immigrant obtains at least 40 per cent therein, he or she shall be deemed to have passed in a recognised subject for the purposes of paragraph 4 (b) and (d);
- (ee) the marks obtained for the Advanced Level first language subject shall be calculated in accordance with the formula prescribed for the senior certificate of the Council and shall be included in the aggregate in the place of the marks for English or Afrikaans First Language Higher Grade for endorsement purposes;
- (ff) an immigrant who offers a recognised Advanced Level first language subject and five senior certificate subjects may in addition to the Advanced Level first language subject present a maximum of three languages, whilst an immigrant offering a recognised Advanced Level first language subject and six or more senior certificate subjects may in addition to the Advanced Level first language subject present a maximum of four language subjects;
- (gg) an immigrant offering in addition to his or her mother tongue, both English and Afrikaans, may offer one of the two languages on Second Language Standard Grade as a recognised subject from Group D mentioned in paragraph 2 for the purposes of paragraph 4 (a) and (d); and
- (g) obtained at least 20 per cent in the subminimum in a subject.

#### **Minimum requirements for matriculation endorsement to be satisfied by part-time candidates**

5. Subject to paragraph 8 and the provisos to paragraph 3 (g) or, in the case of an immigrant, the provisos to paragraph 4 (f), the Council shall endorse the senior certificate of a part-time candidate: Provided that such person—
- (a) offered at least six subjects from Groups A to F mentioned in paragraph 2, but including at least one subject from each of four different groups;
  - (b) satisfied the requirements of paragraph 3 (b), (c), (d), (e), (f) and (g) or, in the case of an immigrant, the requirements of the provisos to paragraph 4 (f);

- (ii) Afrikaans Eerste of Tweede Taal Hoër Graad indien in Engels geslaag is vir die doeleindes van subparagraph (i), of in Engels Eerste of Tweede Taal Hoër Graad indien in Afrikaans geslaag is vir die doeleindes van subparagraph (i), of in 'n ander taal gekies uit Groep D vermeld in paragraaf 2;

Met dien verstande dat—

- (aa) in die geval van 'n Duitssprekende immigrant, 'n slaagpunt in Duits Eerste Taal Hoër Graad in plaas van 'n slaagpunt in 'n Eerste Taal Hoër Graad uit Groep A vermeld in paragraaf 2 aanvaar word en dat sodanige immigrant ook in Engels of Afrikaans op minstens die Eerste Taal Standaardgraadvlak of die Tweede Taal Hoër Graadvlak slaag;
- (bb) 'n slaagpunt in 'n immigrant se moedertaal op die Advanced Level vir 'n eksamen afgeneem deur 'n eksamineringsinstansie in Aanhangsel I vermeld, in plaas van Engels of Afrikaans Eerste of Tweede Taal Hoër Graad aangebied kan word as 'n vak uit Groep A vermeld in paragraaf 2, mits sodanige immigrant ook in Engels of Afrikaans Eerste Taal Hoër Graad of Standaardgraad of Tweede Taal Hoër Graad slaag;
- (cc) 'n Advanced Level-eerstetaalvak waarin geslaag is by 'n eksamensitting wat ses maande voor, gelykydig met of ses maande na die senior sertifikaateksamen plaasgevind het, geag word by een eksamensitting in geslaag te gewees het: Met dien verstande voorts dat die laaste eksamendatum die uitreikingsdatum van die sertifikaat ingevolge paragraaf 9 bepaal;
- (dd) 'n immigrant wat afkomstig is uit 'n land waar Engels 'n amptelike taal is, benewens Engels Eerste Taal Hoër Graad, Afrikaans Tweede Taal Standaardgraad vir die doeleindes van paragraaf 4 (a) kan aanbied as 'n erkende vak uit Groep A vermeld in paragraaf 2, en dat indien sodanige immigrant minstens 40 persent daarin behaal, hy of sy geag word vir die doeleindes van paragraaf 4 (b) en (d) in 'n erkende vak te geslaag het;
- (ee) die punte behaal in die Advanced Level-eerstetaalvak bereken word volgens die formule wat vir die senior sertifikaat van die Raad voorgeskryf is, en vir endosseringsdoeleindes by die groottaal ingesluit word in die plek van die punte vir Engels of Afrikaans Eerste Taal Hoër Graad;
- (ff) 'n immigrant wat 'n erkende Advanced Level-eerstetaalvak en vyf senior sertifikaatvakke aanbied, benewens die Advanced Level-eerstetaalvak 'n maksimum van drie taalvakke kan aanbied, terwyl 'n immigrant wat 'n erkende Advanced Level-eerstetaalvak en ses of meer senior sertifikaatvakke aanbied, benewens die Advanced Level-eerstetaalvak 'n maksimum van vier taalvakke kan aanbied;
- (gg) 'n immigrant wat benewens sy of haar moedertaal, beide Engels en Afrikaans aanbied, een van die twee tale op Tweede Taal Standaardgraadvlak vir die doeleindes van paragraaf 4 (a) en (d) kan aanbied as 'n erkende vak uit Groep D vermeld in paragraaf 2; en
- (g) minstens 20 persent behaal het in die subminimum in 'n vak.

**Minimum vereistes vir matrikulasie-endossement waaraan deeltydse kandidate moet voldoen**

5. Behoudens paragraaf 8 en die voorbehoudsbepalings van paragraaf 3 (g) of, in die geval van 'n immigrant, die voorbehoudsbepalings van paragraaf 4 (f), moet die Raad die senior sertifikaat van 'n deeltydse kandidaat endosseer: Met dien verstande dat so iemand—
  - (a) minstens ses vakke gekies uit Groepe A tot F vermeld in paragraaf 2, maar wat minstens een vak uit elke van vier verskillende groepe insluit, aangebied het;
  - (b) voldoen het aan die vereistes van paragraaf 3 (b), (c), (d), (e), (f) en (g) of, in die geval van 'n immigrant, die vereistes van die voorbehoudsbepalings van paragraaf 4 (f);

- (c) passed at the first examination sitting in at least three subjects, which may be either Higher Grade subjects or Standard Grade subjects or a combination of Higher and Standard Grade subjects, and at a subsequent examination sitting presented the remaining subjects to satisfy the requirements of paragraph 3 (d), (e), (f) and (g):

Provided further that such person at one of the two examination sittings passed simultaneously in at least two Higher Grade subjects selected from two different groups and at the two sittings combined passed in the two languages from Group A mentioned in paragraph 2 and one subject from each of four different groups or two subjects from Group C or Group E and one subject from each of two other groups, and obtained the minimum aggregate prescribed by paragraph 6: Provided further that a maximum of three subjects passed with 40 per cent or more by a full-time candidate at a previous examination sitting may be recognised as subjects passed towards a first part-time examination sitting.

#### **Minimum aggregate**

6. (1) The minimum aggregate to qualify for matriculation endorsement shall be 950 marks and a full-time candidate shall obtain these marks at one and the same examination sitting.
- (2) A part-time candidate shall obtain the minimum aggregate at a maximum of two examination sittings.

#### **Marks excluded from the aggregate**

7. In the case of candidates offering seven or more subjects, the marks in the subject or subjects in which the candidate obtained the lowest marks shall be excluded and the aggregate shall be calculated on the marks obtained in the remaining six subjects: Provided that the marks obtained in the First Language Higher Grade subject and the other First Language Higher Grade or Second Language Higher Grade subject offered for the purposes of Group A mentioned in paragraph 2 or another language enjoying the same recognition shall be included in the calculation of the aggregate.

#### **Conversion formula for satisfying matriculation endorsement or exemption requirements**

8. (1) If a candidate obtains  $33\frac{1}{2}$  per cent to 39 per cent in English or Afrikaans First Language Higher Grade, he or she shall be deemed to have passed with 40 per cent in that First Language Standard Grade and if a candidate obtains 30 per cent to 33 per cent in English or Afrikaans First Language Higher Grade, he or she shall be deemed to have passed with  $33\frac{1}{2}$  per cent in that First Language Standard Grade: Provided that—
- (a) a candidate who offers both English and Afrikaans or an African Language and one of either English or Afrikaans on the First Language Higher Grade level and obtains  $33\frac{1}{2}$  per cent and 39 per cent in one of either English or Afrikaans First Language Higher Grade, shall be deemed to have passed with 40 per cent in that language on the Second Language Higher Grade level; and
- (b) a candidate who offers both English and Afrikaans or an African Language and one of either English or Afrikaans on the First Language Higher Grade level and obtains 30 per cent to 33 per cent in one of either English or Afrikaans First Language Higher Grade, shall be deemed to have passed with  $33\frac{1}{2}$  per cent in that language on the Second Language Higher Grade level.
- (2) If a candidate obtains  $33\frac{1}{2}$  per cent to 39 per cent in German First Language Higher Grade, he or she shall be deemed to have passed with 40 per cent in German Third Language Higher Grade and if a candidate obtains 30 per cent to 33 per cent in German First Language Higher Grade, he or she shall be deemed to have passed with  $33\frac{1}{2}$  per cent in German Third Language Standard Grade.

- (c) by die eerste eksamsitting geslaag het in minstens drie vakke, wat of Hoër Graadvakke of Standaardgraadvakke of 'n kombinasie van Hoër Graad- en Standaardgraadvakke kan wees, en by die daaropvolgende eksamsitting al die oorblywende vakke aangebied het om aan die vereistes van paragraaf 3 (d), (e), (f) en (g) te voldoen:

Met dien verstande voorts dat so iemand by een van die twee eksamsittings in minstens twee Hoër Graadvakke, gekies uit twee verskillende groepe, gelyktydig geslaag het en by die twee sittings gesamentlik geslaag het in die twee tale uit Groep A vermeld in paragraaf 2 en een vak uit elke van vier verskillende groepe of twee vakke uit Groep C of Groep E en een vak uit elke van twee ander groepe, en die minimum groottotaal voorgeskryf by paragraaf 6 behaal het: Met dien verstande voorts dat 'n maksimum van drie vakke waarin 'n heetydse kandidaat by 'n vorige eksamsitting met 40 persent of meer geslaag het, erken kan word as vakke waarin geslaag is vir 'n eerste deeltydse eksamsitting.

#### **Minimum groottotaal**

6. (1) Die minimum groottotaal om vir 'n matrikulasie-endossement te kwalifiseer, is 950 punte en hierdie punte moet deur 'n heetydse kandidaat by een en dieselfde eksamsitting behaal word.
- (2) 'n Deeltydse kandidaat moet die minimum groottotaal by hoogstens twee eksamsittings behaal.

#### **Punte wat uit groottotaal uitgesluit word**

7. In die geval van kandidate wat sewe of meer vakke aanbied, word die punte in die vak of vakke waarin die kandidaat die laagste punte behaal het, uitgesluit en word die groottotaal op die punte behaal in die oorblywende ses vakke bereken: Met dien verstande dat die punte behaal in die Eerste Taal Hoër Graadvak en die ander Eerste Taal Hoër Graad- of Tweede Taal Hoër Graadvak wat vir die doeleindes van Groep A vermeld in paragraaf 2 aangebied is of 'n ander taal wat dieselfde erkenning geniet, by die groottotaal ingerekken moet word.

#### **Omwerkingsformule vir voldoening aan matrikulasie-endosserings- of vrystellingsvereistes**

8. (1) Indien 'n kandidaat 33½ persent tot 39 persent in Afrikaans of Engels Eerste Taal Hoër Graad behaal, word hy of sy geag met 40 persent in daardie Eerste Taal Standaardgraad te geslaag het en indien 'n kandidaat 30 persent tot 33 persent in Afrikaans of Engels Eerste Taal Hoër Graad behaal, word hy of sy geag met 33½ persent in daardie Eerste Taal Standaardgraad te geslaag het: Met dien verstande dat—
- (a) 'n kandidaat wat beide Afrikaans of Engels of 'n Afrikataal en een van Afrikaans of Engels op die Eerste Taal Hoër Graadvlek aanbied en tussen 33½ persent en 39 persent in een van Afrikaans of Engels Eerste Taal Hoër Graad behaal, geag word met 40 persent in daardie taal op die Tweede Taal Hoër Graadvlek te geslaag het; en
- (b) 'n kandidaat wat beide Afrikaans en Engels of 'n Afrikataal en een van Afrikaans of Engels op die Eerste Taal Hoër Graad aanbied en 30 persent tot 33 persent in een van Afrikaans of Engels Eerste Taal Hoër Graad behaal, geag word met 33½ persent in daardie taal op die Tweede Taal Hoër Graadvlek te geslaag het.
- (2) Indien 'n kandidaat 33½ persent tot 39 persent in Duits Eerste Taal Hoër Graad behaal, word hy of sy geag met 40 persent in Duits Derde Taal Hoër Graad te geslaag het en indien 'n kandidaat 30 persent tot 33 persent in Duits Eerste Taal Hoër Graad behaal, word hy of sy geag met 33½ persent in Duits Derde Taal Standaardgraad te geslaag het.

- (3) If a candidate obtains 33½ per cent to 39 per cent in an African Language First Language Higher Grade, he or she shall be deemed to have passed with 40 per cent in that African Language First Language Standard Grade and if a candidate obtains 30 per cent to 33 per cent in an African Language First Language Higher Grade, he or she shall be deemed to have passed with 33½ per cent in that African Language First Language Standard Grade.
- (4) If a candidate obtains 33½ per cent to 39 per cent in any Higher Grade subject other than those mentioned in subparagraphs (1), (2) and (3), he or she shall be deemed to have passed with 40 per cent in that subject on the Standard Grade and if a candidate obtains 30 per cent to 33 per cent in such a Higher Grade subject, he or she shall be deemed to have passed with 33½ per cent in that subject on the Standard Grade.
- (5) Subparagraphs (2), (3) and (4) shall also apply in cases where no official examination is offered in that subject on the Standard Grade.
- (6) Subject to paragraph 7, the final marks which were obtained in a subject at the level on which that subject was offered, shall be included in the aggregate.

**Date of issue of matriculation endorsement**

9. The Council shall endorse senior certificates that have to be endorsed in terms of paragraphs 3, 4 and 5 on the first day of the month following the month in which the requirements for endorsement were satisfied: Provided that in the case of a candidate who satisfied the requirements for endorsement at two examination sittings, the dates of the subjects passed at the relevant examination sittings shall be indicated on the senior certificate.

**REQUIREMENTS FOR ISSUE OF CERTIFICATES OF EXEMPTION**

**Certificate of exemption by virtue of a combination of technical subjects and senior certificate subjects**

10. The Committee of Principals shall issue a certificate of exemption to any person who passes in a combination of technical and senior certificate subjects: Provided that such person—
- (a) passed in each of at least four technical subjects on the N5 standard or T2 standard;
  - (b) included Mathematics among such four technical subjects; and
  - (c) towards the completion or partial completion of a senior certificate of the Council passed in both English or Afrikaans First Language Higher Grade and Afrikaans First or Second Language Higher Grade if English had been passed to satisfy the first language requirement or in English First or Second Language Higher Grade if Afrikaans had been passed to satisfy the first language requirement, or, in the case of a candidate offering an African Language as a first language for the purposes of Group A mentioned in paragraph 2, passed in an African Language First Language Higher Grade and in at least one of either English or Afrikaans First or Second Language Higher Grade, or, in the case of an immigrant, satisfied the language requirements specified in paragraph 4 (f).

**Certificate of exemption by virtue of the examinations of the examining bodies mentioned in Annexure I**

11. (1) Subject to subparagraph (2) hereof, the Committee of Principals shall issue a certificate of exemption to any person who passes the examination of the examining body mentioned in Annexure I: Provided that—
- (a) such person at one or more sittings for the examination obtained a pass determined by the examining body in a minimum of either five subjects approved by the Committee of Principals for this purpose, at least two of which shall be approved Advanced Level subjects and the remainder approved Ordinary Level subjects, or four approved subjects, three of which shall be approved Advanced Level subjects and the remaining subject any approved Ordinary Level subject; and

- (3) Indien 'n kandidaat  $33\frac{1}{2}$  persent tot 39 persent in 'n Afrikataal Eerste Taal Hoër Graad behaal, word hy of sy geag met 40 persent in daardie Afrikataal Eerste Taal Standaardgraad te geslaag het en indien 'n kandidaat 30 persent tot 33 persent in 'n Afrikataal Eerste Taal Hoër Graad behaal, word hy of sy geag met  $33\frac{1}{2}$  persent in daardie Afrikataal Eerste Taal Standaardgraad te geslaag het.
- (4) Indien 'n kandidaat  $33\frac{1}{2}$  persent tot 39 persent behaal in enige ander Hoër Graadvak as dié vermeld in subparagrawe (1), (2) en (3), word hy of sy geag met 40 persent in daardie vak op die Standaardgraad te geslaag het en indien die kandidaat 30 persent tot 33 persent in 'n Hoër Graadvak behaal, word hy of sy geag met  $33\frac{1}{2}$  persent in daardie vak op die Standaardgraad te geslaag het.
- (5) Subparagrawe (2), (3) en (4) is ook van toepassing in gevalle waar daar geen amptelike eksamen in daardie vak op die Standaardgraad afgeneem word nie.
- (6) Behoudens paragraaf 7 word die finale punte wat behaal is in 'n vak op dievlak waarop daardie vak aangebied is, by die groottotaal ingerekken.

#### **Datum van uitreiking van matrikulasie-endossement**

- 9. Die Raad moet senior sertifikate wat ingevolge paragrawe 3, 4 en 5 geendosseer moet word, endosseer op die eerste dag van die maand wat volg op die maand waarin aan die matrikulasie-endosseringsvereistes voldoen is: Met dien verstande dat in die geval van 'n kandidaat wat by twee eksamensittings aan die endosseringsvereistes voldoen het, die datums van die vakke waarin daar by die betrokke eksamensittings geslaag is, op die senior sertifikaat aangedui moet word.

#### **VEREISTES VIR UITREIKING VAN VRYSTELLINGSERTIFIKATE**

##### **Vrystellingsertifikaat op grond van 'n kombinasie van tegniese vakke en senior sertifikaatvakke**

- 10. Die Komitee van Hoofde moet 'n vrystellingsertifikaat uitreik aan iemand wat in 'n kombinasie van tegniese vakke en senior sertifikaatvakke geslaag het: Met dien verstande dat so iemand—
  - (a) geslaag het in elk van minstens vier tegniese vakke op N5-peil of T2-peil;
  - (b) Wiskunde by sodanige vier tegniese vakke ingesluit het; en
  - (c) ter verwerwing of gedeeltelike verwerwing van 'n senior sertifikaat van die Raad geslaag het in sowel Engels of Afrikaans Eerste Taal Hoër Graad as Afrikaans Eerste of Tweede Taal Hoër Graad indien in Engels geslaag is om aan die eerstetaalvereiste te voldoen of Engels Eerste of Tweede Taal Hoër Graad indien in Afrikaans geslaag is om aan die eerstetaalvereiste te voldoen, of, in die geval van 'n kandidaat wat 'n Afrikataal as Eerste Taal vir die doeleindest van Groep A vermeld in paragraaf 2 aanbied, geslaag het in 'n Afrikataal Eerste Taal Hoër Graad en in minstens een van Engels of Afrikaans Eerste of Tweede Taal Hoër Graad, of, in die geval van 'n immigrant, voldoen het aan die taalvereistes bepaal by paragraaf 4 (f).

##### **Vrystellingsertifikaat op grond van die eksamens van die eksamineringsinstansies vermeld in Aanhangsel I**

- 11. (1) Behoudens subparagraaf (2) moet die Komitee van Hoofde 'n vrystellingsertifikaat uitreik aan iemand wat in die eksamen van 'n eksamineringsinstansie vermeld in Aanhangsel I geslaag het: Met dien verstande dat—
  - (a) so iemand by een of meer eksamensittings 'n slaagpunt, bepaal deur die eksamineringsinstansie, behaal het in minstens vyf vakke wat deur die Komitee van Hoofde vir dié doel goedgekeur is en waarvan minstens twee goedgekeurde Advanced Level-vakke en die res goedgekeurde Ordinary Level-vakke is, óf vier goedgekeurde vakke waarvan drie goedgekeurde Advanced Level-vakke en die oorblywende vak 'n goedgekeurde Ordinary Level-vak is; en

- (b) such person included in the four or five subjects at least one subject selected from each of the following groups:
- Group I:** English Language;
- Group II:** Afrikaans, French, German, Greek, Hebrew, Italian, Latin, Nederlands, Portuguese or any other language approved by the Committee of Principals;
- Group III:** Biology, Botany, Chemistry, French (if not offered under Group II), General Science, Geology, German (if not offered under Group II), Greek (if not offered under Group II), Hebrew (if not offered under Group II), Italian (if not offered under Group II), Latin (if not offered under Group II), Mathematics, Nederlands (if not offered under Group II), Physics, Physics-with-Chemistry, Portuguese (if not offered under Group II) and Zoology, or any other language approved by the Committee of Principals (if not offered under Group II).

(2) For the purposes of the issuing of a certificate of exemption—

- (a) a credit in the Cambridge Overseas School Certificate examination shall be deemed to be an Ordinary Level subject pass of the General Certificate of Education;
- (b) a Subsidiary Level subject pass for an examination conducted by an examining body specified in Annexure I up to and including the July 1993 examination shall be deemed to be an Ordinary Level or an M Level subject pass, whilst as from the November 1993 examination such a subject pass shall be deemed to be an Ordinary Level pass only;
- (c) a mark of 42 to 44 per cent of the maximum marks in an M Level examination of the Associated Examining Board referred to in Annexure I shall be deemed to be an Ordinary Level pass;
- (d) a Principal Level subject pass at the Higher School Certificate examination conducted by an examining body specified in Annexure I shall be deemed to be an Advanced Level pass; and
- (e) a pass in a first-year degree instructional offering at a South African university approved for this purpose by the Committee of Principals, shall be deemed to be an Advanced Level pass.

**Certificate of exemption by virtue of the M Level examination of the Associated Examining Board**

12. (1) Subject to paragraph 11 (2) and subparagraph (2) and (3) hereof, the Committee of Principals shall issue a certificate of exemption to any person who passes the M Level examination of the Associated Examining Board referred to in Annexure I: Provided that such a person obtained the pass determined by the Associated Examining Board in—
- (a) at least five M Level subjects or a combination of four M Level subjects and one Ordinary Level subject or, in the case of an M Level examination written in November 1972 or thereafter, a combination of three M Level subjects and two Ordinary Level subjects approved by the Committee of Principals;
  - (b) at least one subject selected from each of the following groups:
- Group I:** English Language;
- Group II:** Afrikaans, French, German, Greek, Hebrew, Italian, Latin, Nederlands, Portuguese or any other language approved by the Committee of Principals;

- (b) so iemand by die vier of vyf vakke minstens een vak ingesluit het wat gekies is uit elk van die volgende groepe:

**Groep I:** Engelse Taal;

**Groep II:** Afrikaans, Duits, Frans, Grieks, Hebreeus, Italiaans, Latyn, Nederlands, Portugees of enige ander taal wat die Komitee van Hoofde goedkeur;

- (b) minstens een vak gekies uit elk van die volgende groepe:

**Groep I:** Engelse Taal;

**Groep II:** Afrikaans, Duits, Frans, Grieks, Hebreeus, Italiaans, Latyn, Nederlands, Portugees of enige ander taal wat die Komitee van Hoofde goedkeur;

**Group III:** Biology, Botany, Chemistry, French (if not offered under Group II), General Science, Geology, German (if not offered under Group II), General Science, Geology, German (if not offered under Group II), Greek (if not offered under Group II), Hebrew (if not offered under Group II), Italian (if not offered under Group II), Latin (if not offered under Group II), Mathematics, Nederlands (if not offered under Group II), Physics, Physics-with-Chemistry, Portuguese (if not offered under Group II) and Zoology, or any other language approved by the Committee of Principals (if not offered under Group II); and

**Group IV:** Any other subject from Group II or Mathematics (if not offered under Group III) or one of either Art, Biblical Studies, Economic Geography, Economic History, Economics, Geography, History or Music:

Provided further that not more than two Ordinary Level subjects may be recognised for the purpose of satisfying the grouping requirements mentioned in subparagraph (1) (b).

- (2) A candidate shall satisfy all the requirements of subparagraph (1) (a) and (b) at not more than three examination sittings.
- (3) For the purposes of subparagraph (2), a sitting for the examination in June and a sitting in December of the same year or a sitting in December and a sitting in the following June shall be deemed to be one sitting for such examination.

**Certificate of exemption by virtue of HIGCSE and IGCSE level examinations of the University of Cambridge Local Examinations Syndicate**

13. (1) Subject to paragraph 11 (2) and subparagraphs (2) and (3) hereof, the Committee of Principals shall issue a certificate of exemption to any person who—
- (a) passes in at least five different subjects on the HIGCSE and the IGCSE levels selected from four of the following groups:
- Group I:** A first language approved by the Committee of Principals;
- Group II:** A second language approved by the Committee of Principals;
- Group III:** A third language approved by the Committee of Principals which is not offered for the purposes of Group I or II, Biology, Mathematics, or Physical Science;
- Group IV:** Biology (if not offered under Group III), Geography, History, Mathematics (if not offered under Group III), or Physical Science (if not offered under Group III);
- Group V:** Accounting, Computer Studies or Design and Technology;
- (b) passes four HIGCSE level subjects, of which at least one shall be from Group I or II and at least two shall be from different groups, selected from Groups III, IV or V of paragraph (a); and
  - (c) passes either First Language English or English as a Second Language at HIGCSE level.
- (2) A HIGCSE level subject from Group V of subparagraph (1) (a), selected for the purposes of subparagraph (1) (b), shall be accompanied by a pass in Mathematics on at least the IGCSE level.
- (3) A candidate shall satisfy all the requirements of subparagraphs (1) (a) and (b) at not more than two examination sittings.

13. (1) Behoudens paragraaf 11 (2) en subparagraphe (2) en (3) hiervan, moet die Komitee van Hoofde 'n vrystellingsertifikaat uitrek aan iemand wat—

- (a) geslaag het in minstens vyf verskillende vakke op die HIGCSE- en die IGCSE-vlak gekies uit vier van die volgende groepe:

**Groep I:** 'n Eerste taal goedgekeur deur die Komitee van Hoofde;

**Groep II:** 'n Tweede taal goedgekeur deur die Komitee van Hoofde;

**Groep III:** 'n Derde taal, goedgekeur deur die Komitee van Hoofde, wat nie vir die doeleindes van Groep I of Groep II aangebied is nie, Biologie, Natuur- en Skeikunde of Wiskunde;

**Certificate of exemption by virtue of academic and professional certificates**

- 14.** The Committee of Principals shall, irrespective of the subjects offered at the qualifying examination, issue a certificate of exemption to—
- a graduate-by-examination of a foreign university or other foreign institution approved by the Committee of Principals;
  - any person who has passed examinations at a foreign university or other foreign institution approved by the Committee of Principals and who satisfies all the requirements of a qualification which in the opinion of the Committee of Principals is equivalent to an approved university degree; or
  - a medical or dental practitioner duly registered to practise as such under the provisions of the Medical, Dental and Supplementary Health Services Professions Act, 1974 (Act No. 56 of 1974).

**Certificate of exemption by virtue of post-school qualifications**

- 15. (1)** The Committee of Principals shall issue a certificate of exemption to any person who is in possession of—
- a senior certificate issued by the Council or any of the examining institutions previously recognised for this purpose by the Matriculation Board for matriculation exemption, or any equivalent qualification approved by the Committee of Principals; and
  - one of the following completed diplomas approved by the Committee of Principals, with a minimum prescribed full-time post-school duration of study of three years:
    - A diploma obtained from a South African university;
    - teachers' diploma obtained from a South African teachers' training college;
    - national diploma obtained at a South African technikon;
    - nursing diploma obtained at a South African nursing college in terms of a co-operation agreement with a South African university; or
    - any other equivalent post-school qualification approved by the Committee of Principals.
- (2)** A certificate of exemption issued in terms of subparagraph (1) shall be dated with effect from the first day of the month following the date of completion of the recognised diploma: Provided that if the university where the candidate intends to register for degree purposes is prepared to grant exemption from such degree instructional offerings by virtue of instructional offerings passed towards completion of such diploma, such university may apply on behalf of the candidate to antedate the certificate of exemption and the Committee of Principals may antedate such certificate to the beginning of the year in which the first diploma instructional offerings were passed on the grounds of which the relevant university is prepared to grant exemption from degree instructional offerings in terms of the provisions of the Joint Statute.

**Certificate of exemption to immigrants by virtue of a combination of senior certificate subjects and one language with Advanced Level equivalence**

- 16.** Subject to provisos (ii), (iii), (iv), (v), (vii), (viii), (ix), (x), (xi), (xii) and (xiii) to paragraph 3 (g) and the provisions of paragraph 6 of the endorsement requirements, the Committee of Principals may issue a certificate of exemption to an immigrant who was enrolled as a full-time candidate for a recognised examination, provided he was an immigrant who arrived in South Africa not more than five years previously, calculated from the first day of January following the date of his first day of school attendance in South Africa and who, at one and the same examination sitting—
- offered at least five senior certificate subjects selected from Groups A to F mentioned in paragraph 2, but included at least one subject from each of four different groups;

**Vrystellingsertikaat op grond van naskoolse kwalifikasies**

**15. (1)** Die Komitee van Hoofde moet 'n vrystellingsertikaat uitreik aan iemand wat in besit is van—

- (a) 'n senior sertifikaat uitgereik deur die Raad of enige van die eksamineringsinstansies wat voorheen vir dié doel deur die Matrikulasierraad vir matrikulasiervrystelling erken is, of enige gelykwaardige kwalifikasie deur die Komitee van Hoofde goedgekeur; en
- (b) een van ondervermelde voltooide diplomas, deur die Komitee van Hoofde goedgekeur, met 'n minimum voorgeskrewe heeltydse naskoolse studieduur van drie jaar:
  - (i) 'n Diploma wat aan 'n Suid-Afrikaanse universiteit verwerf is;
  - (ii) 'n onderwysdiploma wat aan 'n Suid-Afrikaanse onderwysersopleidingskollege verwerf is;
  - (iii) 'n nasionale diploma wat aan 'n Suid-Afrikaanse technikon verwerf is;
  - (iv) 'n verplegingsdiploma wat aan 'n Suid-Afrikaanse verpleegkollege ingevolge 'n samewerkingsooreenkoms met 'n Suid-Afrikaanse universiteit verwerf is; of
  - (v) enige ander gelykwaardige naskoolse kwalifikasie deur die Komitee van Hoofde goedgekeur.
- (2) 'n Vrystellingsertikaat uitgereik ingevolge subparagraph (1) word gedateer met ingang van die eerste dag van die maand wat volg op die datum van voltooiing van die erkende diploma: Met dien verstande dat indien die universiteit waar die kandidaat van voorneme is om hom of haar vir graadstudie te laat registreer, bereid is om vir graaddoelendes vrystelling van sekere onderrigaanbiedinge te verleen op grond van onderrigaanbiedinge waarin geslaag is ter voltooiing van bedoelde diploma, sodanige universiteit namens die kandidaat aansoek kan doen om terugdatering van die vrystellingsertikaat en die Komitee van Hoofde sodanige vrystellingsertikaat kan terugdateer tot die begin van die jaar waarin daar geslaag is in die eerste diploma-onderrigaanbiedinge op grond waarvan die betrokke universiteit bereid is om vrystelling van onderrigaanbiedinge ooreenkomsdig die bepalings van die Gemeenskaplike Statuut te verleen.

**Vrystellingsertikaat aan immigrante op grond van 'n kombinasie van senior sertifikaatvakke en een taal met Advanced Level-ekwivalensie**

**16.** Behoudens voorbeholdsbeplings (ii), (iii), (iv), (v), (vii), (viii), (ix), (x), (xi), (xii) en (xiii) van paragraaf 3 (g) en die beplings van paragraaf 6, kan die Komitee van Hoofde 'n vrystellingsertikaat aan 'n immigrant wat as 'n heeltydse kandidaat vir 'n erkende eksamen ingeskryf was, uitreik mits hy of sy hoogstens vyf jaar tevore, gereken vanaf die eerste dag van Januarie wat volg op die datum van sy of haar eerste skoolbywoning in Suid-Afrika, in Suid-Afrika aangekom het en by een en dieselfde eksamensitting—

- (a) minstens vyf senior sertifikaatvakke gekies uit Groepe A tot F vermeld in paragraaf 2, maar wat minstens een vak uit elk van vier verskillende groepe insluit, aangebied het;

- (b) offered a language with Advanced Level equivalence;
- (c) passed in at least the language with Advanced Level equivalence mentioned in paragraph (b) and four other subjects;
- (d) obtained the minimum aggregate prescribed by paragraph 6;
- (e) in addition to a pass in the language with Advanced Level equivalence mentioned in subparagraph (b), included in the subjects passed at least one subject from four different groups or two subjects from Group C or Group E mentioned in paragraph 2 and one subject from each of two other groups: Provided that the language with Advanced Level equivalence shall be recognised as a subject from Group A mentioned in paragraph 2 for the purposes of this paragraph;
- (f) passed in at least the language with Advanced Level equivalence mentioned in subparagraph (b) and two subjects on the Higher Grade which subjects passed shall, subject to the provisions of subparagraph (h) and provisos (vii), (viii), (ix), (x), (xi), (xii), (xiii) and (xiv) of paragraph 3 (g), be selected from any two of the Groups B, C, D, E or F mentioned in paragraph 2;
- (g) obtained at least 20 per cent in the subminimum in a fifth subject in a case where only the language referred to in subparagraph (b) and four subjects had been passed;
- (h) passed in Afrikaans or English First Language Higher Grade or Standard Grade or Second Language Higher Grade: Provided that—
  - (i) the marks obtained for the language with Advanced Level equivalence mentioned in paragraph (b) shall be calculated from a total of 400 marks which shall be added to the university admission aggregate in the place of the marks for the First Language Higher Grade;
  - (ii) the marks obtained in Afrikaans or English First Language Higher Grade, First Language Standard Grade or Second Language Higher Grade may be excluded for the purposes of calculating the aggregate;
  - (iii) an examination sitting in the language with Advanced Level equivalence mentioned in subparagraph (b), which was conducted six months before, concurrently with or six months after the senior certificate examination sitting, shall be regarded as one examination sitting for the purposes of this paragraph;
  - (iv) a candidate who offered a language with Advanced Level equivalence mentioned in subparagraph (b) and five subjects may, in addition to that language, present a maximum of three languages, and a candidate offering the language with Advanced Level equivalence and six or more subjects but who does not qualify for an endorsed certificate in terms of paragraph 4 may present a maximum of four languages in addition to that language; and
  - (v) if an immigrant, apart from the language offered in lieu of a First Language Higher Grade from Group A mentioned in paragraph 2, offered both English and Afrikaans, he or she may, in addition to one of the languages English or Afrikaans First or Second Language Higher Grade, offer the other one on the Second Language Standard Grade level as a recognised subject from Group D mentioned in paragraph 2 for the purposes of paragraph 4 (a) and if he or she obtains at least 40 per cent therein, he or she shall be deemed to have passed in a recognised subject for purposes of paragraph 4 (b) and (d).

**Date of issue of certificates of exemption**

- 17.** Subject to paragraph 15 (2) the Committee of Principals shall date certificates of exemption which are issued in terms of the provisions of paragraphs 10 to 15, from the first day of the month following the month in which these exemption requirements are satisfied.

- (b) 'n taal met Advanced Level-ekwivalensie aangebied het;

- (g) minstens 20 persent behaal het in die subminimum in 'n vyfde vak in die geval waar in slegs die taal vermeld in subparagraaf (b) en vier vakke geslaag is;
- (h) geslaag het in Afrikaans of Engels Eerste Taal Hoër Graad of Standaardgraad of Tweede Taal Hoër Graad: Met dien verstande dat—
  - (i) die punte behaal in die taal met Advanced Level-ekwivalensie vermeld in subparagraaf (b), bereken word uit 'n totaal van 400 punte wat by die groottotaal vir universiteitstoelating ingereken moet word in die plek van die punte in die Eerste Taal Hoër Graad;
  - (ii) die punte behaal in Afrikaans of Engels Eerste Taal Hoër Graad, Eerste Taal Standaardgraad of Tweede Taal Hoër Graad vir die berekening van die groottotaal uitgesluit kan word;
  - (iii) 'n eksamensitting in die taal met Advanced Level-ekwivalensie vermeld in subparagraaf (b), wat ses maande voor, gelykydig met of ses maande na die senior sertifikaatsamensitting plaasgevind het, geag word vir die doeleindes van hierdie paragraaf een eksamensitting te wees;
  - (iv) 'n kandidaat wat 'n taal met Advanced Level-ekwivalensie vermeld in subparagraaf (b) en vyf vakke aangebied het, benewens daardie taal 'n maksimum van drie tale kan aanbied, en 'n kandidaat wat die taal met Advanced Level-ekwivalensie en ses of meer vakke aangebied het maar wat nie vir 'n geëndosseerde sertifikaat ingevolge die bepalings van paragraaf 4 kwalifiseer nie, benewens daardie taal 'n maksimum van vier tale kan aanbied; en
  - (v) indien 'n immigrant, benewens die taal wat aangebied is in die plek van 'n Eerste Taal Hoër Graad uit Groep A vermeld in paragraaf 2, beide Engels en Afrikaans aangebied het, hy of sy, benewens een van die tale Engels of Afrikaans Eerste of Tweede Taal Hoër Graad, vir die doeleindes van paragraaf 4 (a), ook die ander taal op Tweede Taal Standaardgraadvak as 'n erkende vak uit Groepe D vermeld in paragraaf 2 kan aanbied, en indien hy of sy minstens 40 persent daarin behaal het, hy of sy geag word vir die doeleindes van paragraaf 4 (b) en (d) in 'n erkende vak te geslaag het.

#### Datum van uitreiking van vrystellingsertifikate

17. Behoudens paragraaf 15 (2) moet die Komitee van Hoofde vrystellingsertifikate wat ingevolge die bepalings van paragrawe 10 tot 15 uitgereik word, dateer vanaf die eerste dag van die maand wat volg op die maand waarin daar aan die vrystellingsvereistes voldoen is.

**Conversion of certificates of conditional exemption to endorsed senior certificates or certificates of complete exemption**

- 18.** (1) The Council shall endorse the senior certificate of a candidate who qualified for the issue of a certificate of conditional exemption in terms of the provisions of paragraphs 20 and 26, but to whom no certificate of conditional exemption had been issued, if such person satisfies the outstanding requirement or requirements at a subsequent senior certificate examination.
- (2) The Committee of Principals shall issue a certificate of complete exemption to a candidate to whom a certificate of conditional exemption had been issued in terms of paragraphs 20 to 27 if such person satisfies the outstanding requirement or requirements.

**REQUIREMENTS FOR THE ISSUING OF CERTIFICATES OF CONDITIONAL EXEMPTION****Issuing of certificates of conditional exemption**

- 19.** Subject to paragraphs 20 to 29, the Committee of Principals shall on application issue a certificate of conditional exemption to a person who intends enrolling for bachelor's degree studies at a South African university.

**Certificate of conditional exemption by virtue of a senior certificate issued by the Council**

- 20.** Subject to paragraphs 5, 6, 19, 29 and 30, the Committee of Principals shall issue a certificate of conditional exemption to a person who in an examination for a senior certificate of the Council—

- (a) at one and the same examination sitting or, in the case of a part-time candidate, at the two permitted qualifying sittings for the examination presented at least six subjects from Groups A to F mentioned in paragraph 2;
- (b) passed in at least five subjects;
- (c) obtained the minimum aggregate of 950 marks as prescribed by paragraph 6; and
- (d) lacks only one of the following requirements for the issuing of an endorsed certificate:
  - (i) a pass in one of the languages required by paragraph 3 (d);
  - (ii) a subject from a fourth group in terms of the provisions of paragraph 3 (a) or 4 (a) or a pass in a subject from one of the four groups required by paragraph 3 (e) or 4 (e);
  - (iii) a pass in a language from Group A mentioned in paragraph 2 required by proviso (v) to paragraph 3 (g);
  - (iv) a pass in one of either English or Afrikaans required by proviso (vi) to paragraph 3 (g);
  - (v) a pass in Mathematics or a natural science subject required by proviso (vii), (viii) or (ix) to paragraph 3 (g);
  - (vi) a pass in one of the subjects on the Higher Grade required by paragraph 3 (f); or
  - (vii) a 20 per cent subminimum in a subject: Provided that—
    - (aa) if a candidate lacks only a First Language Higher Grade to qualify for a matriculation endorsement, he or she shall be regarded as having to satisfy only one outstanding requirement; and
    - (bb) where a failure in one subject results in the candidate having to satisfy more than one requirement for a matriculation endorsement, a certificate of conditional exemption shall not be issued.

**Omskepping van voorwaardelikevrystellingsertifikate in geëndosseerde senior sertifikate of algehelevrystellingsertifikate**

18. (1) Die Raad moet die senior sertifikaat endosseer van 'n kandidaat wat vir die uitreiking van 'n voorwaardelikevrystellingsertifikaat ingevolge die bepalings van paragrawe 20 en 26 gekwalifieer het maar aan wie 'n voorwaardelikevrystellingsertifikaat nie uitgereik is nie, indien so 'n persoon aan die ontbrekende vereiste of vereistes by 'n daaropvolgende senior sertifikaateksamen voldoen.
- (2) Die Komitee van Hoofde moet 'n algehelevrystellingsertifikaat uitrek aan 'n kandidaat aan wie 'n voorwaardelikevrystellingsertifikaat ingevolge die bepalings van paragrawe 20 tot 27 uitgereik is, indien so 'n persoon aan die ontbrekende vereiste of vereistes voldoen.

**VEREISTES VIR DIE UITREIKING VAN VOORWAARDELIKEVRYSTELLINGERTIFIKATE**

**Uitreiking van voorwaardelikevrystellingsertifikate**

19. Behoudens paragrawe 20 tot 29 moet die Komitee van Hoofde op aansoek 'n voorwaardelikevrystellingsertifikaat uitrek aan iemand wat van voorneme is om hom of haar vir baccalaureusgraadstudie aan 'n Suid-Afrikaanse universiteit te laat inskryf.

**Voorwaardelikevrystellingsertifikaat op grond van 'n senior sertifikaat deur die Raad uitgereik**

20. Behoudens paragrawe 5, 6, 19, 29 en 30, moet die Komitee van Hoofde 'n voorwaardelikevrystellingsertifikaat uitgereik aan iemand wat in 'n eksamen ter verwerking van 'n senior sertifikaat van die Raad—
  - (a) by een en dieselfde eksamensitting of, in die geval van 'n deeltydse kandidaat, by die twee toegelate kwalifiserende sittings vir die eksamen minstens ses vakke gekies uit Groepe A tot F vermeld in paragraaf 2 aangebied het;
  - (b) in minstens vyf vakke geslaag het;
  - (c) die minimum groottotaal van 950 punte voorgeskryf by paragraaf 6 behaal het; en
  - (d) slegs **een** van die volgende vereistes vir die uitreiking van 'n geëndosseerde sertifikaat kortkom:
    - (i) 'n Slaagpunt in een van die tale vereis in paragraaf 3 (d);
    - (ii) 'n vak uit 'n vierde groep ingevolge die bepalings van paragraaf 3 (a) of 4 (a) of 'n slaagpunt in 'n vak uit een van die vier groepe vereis by paragraaf 3 (e) of 4 (e);
    - (iii) 'n slaagpunt in 'n taal uit Groep A vermeld in paragraaf 2 soos vereis by voorbehoudsbepaling (v) van paragraaf 3 (g);
    - (iv) 'n slaagpunt in een van Engels of Afrikaans vereis by voorbehoudsbepalings (vi) van paragraaf 3 (g);
    - (v) 'n slaagpunt in Wiskunde of 'n natuurwetenskapvak vereis by voorbehoudsbepaling (vii), (viii) of (ix) van paragraaf 3 (g);
    - (vi) 'n slaagpunt in een van die vakke op die Hoër Graad vereis by paragraaf 3 (f); of
    - (vii) 'n subminimum van 20 persent in 'n vak: Met dien verstande dat—
      - (aa) indien 'n kandidaat slegs 'n Eerste Taal Hoër Graad kortkom om vir 'n matrikulasie-endossement te kwalifieer, hy of sy geag word slegs aan een ontbrekende vereiste te moet voldoen; en
      - (bb) waar 'n druipsyfer in een vak meebring dat 'n kandidaat aan meer as een vereiste vir 'n matrikulasie-endossement moet voldoen, 'n voorwaardelikevrystellingsertifikaat nie uitgereik mag word nie.

**Certificate of conditional exemption by virtue of a combination of subjects passed in technical and other examinations**

**21.** Subject to paragraphs 26, 27 and 29, the Committee of Principals, shall issue a certificate of conditional exemption to a person who—

- (a) passed in four technical subjects, including Mathematics at the N5 level or the T2 level, and in one of the two languages prescribed by paragraph 10 (c); or
- (b) passed in both languages prescribed by paragraph 10 (c), but did not obtain a pass in Mathematics as one of the four technical subjects at the N5 level or the T2 level.

**Certificate of conditional exemption by virtue of the examinations of the examining bodies mentioned in Annexure I**

**22.** Subject to the provisions of paragraphs 11 (1), 27 (2), 28 and 30, the Committee of Principals shall issue a certificate of conditional exemption to a person who obtained, towards a certificate mentioned in Annexure I, the pass mark determined by the examining body concerned in a minimum of such four Ordinary Level and Advanced Level subjects as the Committee of Principals may approve: Provided that—

- (a) such person passed in at least one approved Advanced Level subject and in addition satisfied all the requirements of paragraph 11 (1) (b); or
- (b) such person passed in at least two approved Advanced Level subjects and in a subject from each of two of the three groups prescribed by paragraph 11 (1) (b); or
- (c) such person passed in at least two approved Advanced Level subject and in a subject from each of the three groups prescribed by paragraph 11 (1) (b) but lacks a pass in a fifth subject required by paragraph 11 (1) (a); or
- (d) if an exile passed in at least five approved Ordinary Level subjects, such subjects shall be accepted for the purposes of this paragraph: Provided further that the requirements of Groups II and III referred to in paragraph 11 shall be satisfied and that no new certificate or renewed certificate shall be issued to such candidate as from 1 January 1997.

**Certificate of conditional exemption by virtue of M Level examination of the Associated Examining Board**

**23. (1)** Subject to paragraphs 11 (2), 12 (2), 12 (3), 23 (2), 23 (3), 29 and 30, the Committee of Principals shall issue a certificate of conditional exemption to any person who—

- (a) offered a minimum of four M Level subjects for an examination of the Associated Examining Board referred to in Annexure I before November 1972 and obtained a pass determined by the abovementioned body in such four M Level subjects or in three of such M Level subjects and one Ordinary Level subject approved by the Committee of Principals: Provided that—
  - (i) such person satisfied all the requirements of paragraph 12 (1) (b) but passed in only three of the required four M Level subjects; or
  - (ii) such person passed in at least four M Level subjects but lacks a pass in a subject from groups I to IV mentioned in paragraph 12 (1) (b); or
  - (iii) such person passed in four M Level subjects that satisfy all the requirements of paragraph 12 (1) (b) but lacks a pass in a fifth subject required by paragraph 12 (1) (a).

**Voorwaardelikevrystellingsertifikaat op grond van 'n kombinasie van vakke waarin geslaag in tegniese en ander eksamens**

**21.** Behoudens paragrawe 26, 27 en 29 moet die Komitee van Hoofde 'n voorwaardelikevrystellingsertifikaat uitreik aan iemand wat—

- (a) geslaag het in vier tegniese vakke, insluitende Wiskunde op N5-peil of T2-peil, en in een van die twee tale voorgeskryf by paragraaf 10 (c); of
- (b) geslaag het in beide tale voorgeskryf by paragraaf 10 (c), maar nie geslaag het in Wiskunde as een van die vier tegniese vakke op N5-peil of T2-peil nie.

**Voorwaardelikevrystellingsertifikaat op grond van die eksamens van eksamineringsinstansies vermeld in Aanhangsel I**

**22.** Behoudens paragrawe 11 (1), 27 (2), 28 en 30 moet die Komitee van Hoofde 'n voorwaardelikevrystellingsertifikaat uitreik aan iemand wat vir 'n sertifikaat vermeld in Aanhangsel I die slaagpunt, bepaal deur die betrokke eksamineringsinstansie, behaal het in 'n minimum van die vier Ordinary Level- en Advanced Level-vakke wat die Komitee van Hoofde goedkeur: Met dien verstande dat—

- (a) so iemand in minstens een goedgekeurde Advanced Level-vak geslaag het en daar benewens aan al die vereistes van paragraaf 11 (1) (b) voldoen het; of
- (b) so iemand in minstens twee goedgekeurde Advanced Level-vakke en in 'n vak uit elk van twee van die drie groepe voorgeskryf by paragraaf 11 (1) (b) geslaag het; of
- (c) so iemand in minstens twee goedgekeurde Advanced Level-vakke en in 'n vak uit elk van die drie groepe voorgeskryf by paragraaf 11 (1) (b) geslaag het maar 'n slaagpunt in 'n vyfde vak vereis by paragraaf 11 (1) (a) kortkom; of
- (d) indien 'n uitgewekene in minstens vyf goedgekeurde Ordinary Level-vakke geslaag het, sodanige vakke vir die doeleindes van hierdie paragraaf aanvaar word: Met dien verstande voorts dat daar aan die vereistes van Groepe II en III vermeld in paragraaf 11 voldoen word en dat geen nuwe sertifikaat of hernude sertifikaat vanaf 1 Januarie 1997 aan so 'n kandidaat uitgereik word nie.

**Voorwaardelikevrystellingsertifikaat op grond van M Level-eksamen van die Associated Examining Board**

**23. (1)** Behoudens paragrawe 11 (2), 12 (2), 12 (3), 23 (2), 23 (3), 29 en 30, moet die Komitee van Hoofde 'n voorwaardelikevrystellingsertifikaat uitreik aan iemand wat—

- (a) voor November 1972 'n minimum van vier M Level-vakke vir 'n eksamen van die Associated Examining Board vermeld in Aanhangsel I aangebied het en die slaagpunt bepaal genoemde instansie behaal het in sodanige vier M Level-vakke of drie van sodanige M Level-vakke en een Ordinary Level-vak wat die Komitee van Hoofde goedkeur: Met dien verstande dat—
  - (i) so iemand aan al die vereistes van paragraaf 12 (1) (b) voldoen het maar in slegs drie van die vereiste vier M Level-vakke geslaag het; of
  - (ii) so iemand in minstens vier M Level-vakke geslaag het maar 'n slaagpunt in 'n vak uit Groepe I tot IV vermeld in paragraaf 12 (1) (b) kortkom; of
  - (iii) so iemand geslaag het in vier M Level-vakke wat aan al die vereistes van paragraaf 12 (1) (b) voldoen, maar 'n slaagpunt in 'n vyfde vak vereis by paragraaf 12 (1) (a) kortkom;

- (b) for an examination of the Associated Examining Board referred to in Annexure I, conducted as from November 1972 and thereafter, offered a minimum of three M Level subjects and obtained the pass determined by the above-mentioned body in such three M Level subjects and in one Ordinary Level subject or in two M Level subjects and two Ordinary Level subjects approved by the Committee of Principals: Provided that—
- (i) such person satisfied all the requirements of paragraph 12 (1) (b) but passed in only two of the required three M Level subjects; or
  - (ii) such person passed in at least three M Level subjects but lacks a pass in a subject from groups I to IV mentioned in paragraph 12 (1) (b); or
  - (iii) such person passed in three M Level subjects and one Ordinary Level subject that satisfy all the requirements of paragraph 12 (1) (b) but lacks a pass in a fifth subject required by paragraph 12 (1) (a).
- (2) A candidate shall not be entitled to a certificate of conditional exemption if the qualification on the grounds of which he or she would have qualified for the certificate in terms of subparagraph (1) was obtained at more than two examination sittings.
- (3) Any person to whom a certificate of conditional exemption was issued and who lacks a pass in another Ordinary Level subject, may satisfy the outstanding requirement by obtaining a pass in the particular subject at the Higher or Standard Grade for the purposes of a senior certificate of the Council or by obtaining a pass at a South African university in an examination for a qualifying instructional offering in the equivalent field of study.
- (4) Any person to whom a certificate of conditional exemption was issued and who lacks a pass in another M Level subject, may satisfy the outstanding requirement by obtaining a pass in the particular subject at the Higher Grade for the purposes of a senior certificate of the Council or by obtaining a pass in an examination for a qualifying instructional offering at a South African university at the first-year level which leads unconditionally to an instructional offering at the second-year level in the relevant field of study.

**Certificate of conditional exemption by virtue of HIGCSE and IGCSE level examinations of the University of Cambridge Local Examinations Syndicate**

24. (1) Subject to paragraphs 13 (2), 13 (3), 24 (2) and 29, the Committee of Principals shall issue a certificate of conditional exemption to a person who passed a minimum of four HIGCSE level subjects on one IGCSE level subject in an examination conducted by the University of Cambridge Local Examinations Syndicate and who lacks one of the following requirements:
- (a) an approved IGCSE or HIGCSE level subject for the purposes of paragraph 13 (1) (a);
  - (b) one of the compulsory groups required by paragraph 13 (1) (b);
  - (c) a HIGCSE level subject required by paragraph 13 (1) (b); or
  - (d) a pass in Mathematics on at least the IGCSE level as required by paragraph 13 (2).
- (2) A person is entitled to a certificate of conditional exemption if he or she has passed in the subjects by virtue of which the certificate was obtained in terms of subparagraph (1) at no more than two examination sittings.

**Voorwaardelikevrystellingsertifikaat op grond van HIGCSE- en IGCSE-vlak eksamens van die University of Cambridge Local Examinations Syndicate**

24. (1) Behoudens paragrawe 13 (2), 13 (3), 24 (2) en 29 moet die Komitee van Hoofde 'n voorwaardelikevrystellingsertifikaat uitreik aan iemand wat in 'n minimum van vier HIGCSE-vlak vakke en een IGCSE-vlak vak geslaag het in 'n eksamen afgeneem deur die University of Cambridge Local Examinations Syndicate en wat een van die volgende vereistes kortkom:
- (a) 'n Goedgekeurde IGCSE- of HIGCSE-vlak vak vir die doeleindes van paragraaf 13 (1) (a);
  - (b) een van die verpligte groepe by paragraaf 13 (1) (b) vereis;
  - (c) 'n HIGCSE-vlak vak by paragraaf 13 (1) (b) vereis; of
  - (d) 'n slaagpunt in Wiskunde op minstens die IGCSE-vlak soos by paragraaf 13 (2) vereis.
- (2) 'n Persoon is geregtig op 'n voorwaardelikevrystellingsertifikaat indien by hoogstens twee eksamensittings geslaag is in die vakke op grond waarvan die sertifikaat ingevolge subparagraaf (1) verwef is.

- (3) Any person to whom a certificate of conditional exemption was issued and who lacks a pass in another IGCSE level subject, may satisfy the outstanding requirement by obtaining a pass in the particular subject at the Higher or Standard Grade for the purposes of a senior certificate of the Council or by obtaining a pass at a South African university in an examination for a qualifying instructional offering in the equivalent field of study.
- (4) Any person to whom a certificate of conditional exemption was issued and who lacks a pass in another HIGCSE level subject, may satisfy the outstanding requirement by obtaining a pass in the particular subject at the Higher Grade for the purpose of a senior certificate of the Council or by obtaining a pass in an examination in the qualifying instructional offering at a South African university at the first-year level which leads unconditionally to an instructional offering at the second-year level in the relevant field of study.

**Certificate of conditional exemption to applicants from foreign countries**

25. Subject to paragraphs 29 (2), 29 (3) and 31, the Committee of Principals shall issue, irrespective of the subjects taken for the qualifying foreign school-leaving examination, a certificate of conditional exemption to the registrar of a South African university on behalf of an applicant from any foreign country: Provided that such person holds a certificate entitling him to unconditional admission as a candidate for a degree or equivalent qualification at a foreign university or other institution, approved by the Committee of Principals, in the country where the candidate obtained his first school certificate: Provided further that admission to such institution on the grounds of mature age or any other special conditions, shall not be regarded as unconditional admission to degree studies for the purposes of this paragraph.

**Certificate of conditional exemption to immigrants**

26. (1) Subject to paragraphs 2, 29 (2), 29 (3) and 31, the Committee of Principals shall issue a certificate of conditional exemption to an immigrant who, at the time of writing the examination qualifying him for a senior certificate of the Council, was an immigrant who had arrived in South Africa not more than five years previously, calculated from the first day of January following the date of his first school attendance in South Africa: Provided that such person at one and the same examination sitting—
- (a) offered for the examination at least six subjects selected from Groups A to F mentioned in paragraph 2, including at least one subject from each of four different groups;
  - (b) passed in at least five subjects;
  - (c) obtained the minimum aggregate prescribed by paragraph 6;
  - (d) obtained at least 33 $\frac{1}{3}$  per cent in either English or Afrikaans First Language Higher Grade; and
  - (e) satisfied the requirements of paragraph 3 (e), (f) and (g).
- (2) Subject to paragraphs 11, 26 (1) (a), 26 (1) (b), 29 (1), 29 (2) and 32, the Committee of Principals shall issue a certificate of conditional exemption to an immigrant who passed four technical subjects, including Mathematics, at the N5 level or the T2 level, and who wishes to register immediately as a student for bachelor's degree studies at a South African university: Provided that such person—
- (a) passed in each of at least four technical subjects at the N5 level or the T2 level;
  - (b) included Mathematics amongst such four subjects; and
  - (c) obtained at least 33 $\frac{1}{3}$  per cent in either English or Afrikaans First Language Higher Grade towards a senior certificate of the Council.

- (4) Iemand aan wie 'n voorwaardelikevrystellingsertifikaat uitgereik is en wat 'n slaagpunt in nog 'n HIGCSE-vlak vak kortkom, kan aan die ontbrekende vereiste voldoen deur 'n slaagpunt in die betrokke vak op die Hoër Graad te behaal vir die doeleinnes van 'n senior sertifikaat van die Raad of deur aan 'n Suid-Afrikaanse universiteit 'n slaagpunt te behaal in 'n eksamen vir 'n kwalifiserende onderrigaanbieding op eerstejaarsvlak wat onvoorwaardelik lei tot 'n onderrigaanbieding op tweedejaarsvlak in die ooreenstemmende vakgebied.

#### **Voorwaardelikevrystellingsertifikaat aan applikante uit die buitenland**

25. Behoudens paragrawe 29 (2), 29 (3) en 31 moet die Komitee van Hoofde, ongeag die vakke wat geneem is vir die kwalifiserende buitenlandse skooleindeksamen, 'n voorwaardelikevrystellingsertifikaat aan die registrateur van 'n Suid-Afrikaanse universiteit uitreik ten behoeve van 'n applikant uit enige vreemde land: Met dien verstande dat so iemand in besit is van 'n sertifikaat wat hom onvoorwaardelik toelaat as kandidaat vir 'n graad of gelykwaardige kwalifikasie van 'n deur die Komitee van Hoofde goedgekeurde buitenlandse universiteit of ander inrigting in die land waar die kandidaat sy eerste skoolsertifikaat verwerf het: Met dien verstande voorts dat toelating to so 'n inrigting op grond van gevorderde ouderdom of enige ander buitengewone voorwaardes, nie vir die doeleinnes van hierdie paragraaf as onvoorwaardelike toelating tot graadstudie beskou word nie.

#### **Voorwaardelikevrystellingsertifikaat aan immigrante**

26. (1) Behoudens paragrawe 2, 29 (2), 29 (3) en 31, moet die Komitee van Hoofde 'n voorwaardelikevrystellingsertifikaat uitreik aan 'n immigrant wat ten tyde van die afle van die eksamen wat hom vir 'n senior sertifikaat van die Raad laat kwalifieer, 'n immigrant was wat hoogstens vyf jaar tevore, gereken vanaf die eerste dag van Januarie wat volg op die datum van sy eerste skoolbywoning in Suid-Afrika, in Suid-Afrika aangekom het: Met dien verstande dat so iemand by een en dieselfde eksamensitting —
- (a) minstens ses vakke gekies uit Groepe A tot F vermeld in paragraaf 2, wat minstens een vak uit elk van vier verskillende groepe insluit, vir die eksamen aangebied het;
  - (b) in minstens vyf vakke geslaag het;
  - (c) die minimum groottotaal voorgeskryf by paragraaf 6 behaal het;
  - (d) minstens  $33\frac{1}{2}$  persent in óf Engels óf Afrikaans Eerste Taal Hoër Graad behaal het; en
  - (e) aan die vereistes van paragraaf 3 (e), (f) en (g) voldoen het.
- (2) Behoudens paragrawe 11, 26 (1) (a), 26 (1) (b), 29 (1), 29 (2) en 32 moet die Komitee van Hoofde 'n voorwaardelikevrystellingsertifikaat uitreik aan 'n immigrant wat in vier tegniese vakke, insluitende Wiskunde op N5-peil of T2-peil, geslaag het en wat hom of haar onmiddellik as 'n student vir baccalaureusgraadstudie aan 'n Suid-Afrikaanse universiteit wil laat inskryf: Met dien verstande dat so iemand —
- (a) geslaag het in elk van minstens vier tegniese vakke op N5-peil of T2-peil;
  - (b) Wiskunde by sodanige vier vakke ingesluit het; en
  - (c) in 'n eksamen ter verwerwing van 'n senior sertifikaat van die Raad minstens  $33\frac{1}{2}$  persent in óf Engels óf Afrikaans Eerste Taal Hoër Graad behaal het.

- (3) A pass in the home language of an immigrant at the Advanced Level of the General Certificate of Education shall be accepted in lieu of a pass in a First Language Higher Grade from Group A mentioned in paragraph 2, and such an immigrant shall be required to pass in one of either English or Afrikaans First Language Higher or Standard Grade or Second Language Higher Grade before a bachelor's degree can be conferred on him or her.
- (4) In the case of a German-speaking immigrant, a pass in German First Language Higher Grade shall be accepted in the place of a pass in a First Language Higher Grade from Group A mentioned in paragraph 2, and such an immigrant shall be required to pass one of either English or Afrikaans First Language Higher Grade or Standard Grade or Second Language Higher Grade before a bachelor's degree can be conferred on him or her.

**Certificate of conditional exemption by virtue of mature age**

- 27. (1) Subject to paragraphs 29 and 33, the Committee of Principals shall issue a certificate of conditional exemption to the registrar of a South African university on behalf of any person who submits a statement from the senate of the university specifically stating that the applicant may in the opinion of the senate reasonably be expected to complete the curriculum: Provided that the applicant—
  - (a) attained the age of 23 years before or during the year in which the applicant wishes to enrol at a South African university for a bachelor's degree with a minimum prescribed full-time duration of three years, for which a matriculation endorsement or a certificate of exemption is a prerequisite; and
  - (b) before 31 March of the year for which a certificate of conditional exemption is required, passed with at least 40 per cent in at least four Higher Grade or Standard Grade subjects, at least three of which shall have been passed simultaneously and one of which shall be a recognised subject on the Higher Grade: Provided further that—
    - (i) English or Afrikaans Second Language Higher Grade shall not be recognised as a Higher Grade subject for the purposes of this subparagraph, except in terms of proviso (v) to paragraph 3 (g); and
    - (ii) other subjects may be recognised for the purposes of this subparagraph, or that a certificate of conditional exemption may be issued in terms of this subparagraph to any person whose general educational qualifications satisfy the Committee of Principals.
- (2) Subject to paragraphs 27 (1), 29 and 30, the Committee of Principals shall, regardless of the applicant's educational qualifications, issue a certificate of conditional exemption to the registrar of a South African university on behalf of any person who submits a statement from the senate of the university specifically stating that the applicant may in the opinion of the senate reasonably be expected to complete the curriculum: Provided that the applicant attained the age of 45 years before or during the year in which the applicant wishes to enrol at a South African university for a bachelor's degree with a minimum prescribed full-time duration of three years.

**Certificate of conditional exemption by virtue of admission by the senate of a university**

- 28. (1) The Committee of Principals shall issue a certificate of conditional exemption to a person who, in the opinion of the senate of a university, has demonstrated, in a selection process approved by that senate, that he or she is suitable for admission to bachelor's degree studies, which certificate shall be valid for admission to that university only.

- (3) 'n Slaagpunt in die moedertaal van 'n immigrant op die Advanced Level van die General Certificate of Education word aanvaar in plaas van 'n slaagpunt in 'n Eerste Taal Hoër Graad uit Groep A vermeld in paragraaf 2, en van so 'n immigrant word vereis dat hy of sy in een van Engels of Afrikaans Eerste Taal Hoër Graad of Standaardgraad of Tweede Taal Hoër Graad slaag alvorens 'n baccalaureusgraad aan hom of haar toegeken kan word.
- (4) In die geval van 'n Duitssprekende immigrant word 'n slaagpunt in Duits Eerste Taal Hoër Graad aanvaar in plaas van 'n slaagpunt in 'n Eerste Taal Hoër Graad uit Groep A vermeld in paragraaf 2, en van so 'n immigrant word vereis dat hy of sy in een van Engels of Afrikaans Eerste Taal Hoër Graad of Standaardgraad of Tweede Taal Hoër Graad slaag alvorens 'n baccalaureusgraad aan hom of haar toegeken kan word.

#### **Voorwaardelikevrystellingsertifikaat op grond van gevorderde ouderdom**

27. (1) Behoudens paragrawe 29 en 33 moet die Komitee van Hoofde 'n voorwaardelikevrystellingsertifikaat aan die registrator van 'n Suid-Afrikaanse universiteit uitrek ten behoeve van iemand wat 'n verklaring van die senaat van die universiteit indien waarin uitdruklik verklaar word dat daar na die mening van die senaat redelikerwys verwag kan word dat die applikant die leergang sal voltooi: Met dien verstande dat die applikant—
- (a) die ouderdom van 23 jaar bereik het voor of gedurende die jaar waarin die applikant hom of haar aan 'n Suid-Afrikaanse universiteit laat inskryf vir 'n baccalaureusgraad met 'n minimum voorgeskrewe heeltydse duur van drie jaar waarvoor 'n matrikulasie-endossement of 'n vrystellingsertifikaat 'n voorvereiste is; en
  - (b) voor 31 Maart van die jaar waarvoor 'n voorwaardelikevrystellingsertifikaat verlang word, met minstens 40 persent geslaag het in minstens vier Hoër Graad- of Standaardgraadvakke waarin minstens drie gelyktydig geslaag is en waarvan een 'n erkende Hoër Graadvak is: Met dien verstande voorts dat—
    - (i) Engels of Afrikaans Tweede Taal Hoër Graad vir die doeleindes van hierdie subparagraph nie as 'n Hoër Graadvak erken word nie, uitgesonderd ingevolge voorbehoudsbepaling (v) van paragraaf 3 (g); en
    - (ii) ander vakke vir die doeleindes van hierdie subparagraph erken kan word of dat 'n voorwaardelikevrystellingsertifikaat kragtens hierdie subparagraph uitgereik kan word aan iemand wie se algemene opvoedkundige kwalifikasies die Komitee van Hoofde bevredig.
- (2) Behoudens paragrawe 27 (1), 29 en 30 moet die Komitee van Hoofde, ongeag die applikant se onderwyskwalifikasies, 'n voorwaardelikevrystellingsertifikaat aan die registrator van 'n Suid-Afrikaanse universiteit uitrek ten behoeve van iemand wat 'n verklaring van die senaat van die universiteit indien waarin uitdruklik verklaar word dat daar na die mening van die senaat redelickerwys verwag kan word dat die applikant die leergang sal voltooi: Met dien verstande dat die applikant die ouderdom van 45 jaar bereik het voor of gedurende die jaar waarin die applikant hom of haar aan 'n Suid-Afrikaanse universiteit laat inskryf vir 'n baccalaureusgraad met 'n minimum voorgeskrewe heeltydse duur van drie jaar.

#### **Voorwaardelikevrystellingsertifikaat op grond van toelating deur die senaat van 'n universiteit**

28. (1) Die Komitee van Hoofde moet 'n voorwaardelikevrystellingsertifikaat uitrek aan 'n persoon wat volgens die mening van die senaat van 'n universiteit in 'n keuringsproses deur daardie senaat goedgekeur, bewys gelewer het dat hy of sy geskik is vir toelating tot baccalaureusgraadstudie, welke sertifikaat geldig is vir toelating tot slegs daardie universiteit.

- (2) The issuing of such a certificate shall be provisional and shall not entitle a university to claim a subsidy for the person before a certificate of complete exemption is issued to him or her, but shall nevertheless entitle the university to admit him or her to bachelor's degree studies and to award credits towards a degree of that university for work completed towards the degree.
- (3) Where the senate of a university certifies that the holder of a certificate of conditional exemption issued in terms of this paragraph has completed one full credit of instructional offerings, the Committee of Principals shall issue a certificate of complete exemption to him or her, dated from the date of coming into operation of the certificate of conditional exemption.

**Period of validity of certificates of conditional exemption**

- 29. (1) A certificate of conditional exemption issued in terms of paragraphs 20 to 24 shall be deemed to have lapsed if the holder thereof does not satisfy the outstanding requirement mentioned on the certificate of conditional exemption on or before 31 March of the year following the year of registration for bachelor's degree studies at a South African university.
- (2) A certificate of conditional exemption issued in terms of paragraphs 20 to 27 shall be deemed to have lapsed if the holder thereof does not satisfy the outstanding requirement for exemption within a period equal to the minimum prescribed full-time duration for the relevant bachelor's degree plus two additional years calculated from 1 January of the year in which the holder registers for a bachelor's degree at a university.
- (3) A certificate of conditional exemption issued in terms of paragraph 28 shall be deemed to have lapsed if the holder thereof does not satisfy the outstanding requirements within a period of three years calculated from 1 January of the year in which the holder provisionally registers for a bachelor's degree at the relevant university.
- (4) Any person whose certificate of conditional exemption has lapsed, may again apply for a certificate in terms of the relevant provisions of paragraph 19 to 34.

**Completion of outstanding requirements for a certificate of conditional exemption by candidates who wrote their examinations before the introduction of the differentiated education system**

- 30. A candidate who in terms of the requirements and conditions applicable before the introduction of the provisions of the differentiated education system and who in terms of the regulations applicable at that stage, qualified to satisfy the outstanding requirements for a matriculation exemption certificate at a subsequent examination or examinations without having to repeat the whole examination, shall be allowed to satisfy the outstanding requirements in terms of the provisions of paragraph 6 (4) of the regulations of the Matriculation Board as published in Government Notice No. R. 323 of 18 February 1983.

**Certificate of conditional exemption issued in terms of the provisions of paragraphs 20 to 24**

- 31. (1) The holder of a certificate of conditional exemption issued in terms of paragraphs 20 to 24 who, during the period prescribed by paragraph 29, satisfies the conditions mentioned on the certificate and obtains at a South African university a credit for a bachelor's degree with a minimum prescribed full-time duration of three years, for which a matriculation endorsement or a certificate of exemption is a prerequisite, shall be deemed to be a student who is in possession of a certificate of exemption as from the commencement of such period and the Committee of Principals shall issue a certificate, dated accordingly, to him or her.

- (2) Die uitreiking van sodanige sertifikaat is voorlopig en verleen nie aan 'n universiteit die reg om 'n subsidie vir die persoon te eis alvorens 'n algehelevrystellingsertifikaat aan hom of haar uitgereik word nie, maar maak die universiteit desnieteenstaande daarop geregtig om die persoon tot baccalaureusgraadstudie toe te laat en aan hom of haar krediet vir 'n graad van daardie universiteit te verleen vir werk wat reeds ten opsigte van die graad voltooi is.
- (3) Waar die senaat van 'n universiteit verklaar dat die houer van 'n voorwaardelikevrystellingsertifikaat ingevolge hierdie paragraaf uitgereik, een volle krediet van onderrig-aanbiedinge voltooi het, moet die Komitee van Hoofde 'n algehelevrystellingsertifikaat aan hom of haar uitrek, gedateer vanaf die datum van inwerkingtreding van die voorwaardelikevrystellingsertifikaat.

#### **Geldigheidsduur van voorwaardelikevrystellingsertifikaate**

29. (1) 'n Voorwaardelikevrystellingsertifikaat uitgereik ingevolge paragrawe 20 tot 24 word geag te verval het indien die houer daarvan nie aan die ontbrekende vereiste vermeld in die voorwaardelikevrystellingsertifikaat voldoen het nie voor of op 31 Maart van die jaar wat volg op die jaar van inskrywing vir baccalaureusgraadstudie aan 'n Suid-Afrikaanse universiteit.
- (2) 'n Voorwaardelikevrystellingsertifikaat uitgereik ingevolge paragrawe 20 tot 27 word geag te verval het indien die houer daarvan nie aan die ontbrekende vrystellingsvereiste voldoen nie binne 'n tydperk gelykstaande aan die minimum heetlydse duur vir die betrokke baccalaureusgraad voorgeskryf plus 'n addisionele twee jaar bereken vanaf 1 Januarie van die jaar waarin die houer hom of haar vir 'n baccalaureusgraad aan 'n universiteit laat inskryf.
- (3) 'n Voorwaardelikevrystellingsertifikaat uitgereik ingevolge paragraaf 28 word geag te verval het indien die houer daarvan nie aan die ontbrekende vrystellingsvereistes voldoen nie binne 'n tydperk van drie jaar bereken vanaf 1 Januarie van die jaar waarin die houer hom of haar voorlopig laat inskryf vir 'n baccalaureusgraad aan die betrokke universiteit.
- (4) Iemand wie se voorwaardelikevrystellingsertifikaat verval het, kan opnuut kragtens die toepaslike bepalings van paragrawe 19 tot 34 om 'n sertifikaat aansoek doen.

#### **Voltooiing van ontbrekende vereistes vir 'n vrystellingsertifikaat deur kandidate wat 'n eksamen afgelê het voor die inwerkingtreding van die gedifferensieerde onderwysbedeling**

30. 'n Kandidaat wat ingevolge die vereistes en voorwaardes wat van krag was voor die inwerkingtreding van die bepalings van die gedifferensieerde onderwysbedeling en wat ingevolge die voorskrifte op daardie stadium van toepassing gekwalifiseer het om die ontbrekende vereistes vir 'n matrikulasienvrystellingsertifikaat by 'n daaropvolgende eksamen of eksamens aan te vul sonder om die eksamen in die geheel te herhaal, word toegelaat om ooreenkomstig die bepalings van paragraaf 6 (4) van die voorskrifte van die Matrikulasieraad soos gepubliseer in Goewermentskennisgewing No. R. 323 van 18 Februarie 1983 aan die ontbrekende vereistes te voldoen.

#### **Voorwaardelikevrystellingsertifikaat uitgereik ingevolge die bepalings van paragrawe 20 tot 24**

31. (1) Die houer van 'n voorwaardelikevrystellingsertifikaat uitgereik ingevolge paragrawe 20 tot 24 wat gedurende die tydperk voorgeskryf by paragraaf 29 aan die voorwaardes voldoen wat in die sertifikaat vermeld word en aan 'n Suid-Afrikaanse universiteit 'n krediet verwerf vir 'n baccalaureusgraad met 'n minimum heetlydse duur van drie jaar waarvoor 'n matrikulasi-endossement of 'n vrystellingsertifikaat 'n voorvereiste is, word geag 'n student te wees wat in besit is van 'n vrystellingsertifikaat vanaf die aanvang van sodanige tydperk, en die Komitee van Hoofde moet 'n sertifikaat dienooreenkomstig gedateer aan hom of haar uitrek.

- (2) If the holder of a certificate of conditional exemption satisfies the conditions mentioned on the certificate during the period prescribed by paragraph 29 (1) and (3) but obtains no credit for a bachelor's degree at a South African university during such period, the Committee of Principals shall issue a certificate of exemption to him dated from the first day of the month following the date on which he or she obtained a pass in the outstanding subject.
- (3) (a) If the holder of a certificate of conditional exemption does not satisfy the conditions mentioned on the certificate during the period prescribed by paragraph 29 (1), the certificate shall be deemed to have lapsed and he or she shall not be allowed to proceed with degree studies at university at the second-year level until he or she has satisfied the outstanding requirement.
- (b) A person referred to in subparagraph (a) may again apply in terms of paragraph 29 (4) for the renewal of his or her certificate of conditional exemption, and if such certificate is thus renewed, he or she shall be allowed to present further instructional offerings at the first-year level or may recommence his or her studies at the first-year level.

**Certificate of conditional exemption issued in terms of paragraph 25**

32. If any person to whom a certificate of conditional exemption has been issued in terms of paragraph 25 satisfies all the requirements of a South African university for a bachelor's degree with a minimum prescribed full-time duration of three years and for which a matriculation endorsement or a certificate of exemption is a prerequisite, the certificate of complete exemption shall be dated on the first day of the month following the month in which the applicant qualified for the school certificate in terms of which he was admitted as a candidate for a bachelor's degree or an equivalent qualification at a university or other institution approved by the Committee of Principals, in the country where the qualification was obtained.

**Certificate of conditional exemption issued in terms of paragraph 26**

33. (1) If the holder of a certificate of conditional exemption issued in terms of paragraph 26 (1) satisfies, at a South African university, during the period of validity of the certificate, the requirements for a bachelor's degree with a minimum prescribed full-time duration of three years, for which a matriculation endorsement or a certificate of exemption is a prerequisite, a certificate of complete exemption, dated with effect from 1 January of the year in which such candidate obtained the conditional credit for the bachelor's degree in terms of this paragraph, shall be issued to him or her, provided he or she at one or more recognised examinations and subject to the provisions of paragraph 8—
- (a) obtained at least 40 per cent in English or Afrikaans First Language Higher Grade if this minimum percentage was not obtained at the original examination; and
  - (b) obtained at least 33½ per cent in any other language on the Higher or Standard Grade selected from Group A or D mentioned in paragraph 2.
- (2) (a) A candidate who offers another language mentioned in paragraph 26 (3) or (4) in lieu of Afrikaans or English First Language Higher Grade shall be required to pass in Afrikaans or English First Language Higher Grade or Second Language Higher Grade before a bachelor's degree can be conferred on him or her.
- (b) The provisions of paragraph 8 shall apply in the cases referred to in subparagraph (a).

- (2) Indien die houer van 'n voorwaardelikevrystellingsertifikaat gedurende die tydperk voor geskryf by paragraaf 29 (1) en (3) aan die voorwaardes voldoen wat in die sertifikaat vermeld word, maar gedurende sodanige tydperk geen krediet vir 'n baccalaureusgraad aan 'n Suid-Afrikaanse universiteit verwef nie, moet die Komitee van Hoofde 'n vrystellingsertifikaat aan hom of haar uitrek, gedateer vanaf die eerste dag van die maand wat volg op die datum waarop hy of sy 'n slaagpunt in die ontbrekende vak behaal het.
- (3) (a) Indien die houer van 'n voorwaardelikevrystellingsertifikaat nie gedurende die tydperk voorgeskryf by paragraaf 29 (1) aan die voorwaardes vermeld in die sertifikaat voldoen nie, word die sertifikaat geag te verval het en word hy of sy nie toegelaat om met graadstudie op universiteit op tweedejaarsvlak voort te gaan nie alvorens hy of sy aan die ontbrekende vereiste voldoen het.
- (b) 'n Persoon bedoel in subparagraph (a) kan kragtens paragraaf 29 (4) aansoek doen om die hernuwing van sy of haar voorwaardelikevrystellingsertifikaat, en indien die sertifikaat aidus hernu word, word hy of sy toegelaat om verdere onder rigaanbiedinge op eerstejaarsvlak aan te bied of om opnuut 'n aanvang met sy of haar studie op eerstejaarsvlak te maak.

#### **Voorwaardelikevrystellingsertifikaat uitgereik ingevolge paragraaf 25**

32. Indien iemand aan wie 'n voorwaardelikevrystellingsertifikaat ingevolge paragraaf 25 uitgereik is, voldoen aan al die vereistes van 'n Suid-Afrikaanse universiteit vir 'n baccalaureusgraad met 'n minimum voorgeskrewe heetlydse duur van drie jaar waarvoor 'n matrikulasie-endossement of 'n vrystellingsertifikaat 'n voorvereiste is, word die algehelevrystellingsertifikaat gedateer op die eerste dag van die maand wat volg op die maand waarin die applikant die skoolsertifikaat verwerf het waarkragtens hy of sy toegelaat word as kandidaat vir 'n baccalaureusgraad of gelykwaardige kwalifikasie aan 'n universiteit of ander inrigting, deur die Komitee van Hoofde goedgekeur, in die land waar die kwalifikasie behaal is.

#### **Voorwaardelikevrystellingsertifikaat uitgereik ingevolge paragraaf 26**

33. (1) Indien die houer van 'n voorwaardelikevrystellingsertifikaat uitgereik ingevolge paragraaf 26 (1), gedurende die geldigheidsduur van die sertifikaat, aan 'n Suid-Afrikaanse universiteit voldoen aan die vereistes vir 'n baccalaureusgraad met 'n minimum voorgeskrewe heetlydse duur van drie jaar waarvoor 'n matrikulasie-endossement of 'n vrystellingsertifikaat 'n voorvereiste is, word 'n algehelevrystellingsertifikaat, gedateer vanaf 1 Januarie van die jaar waarin so iemand die voorwaardelike krediet vir die baccalaureusgraad ingevolge hierdie paragraaf verwerf het, aan hom of haar uitgereik mits hy of sy by een of meer erkende eksamens en behoudens die bepalings van paragraaf 8—
- (a) minstens 40 persent behaal het in Engels of Afrikaans Eerste Taal Hoër Graad indien hierdie minimum persentasie nie in die oorspronklike eksamen behaal is nie; en
- (b) minstens 33½ persent behaal het in enige ander taal op die Hoër Graad of Standardaardgraad gekies uit Groep A of D, vermeld in paragraaf 2.
- (2) (a) Van 'n kandidaat wat 'n ander taal kragtens paragraaf 26 (3) of (4) in plaas van Afrikaans of Engels Eerste Taal Hoër Graad aanbied, word vereis dat hy of sy slaag in Afrikaans of Engels Eerste Taal Hoër Graad of Tweede Taal Hoër Graad, alvorens 'n baccalaureusgraad aan hom of haar toegeken kan word.
- (b) Die bepalings van paragraaf 8 is in die gevalle bedoel in subparagraph (a) van toepassing.

**Certificate of conditional exemption issued in terms of paragraph 27**

34. (1) If the holder of a certificate of conditional exemption issued in terms of paragraph 27 satisfies, at a South African university, during the period of validity of the certificate, the requirements for a bachelor's degree with a minimum prescribed full-time duration of three years, for which a matriculation endorsement or a certificate of exemption is a prerequisite, and passes at any time during his course of study in one further approved subject on the Higher Grade, other than Afrikaans or English Second Language Higher Grade, and this further subject has been selected from a group other than the one from which the Higher Grade subject already passed was selected, a certificate of complete exemption shall be issued to him or her with effect from 1 January of the year in which such person obtained the conditional credit for a bachelor's degree in terms of this paragraph.
- (2) As soon as the holder of a certificate of conditional exemption issued in terms of paragraph 27 (2) satisfies all the requirements for a bachelor's degree with a minimum prescribed full-time duration of three years, for which a matriculation endorsement or a certificate of exemption is a prerequisite, an antedated certificate of complete exemption shall be issued to him with effect from 1 January of the year in which such person obtained the conditional credit for the bachelor's degree in terms of this paragraph.

**ISSUING OF CERTIFICATE OF EXEMPTION BY VIRTUE OF MEDICAL DISABILITY****Issuing of certificate of complete or conditional exemption by virtue of medical or physical disability**

35. The Committee of Principals shall issue a certificate of complete exemption or a certificate of conditional exemption to any person who, owing to medical or physical disability, is in the Committee's opinion unable to satisfy the endorsement requirements of paragraph 3.

**RECOGNITION OF BACHELOR'S DEGREE INSTRUCTIONAL OFFERINGS FOR EXEMPTION PURPOSES****Recognition of bachelor's degree instructional offerings in the place of corresponding senior certificate subjects for the issuing of a certificate of exemption**

36. (1) A pass in a first bachelor's degree instructional offering leading unconditionally to a second-year level instructional offering in that field of study may be recognised by the Committee of Principals for purposes of exemption from a corresponding senior certificate subject on the Higher Grade or Standard Grade.
- (2) A pass in a first bachelor's degree instructional offering, leading unconditionally to a second-year level instructional offering in a related field of study, may be recognised by the Committee of Principals for the purposes of exemption from a corresponding senior certificate subject on the Higher Grade or the Standard Grade.
- (3) A pass in a special, beginner's or practical bachelor's degree instructional offering recognised as a qualifying instructional offering, which leads to a second-year level instructional offering in that field of study or a related field of study and which is certified as such by the university concerned, may be recognised by the Committee of Principals for the purposes of exemption from a corresponding senior certificate subject on the Higher or Standard Grade: Provided that if such instructional offering does not lead to a second-year level instructional offering in that field of study or a related field of study, the Committee of Principals may recognise such instructional offering for the purposes of exemption from a corresponding senior certificate subject on the Standard Grade and, in the case of Afrikaans and English, for exemption from the relevant Second Language Higher Grade.

**REPEAL OF GOVERNMENT NOTICE**

37. Government Notice No. R. 2456 of 2 September 1992 is hereby repealed.
