PROCLAMATION

No. R. 46, 1995

MINERAL AND ENERGY LAWS RATIONALISATION
ACT, 1994 (ACT NO. 47 OF 1994)

Under sections 2 (1) and 3 (1) of the Mineral and Energy Laws Rationalisation Act, 1994 (Act No. 47 of 1994), I hereby determine that—

(a) the laws mentioned in Schedule 1 shall on 1 May 1995 be made applicable in the remainder of the national territory as defined in the Act; and

(b) the laws mentioned in Schedule 2 shall on 1 May 1995 be repealed in the territories set out in the fourth column thereof.




