MARKETING ACT, 1968 (ACT No. 59 OF 1968)

#### WOOL SCHEME: IMPOSITION OF LEVY

I, André Isak van Niekerk, Minister of Agriculture, hereby make known in terms of section 79 of the Marketing Act, 1968 (Act No. 59 of 1968), that—

(a) the Wool Board referred to in section 6 of the Wool Scheme published by Government Notice No. R. 1274 of 16 July 1993, as amended, has under section 26 of the said Scheme imposed the levy set out in the Schedule;

(b) the said levy has been approved by me and shall come into operation on 1 July 1995; and

(c) Government Notice No. R.1681 of 3 September 1993 is hereby repealed with effect from the said date of commencement.

#### SCHEDULE

##### Definition

1. Any word or expression in this Schedule to which a meaning has been assigned in the Scheme shall have that meaning and "the Scheme" means the Wool Scheme published by Government Notice No. R. 1274 of 16 July 1993, as amended by Government Notices Nos. R. 259 of 11 February 1994 and R. 1563 of 16 September 1994.

#### WOLSKEMA: OPLEGGING VAN HEFFING

Ek, André Isak van Niekerk, Minister van Landbou, maak hierby ingevolge artikel 79 van die Bemarkingswet, 1968 (Wet No. 59 van 1968), bekend dat—

(a) die Wolraad bedoel in artikel 6 van die Wolskema gepubliseer by Goewermentskennisgewing No. R. 1274 van 16 Julie 1993, soos gewysig, kragtens artikel 26 van genoemde Skema die heffing in die Bylae uiteengesit, opgelê het;

(b) die genoemde heffing deur my goedgekeur is en op 1 Julie 1995 in werking tree; en

(c) Goewermentskennisgewing No. R. 1681 van 3 September 1993 hierby herroep word met ingang van die datum van inwerkingtreding.

#### BYLAE

##### Woordomskrywing

1. In hierdie Bylae het enige woord of uitdrukking waaraan 'n betekenis in die Skema geheg is, daardie betekenis en beteken "die Skema" die Wolskema gepubliseer by Goewermentskennisgewing No. R. 1274 van 16 Julie 1993, soos gewysig by Goewermentskennisgewings Nos. R. 259 van 11 Februarie 1994 en R. 1563 van 16 September 1994.

**Imposition of levy**

2. A levy is hereby imposed on all wool that—
- (a) is produced in the Republic for sale in the Republic or for export; and
  - (b) is imported into the Republic for the purpose of the sale or processing thereof in the Republic.

**Amount of levy**

3. The amount of the levy referred to in clause 2 shall be 3 percent of the gross selling price of the wool concerned.

**Oplegging van heffing**

2. 'n Heffing word hierby opgelê op alle wol wat—
- (a) in die Republiek geproduseer word vir verkoop in die Republiek of vir uitvoer;
  - (b) in die Republiek ingevoer word vir doeleindes van die verkoop of verwerking daarvan in die Republiek.

**Bedrag van heffing**

3. Die bedrag van die heffing in klousule 2 bedoel, is 3 persent van die bruto verkoopprijs van die betrokke wol.
