ADMINISTRATION BY THE COMMISSIONER FOR INLAND REVENUE OF CERTAIN LAWS OF THE FORMER REPUBLICS OF TRANSKEI, BOPHUTHATSWANA, VENDA AND CISKEI

I, Christo Ferro Liebenberg, Minister of Finance, acting under section 37 of the Income Tax Act, 1994 (Act No. 21 of 1994), hereby provide that the Commissioner for Inland Revenue referred to in that section shall from 1 September 1995 be responsible for carrying out the provisions of—

- (c) the Income Tax Act, 1962 (Act No. 58 of 1962), of the former Republics of Transkei and Bophuthatswana;
- (d) the Stamp Duties Act, 1968 (Act No. 77 of 1968), of the former Republics of Transkei, Bophuthatswana, Venda and Ciskei;
- (e) the Transkei Taxation Act, 1969 (Act No. 8 of 1969), of the former Republic of Transkei;
- (f) the Bophuthatswana Taxation Act, 1978 (Act No. 26 of 1978), of the former Republic of Bophuthatswana;
- (g) the Company Tax Amendment Act, 1984 (Act No. 16 of 1984), of the former Republic of Ciskei;
