#### CORRECTION NOTICE

(1) The following correction to regulation 7 of the Twenty-Fifth Amendment to the Road Traffic Regulations, published by Government Notice No. R. 228 of 16 February 1996, is hereby published for general information:

(a) In subparagraph (i) of paragraph (c) of subregulation (1) of regulation 365 of the Regulations after the word "vehicle", add the following words:

" , except a trailer, ";

(b) in the Afrikaans text in subparagraph (i) of paragraph (c) of subregulation (1) of regulation 365 of the Regulations after the word "sleepwa", add a comma;

(c) in subparagraph (i) of paragraph (e) of subregulation (1) of regulation 365 of the Regulations after the word "trailer", add a comma; and

(d) in the Afrikaans text in subparagraph (i) of paragraph (e) of subregulation (1) of regulation 365 of the Regulations after the word "voertuig", add the following words:

" , uitgesonderd 'n sleepwa, ".

(2) The following correction to regulation 8 of the Twenty-Fifth Amendment to the Road Traffic Regulations, published by Government Notice No. R. 228 of 16 February 1996, is hereby published for general information:

In the Afrikaans text in subregulation (2) of regulation 365A of the Regulations substitute for the expression "36" of the expression "365".
