ANNEXURE

For general information it is hereby notified that the President has, under the powers vested in him by section 41 (1) of the Public Service Act, 1994, issued the following regulations:

The Public Service Regulations, published under Government Notice No. R. 1091 of 10 June 1994, as amended, are hereby further amended by—

- (a) the substitution in the introductory paragraph of regulation C4.2.1 for the words "(c) and (d)" of the words "(b) or (c)";
- (b) the substitution of the following introductory part to subregulation C4.2.1 (a) for the existing introductory part of subregulation C4.2.1 (a):
 - (a) Persons who were appointed as officers before 1 July 1966 and who were classified in terms of the pre-revised vacation leave in the undermentioned leave groups, and who still were officers on the day immediately before the commencement of the Public Service Amendment Act, 1996;";
- (c) the substitution of the following introductory part of subregulation C4.2.1 (b) for the existing introductory part of subregulation C4.2.1 (b):
 - (b) All persons appointed to the public service, except those listed in (a) and (c) to (i), and who have completed the following service:"; and
- (d) the deletion of subregulation C4.2.1 (c) and the consequent renumbering of subregulations C4.2.1 (d)–(j) to C4.2.1 (c)–(i)

Vir algemene inligting word hiermee bekendgemaak dat die President, kragtens die bevoegdhede aan hom verleen in artikel 41 (1) van die Staatsdienswet, 1994, die volgende regulasies uitgevaardig het:

Die Staatsdiensregulasies gepubliseer in Goewermentskennisgewing No. R. 1091 van 10 Junie 1994, soos gewysig, word hierby verder gewysig deur—

- (a) in die inleidende paragraaf van regulasie C4.2.1 die woorde "(c) of (d)" deur die woorde "(b) of (c)" te vervang;
- (b) die bestaande inleidende deel van subregulasie C4.2.1 (a) deur die volgende inleidende deel van subregulasie C4.2.1 (a) te vervang:
 - "(a) Persone wat voor 1 Julie 1966 as beampes aangestel was en wat ingevolge die voorhersiene vakansieverlof by die onderstaande verlofgroepe ingedeel was en wie nog steeds beampes was op die dag onmiddellik voor die inwerkingtreding van die Staatsdienswysigingswet, 1996;";
- (c) die bestaande inleidende deel van subregulasie C4.2.1 (b) deur die volgende inleidende deel van subregulasie C4.2.1 (b) te vervang:
 - "(b) Alle persone wat in die staatsdiens aangestel is, behalwe daardie gelys in (a) en (c) tot (i), en wat onderstaande diens voltooi het;" en
- (d) die skrapping van subregulasie C4.2.1 (c) en die gevolglike hernommering van subregulasies C4.2.1 (d)–(j) tot C4.2.1 (c)–(i).
