#### CONTROL MEASURES RELATING TO FRESH WATER CRAYFISH: AMENDMENT

#### SCHEDULE

##### *Definitions*

1. In this Schedule "the Control Measures" means the control measures relating to fresh water crayfish published by Government Notice No. R. 1451 of 19 August 1994.

##### *Amendment of paragraph 2*

2. Paragraph 2 of the Control Measures is hereby amended by the insertion of the expression "without the authority of the permit referred to in section 6 (3) (b) of the Act" after the expression "No user of land may".

##### *Amendment of Table 1*

3. Table 1 of the Control Measures is hereby amended by the substitution for the expression "Magisterial District of Bloemfontein" in column 3 of the expression "Indoors at 38 Springbok Avenue, Vaalbank South, Magisterial District of Bloemfontein."
