SEA FISHERY ACT, 1988 (ACT No. 12 OF 1988)

AMENDMENT OF REGULATIONS

The Minister of Environmental Affairs and Tourism has, with the concurrence of the Minister of Finance, under section 46 of the Sea Fishery Act, 1988 (Act No. 12 of 1988), amended the fees payable for the issuing of licences and permits in the Regulations promulgated in terms of the said Act, as set out in the Schedule.

SCHEDULE

1. "The Regulations" means the Regulations published under Government Notice No. R. 2934 dated 23 October 1992, as amended by Government Notices No. R. 3248 of 27 November 1992, No. R. 5 of 8 January 1993, No. R. 1052 of 18 June 1993, No. R. 2003 of 15 October 1993, No. R. 2228 of 17 November 1993, No. R. 2556 of 31 December 1993, No. R. 656 of 8 April 1994, No. R. 1371 of 12 August 1994, No. R. 987 of 30 June 1995, No. R. 1073 of 21 July 1995 and No. R. 1644 of 27 October 1995.

2. The Regulations are hereby amended by the substitution of Schedule B of the following Schedule:

"SCHEDULE B

1. The following licence fees are payable in respect of fishing boats for the period specified on the licence concerned:

For each fishing boat—

- of which the total length does not exceed five metres—R55;
- of which the total length is more than five metres but does not exceed eight metres—R80;
- of which the total length is more than eight metres but does not exceed 12 metres—R135;
- of which the total length is more than 12 metres but does not exceed 20 metres—R265; and
- of which the total length exceeds 20 metres—R395.

2. The following licence fees are payable annually in respect of fishing factories:

For each—

- (a) premises registered or liable for registration in terms of the Machinery and Occupational Safety Act, 1983 (Act No. 6 of 1983)—R395;
- (b) other premises—R80;
- (c) fishing boat which is used only to receive, process or freeze fish and to transport such fish—R395.

3. A fee of R25 is payable for the transfer of a licence.

4. (1) The following fees are payable annually in respect of permits in the fishing industry;

- (a) The issuing of a permit—R25;
- (b) the amendment of a permit—R25; and
- (c) the transfer of a permit—R25.

- (2) The provisions of subparagraph (1) shall not apply to the issuing of a permit in respect of research undertaken in the interest of the Department and the amendment of a permit on the instruction of the director-general."

3. The new fees shall come into operation on 1 July 1996.

THE FOODSTUFFS, COSMETICS AND DISINFECTANTS ACT, 1972
(ACT No. 54 OF 1972)

REGULATIONS RELATING TO FOOD COLOURANTS

The Minister of Health has, in terms of section 15 (1) of the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act No. 54 of 1972), made the regulations in the Schedule.

SCHEDULE

1. In this Schedule "the Act" means the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act No. 54 of 1972), and any expression to which a meaning has been assigned in the Act shall bear such meaning and, unless inconsistent with the context—

"colourant" means any substance which adds or restores colour in a foodstuff and includes any natural component of a foodstuff or a natural source as such not normally consumed as a foodstuff and not normally used as a characteristic ingredient of a foodstuff but added to a foodstuff for the purpose of colouring, and includes the synthetic equivalent of any natural colourant provided it is chemically identical to the pure colour principle of the natural colourant;

"colour index number (C.I. no.)" means the number allotted to the specific colourant in the latest edition of the *Colour Index of the Society of Dyers and Colourists, England*;

"GMP" means limited by good manufacturing practice;

"processed" means processed as defined in the regulations governing the labelling and advertising of foodstuffs published by Government Notice No. R. 2034 of 29 October 1993;

2. No person shall sell any foodstuff to which any colourant has been applied or added, except in so far as provided for as follows:

- (a) Only the colourants listed in Annex 1 may be used as colourants in foodstuffs.
- (b) Colourants may be used only in the foodstuffs listed in Annexes III, IV and V and subject to the conditions specified therein.
- (c) Colourants shall not be used in the foodstuffs listed in Annex II, except where expressly permitted in Annex III, IV or V.
- (d) Colourants permitted for certain uses only are listed in Annex IV.
- (e) Colourants permitted in general in foodstuffs and their conditions of use are specified in Annex V.
- (f) The maximum levels indicated in the Annexes relate to foodstuffs in the ready-to-eat form, unless otherwise stated.

3. All colourants shall comply with the latest specifications for identity and purity of food colourants issued by the Joint Food and Agricultural Organisation/World Health Organisation Expert Committee on Food Additives and, where such specifications do not exist, the provisions of the latest edition of the *Food Chemicals Codex* shall apply.

4. The presence of a colourant in a foodstuff is permissible in a compound foodstuff other than one mentioned in Annex II to the extent that the colourant is permitted in one of the ingredients of the compound foodstuff or if the foodstuff is intended to be used only in the preparation of a compound foodstuff, to such an extent that the compound foodstuff complies with the provisions of this regulation.

5. For the purposes of these regulations the following substances shall not be regarded as colourants:

Foodstuffs, flavouring and their components, incorporated during the manufacture of compound foodstuffs, because of their aromatic, sapid or nutritive properties and, together with this, a secondary colouring effect.

6. No diluent shall be added to any colourant mentioned in Annex I, III, IV or V other than a diluent or any combination of diluents mentioned in Annex VI which conforms to the general purity criteria laid down in Annex VI.

7. These regulations shall not apply to the foodstuffs referred to in the regulations published under Government Notice No. R. 2870 of 31 December 1981 relating to wine, other fermented beverages and spirits.

8. The regulation published under Government Notice No. R. 756 of 6 May 1977, as amended by Government Notices Nos. R. 1958 of 9 September 1983, R. 103 of 20 January 1984, R. 2152 of 27 September 1985, R. 2660 of 29 November 1985, R. 517 of 21 March 1986, R. 937 of 30 April 1987, R. 1123 of 22 May 1987, R. 1293 of 1 July 1988, R. 1427 of 15 July 1988, R. 1933 of 17 August 1990, R. 2380 of 12 October 1990, R. 2140 of 30 August 1991, R. 1878 of 10 July 1992, R. 118 of 29 January 1993, R. 325 of 5 March 1993, R. 341 of 5 March 1993, R. 710 of 30 April 1993, R. 943 of 4 June 1993, R. 964 of 4 June 1993, R. 1027 of 25 June 1993 and R. 1219 of 9 July 1993, is hereby repealed.

9. These regulations shall come into operation on 1 September 1996.

2. The products listed in 1 above shall conform to the following criteria of purity:

(ii) The products shall not contain more than 100 mg/kg of any one of the following substances:

Antimony, copper, chromium, zinc or barium sulphate; or more than 200 mg/kg of these substances taken together. The products shall not contain cadmium, mercury, selenium, thallium, uranium, chromates or soluble barium compounds in measurable quantities.

(a) ORGANIC IMPURITIES

The products shall not contain aromatic polycyclic hydrocarbons.

Die Minister van Gesondheid het kragtens artikel 15 (1) van die Wet op Voedingsmiddels, Skoonheidsmiddels en Ontsmettingsmiddels, 1972 (Wet No. 54 van 1972), die regulasies in die Bylae uitgevaardig.

BYLAE

1. In hierdie Bylae beteken "die Wet" die Wet op Voedingsmiddels, Skoonheidsmiddels en Ontsmettingsmiddels, 1972 (Wet No. 54 van 1972), en het enige uitdrukking waaraan 'n betekenis in die Wet geheg is, daardie betekenis, en, tensy uit die samehang anders blyk, beteken—

"GVP" beperk deur goeie vervaardigingspraktyk;

"kleurindeksnommer (K.I.-no.)" die nommer wat in die jongste uitgawe van die *Colour Index of the Society of Dyers and Colourists, England*, aan die spesifieke kleurstof toegeken is;

"kleurstof" 'n stof wat kleur gee aan of herstel in 'n voedingsmiddel, en ook 'n natuurlike komponent van 'n voedingsmiddel of 'n natuurlike bron, wat as sodanig nie gewoonlik as 'n voedingsmiddel verbruik word nie en nie gewoonlik as karakteristieke bestanddeel van 'n voedingsmiddel gebruik word nie, maar by 'n voedingsmiddel gevoeg word vir die doeleindes van kleuring, en omvat dit die sintetiese ekwivalent van enige natuurlike kleurstof mits dit chemies identies met die suiwer kleurbeginsel van die natuurlike kleurstof is;

"verwerk" verwerk soos omskryf in die regulasies betreffende die etikettering en advertering van voedingsmiddels afgekondig by Goewermentskennissgewing No. R. 2034 van 29 Oktober 1993;

2. Niemand mag 'n voedingsmiddel waarby 'n kleurstof gevoeg is of waarop 'n kleurstof aangewend is, verkoop nie, behalwe in soverre daarvoor soos volg voorsiening gemaak word:

- (a) Slegs die kleurstowwe gelys in Aanhangsel 1 mag as kleurstowwe in voedingsmiddels gebruik word.
- (b) Kleurstowwe mag slegs gebruik word in die voedingsmiddels gelys in Aanhangsels III, IV en V en behoudens die voorwaardes daarin gespesifiseer.
- (c) Kleurstowwe mag nie in die voedingsmiddels gelys in Aanhangsel II gebruik word nie, behalwe waar dit in Aanhangsel III, IV of V uitdruklik toegelaat word.
- (d) Kleurstowwe toegelaat slegs vir sekere gebruike word in Aanhangsel IV gelys.
- (e) Kleurstowwe algemeen toegelaat in voedingsmiddels en die voorwaardes vir die gebruik daarvan word in Aanhangsel V gespesifiseer.
- (f) Die maksimum vlakke aangedui in die Aanhangsels het betrekking op voedingsmiddels in die eetklaarvorm, tensy anders vermeld.

3. Alle kleurstowwe moet voldoen aan die jongste spesifikasies vir die identiteit en suiwerheid van voedselkleurstowwe uitgereik deur die Gesamentlike Voedsel- en Landbou-Organisasie/Wêreldgesondheidsorganisasie Deskundige Komitee op Voedselbymiddels, en waar sodanige spesifikasies nie bestaan nie, is die voorskrifte van die jongste uitgawe in die *Food Chemicals Codex* van toepassing.

4. Die aanwesigheid van 'n kleurstof in 'n voedingsmiddel is toelaatbaar in 'n ander saamgestelde voedingsmiddel as een gemeld in Aanhangsel II, in die mate waarin die kleurstof toegelaat word in een van die bestanddele van die saamgestelde voedingsmiddel of, as die voedingsmiddel bestem is om alleenlik by die voorbereiding van 'n saamgestelde voedingsmiddel gebruik te word, in so 'n mate dat die saamgestelde voedingsmiddel aan die bepalings van hierdie regulasie voldoen.

5. Die volgende stowwe word vir die toepassing van hierdie regulasies nie as kleurstowwe beskou nie:

MARKETING ACT, 1968 (ACT No. 59 OF 1968)

GENERAL LEVY ON WOOL

I, André Isak van Niekerk, Minister of Agriculture, acting in terms of section 46A of the Marketing Act, 1968 (Act No. 59 of 1968), hereby—

- (a) impose a general levy on wool on the basis set out in the Schedule;
- (b) declare that the said general levy shall come into effect on 1 July 1996; and
- (c) repeal Government Notice No. 749 of 11 April 1980 with effect from the said date of commencement.

A. I. VAN NIEKERK**Minister of Agriculture****SCHEDULE****Definitions**

1. In this Schedule any word or expression to which a meaning has been assigned in the scheme shall have that meaning, and—

“the Scheme” means the wool scheme published by Government Notice No. R. 1274 of 16 July 1993, as amended by Government Notices Nos. R. 259 of 11 February 1994 and R. 1563 of 16 September 1994; and

“wool” means the removed, natural coat of the sheep (genus ovis), in whatsoever form, except such wool that is produced in Namibia and Lesotho.

Imposition of general levy

2. A general levy is hereby imposed on all wool produced in the Republic for sale in the Republic or for export purposes.

Amount of general levy

3. The amount of the general levy referred to in clause 2, shall be 0,02 percent (VAT excluded) of the gross sum at which such wool is sold.

Payment of general levy

4. The general levy on wool referred to in clause 2 shall be payable by a producer *mutatis mutandis* at the same time and in the same manner as a levy and special levy payable by such a producer in terms of sections 26 and 27 of the Scheme.

MARKETING ACT, 1968 (ACT No. 59 OF 1968)

TIME AND MANNER OF PAYMENT OF LEVIES ON WOOL: AMENDMENT

I, André Isak van Niekerk, Minister of Agriculture, acting under section 89 of the Marketing Act, 1968 (Act No. 59 of 1968), amended the regulations published by Government Notice No. R. 1275 of 16 July 1993 as set out in the Schedule.

A. I. VAN NIEKERK**Minister of Agriculture****SCHEDULE****Definition**

1. Any word or expression in the Schedule to which a meaning has been assigned in the Scheme shall have that meaning and "the Regulations" means the regulations published by Government Notice No. R. 1275 of 16 July 1993.

Amendment of regulation 1 of the Regulations

2. Regulation 1 of the Regulations is hereby amended by the substitution for the definition of "levy" of the following definition:

"levy—

- (a) a levy and a special levy imposed by the Board in terms of section 26 of the Scheme; and
- (b) a general levy imposed by the Minister in terms of section 46A of the Act."

Addition of regulation 3A to the Regulations

3. The regulations are hereby amended by the insertion of the following regulation after regulation 3:

"Disposal of General Levy

3A. The General Manager of the Board (or his/her assignee) shall—

- (a) deposit the amount payable in respect of a general levy, included in the amount payable to the Board in terms of regulations 2 and 3, in the special account mentioned in section 46C of the Act; and
- (b) deposit such amount in the said account within 30 days after the date on which the Board received payment thereof."

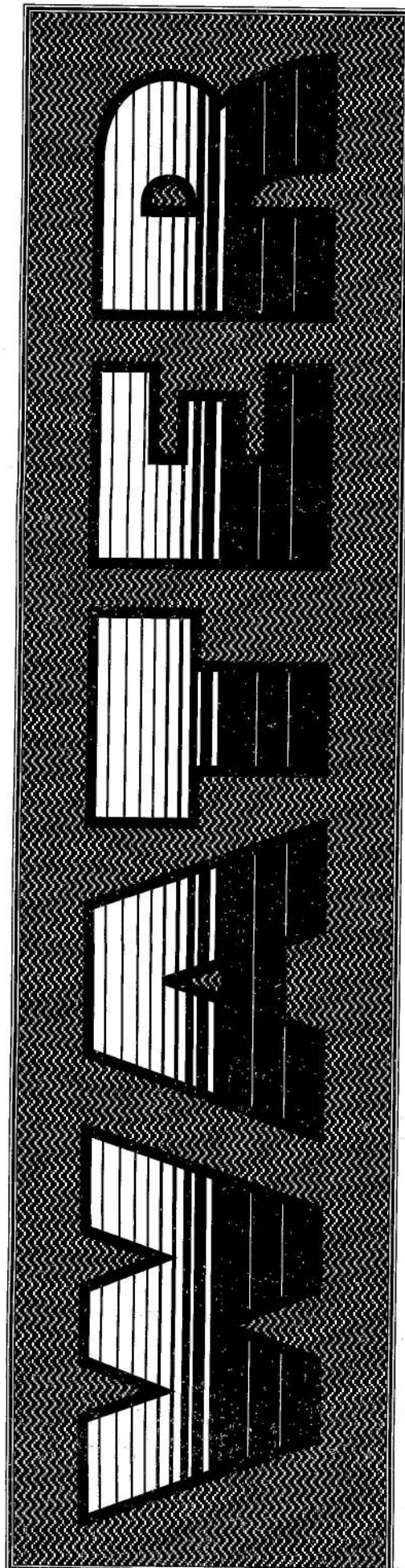
