ESTABLISHMENT OF A DEEDS REGISTRY AT UMTATA

I, Derek André Hanekom, Minister of Land Affairs, under section 1 of the Deeds Registries Act, 1937 (Act No. 47 of 1937), hereby—

- (a) establish, with effect from the date of commencement of Proclamation No. R. 9 of 1997, a deeds registry at Umtata for the area defined in the Schedule hereto; and
- (b) determine that the fees specified in items 5 and 6 to the Schedule of Fees of Office, prescribed by regulation 84 of the Regulations promulgated in terms of the Deeds Registries Act, 1937, may not be charged in the said registry.
