**AMENDMENT OF STATUTE**

The Council of the University of Port Elizabeth has, with the approval of the Minister of Education, under section 17 of the Universities Act, 1955 (Act No. 61 of 1955), framed the Statute set out in the Schedule hereto.

**SCHEDULE**

1. In this Schedule the expression "the Statute" means the statute published under Government Notice R. 766 of 28 May 1965, as amended by Government Notices, R. 27 of 7 January 1966, R. 1904 of 2 December 1966, R. 1629 of 20 September 1968, R. 554 of 10 April 1970, R. 890 of 28 May 1971, R. 1645 of 15 September 1972, R. 273 of 23 February 1973, R. 235 of 13 February 1976, R. 552 of 7 April 1977, R. 829 of 20 April 1979, R. 857 of 24 April 1981, R. 1159 of 18 June 1982, R. 1662 of 6 August 1982, R. 1274 of 17 June 1983, R. 1178 of 30 May 1985, R. 1032 of 8 May 1987, R. 2036 of 7 October 1988 and R. 1257 of 8 May 1992.

2. The following is hereby substituted for paragraph 1 of the Statute:

**"DEFINITION OF TERMS**

1. In this Statute, unless the context otherwise indicates, any expression to which a meaning has been assigned by section 1 of the University of Port Elizabeth Act, 1964, shall have the same meaning and -  
 i. "ballot" includes postal ballot;  
 ii. "committee" means the disciplinary committee referred to in paragraph 47;  
 iii. "country communities" means the organisations or associations which are based, in terms of location of their management structures and their members, in country areas in the University's student feeder area and which primarily serve the interests of the people or communities in the country areas;  
 iv. "day", in so far as it appears in paragraphs 44 to 55, means a day falling outside an academic recess period, excluding a public holiday;  
 v. "donor" means any person or institution who

**WYSIGING VAN STATUUT**

 i. "dag" vir sover dit in paragrawe 44 tot 55 voorkom, 'n dag wat buite 'n akademiese resesperiode val, uitgesonderd 'n openbare vakansiedag;  
 ii. "die Universiteit se studentevoedingsgebied" die Provinsie Oos-Kaap asook die landdrosdistrikte van Riversdale, Mosselbaai, George, Knysna, Uniondale, Oudtshoorn, Calitzdorp, Ladismith, Prince Albert, Beaufort-Wes, Murrarysburg, Richmond, Hanover, Noupoort en Colesberg;  
 iii. "die Wet" die Wet op die Universiteit van Port Elizabeth, 1964 (Wet No. 1 van 1964);  
 iv. "donateur" enige persoon of instelling wat voor 30 Junie 1997 'n totale bedrag van

- or which, before 30 June 1997, donated an aggregate amount of not less than R500 to the University, or who or which made a firm promise to donate an amount of not less than R500 to the University in regular instalments over a period of not more than ten years and is not in arrears with such instalments, or who or which after 1 July 1997, so donates or donated an amount as determined by the Council from time to time;
- vi. "education-related non-governmental organisations and other organisations" means non-governmental and other organisations in the University's student feeder area whose primary objectives and activities are educational;
- vii. "member of staff", in so far as it appears in paragraphs 44 to 55, means a permanently appointed member of staff;
- viii. "organised business" means bodies in the University's student feeder area such as chambers of commerce, chambers of industry and associations representing groups of commercial enterprises or groups of professional persons in private enterprise;
- ix. "organised labour" means bodies in the University's student feeder area such as trade unions, federations of trade unions and employee organisations for non-professional employees;
- x. "permanent staff" means those employees of the University appointed to permanent full-time or permanent part-time posts and employees appointed to non-permanent posts who have been in the University's employ for a minimum of three years;
- xi. "principal" means the principal of the University referred to in section 8 of the Act;
- xii. "registrar" means the officer referred to in paragraph 34;
- xiii. "secondary schools" means the governing bodies of secondary schools in the University's student feeder area;
- xiv. "secretary of the convocation" means the secretary of the convocation referred to in paragraph 34;
- xv. "secretary of the Council" means the secretary of the Council referred to in paragraph 34;
- xvi. "secretary of the Senate" means the secretary of the Senate referred to in paragraph 34;
- xvii. "the Act" means the University of Port Elizabeth Act, 1964 (Act 1 of 1964);
- xviii. "the University's student feeder area" means the Province of the Eastern Cape, as well as the magisterial districts of Riversdale, Mossel Bay, George, Knysna, Uniondale, Oudtshoorn, Calitzdorp, Ladismith, Prince Albert, Beaufort West, Murraysburg, minstens R500 aan die Universiteit geskenk het of wat 'n vaste belofte gedoen het om 'n bedrag van minstens R500 in gereelde paaiente gedurende 'n tydperk van hoogstens tien jaar aan die Universiteit te skenk en wat nie agterstallig is met sy of haar paaiente nie, of wat na 1 Julie 1997 'n bedrag soos van tyd tot tyd deur die Raad bepaal, aldus skenk of geskenk het;

- xv. "sekretaris van die konvokasie" die sekretaris van die konvokasie in paragraaf 34 vermeld;
- xvi. "sekretaris van die Raad" die sekretaris van die Raad in paragraaf 34 vermeld;
- xvii. "sekretaris van die Senaat" die sekretaris van die Senaat in paragraaf 34 vermeld;

xix.“vice-principal” means a vice-principal of the University referred to in section 8A of the Act.”.

3. The following paragraphs are hereby substituted for paragraphs 7 up to and including paragraph 16 of the Statute:

### **“COUNCIL**

#### *Mode of election: Convocation*

7. (1) Whenever it is necessary for the Convocation to elect a member of the Council, the secretary of the Council shall, by a notice published in those newspapers and internal University publications designated by Council, invite each member of the Convocation to nominate, in writing, a number of persons not exceeding the number of vacancies, to be elected as members of the Council.

(2) Each nomination shall be lodged with the secretary of the Council within thirty calendar days of the date of publication of the notice referred to in subparagraph 7(1), such nomination to be signed by at least five members and countersigned by the nominee to denote his or her acceptance of nomination.

(3) If the number of persons nominated is not greater than the number of vacancies, the secretary of the Council shall forthwith declare such person or persons to be duly elected, but if the number of persons nominated is greater than the number of vacancies, the secretary of the Council shall conduct a postal ballot involving all members of Convocation to elect the required number of members of the Council.

(4) In a postal ballot the ballot papers shall be returned to the secretary of the Council within thirty calendar days after the date on which the ballot papers were posted to voters.

(5) The principal shall, for the purposes of a postal ballot, appoint at least two scrutineers to assist the secretary of the Council with the conducting of the ballot.

#### *Mode of election: Donors*

8. Whenever it is necessary for the donors to elect a member of the Council, the procedure shall *mutatis mutandis* be the same as that prescribed for an election of a member of the Council by the Convocation in paragraph 7 of the Statute, provided that -

(a) an invitation to submit nominations shall be forwarded to individual donors by post with a return date for nominations of not less than thirty calendar days after the date

### **“RAAD**

#### *Wyse van verkiesing: Konvokasie*

7. (1) Wanneer die Konvokasie ‘n lid van die Raad moet verkies, nooi die sekretaris van die Raad by wyse van ‘n kennisgewing in daardie koerante en interne Universiteitspublikasies soos deur die Raad bepaal, elke lid van die Konvokasie uit om hoogstens soveel persone as waarvoor daar vakatures bestaan, skriftelik vir verkiesing as lede van die Raad te nomineer.

(2) Elke nominasie, onderteken deur minstens vyf lede en mede-onderteken deur die genomineerde ter aanduiding van sy of haar aanvaarding van die nominasie, moet binne dertig kalenderdae vanaf die datum van publikasie van die kennisgewing verwys na in subparagraph 7(1), by die sekretaris van die Raad ingedien word.

(3) Indien die getal genomineerde nie meer is as die aantal vakatures nie, verklaar die sekretaris van die Raad onverwyld dat sodanige persoon of persone behoorlik verkies is, maar indien die getal genomineerde meer is as die aantal vakatures, hou die sekretaris van die Raad ‘n posstemming wat alle konvokasielede betrek, om die vereiste aantal lede van die Raad te verkies.

(4) In ‘n posstemming moet die stembriewe binne dertig kalenderdae na die datum waarop die stembriewe aan kiesers gepos is, aan die sekretaris van die Raad teruggestuur word.

(5) Die rektor benoem vir die doel van ‘n posstemming minstens twee stemopnemers om die sekretaris van die Raad met die hou van stemming behulpsaam te wees.

#### *Wyse van verkiesing: Donateurs*

8. Wanneer die donateurs ‘n lid van die Raad moet verkies, is die prosedure *mutatis mutandis* dieselfde as dié wat vir die verkiesing van ‘n lid van die Raad deur die Konvokasie in paragraaf 7 van die Statuut voorgeskryf word, met dien verstande dat -

(a) ‘n uitnodiging om nominasies in te dien aan individuele donateurs per pos gerig word, met ‘n keerdatum vir nominasies van minstens dertig kalenderdae na die

(b) the nomination form need be signed by one donor only.

*Mode of election: Local authorities excluding the local authority of the city of Port Elizabeth*

9. (1) Whenever it is necessary for the local authorities in the University's student feeder area, excluding the local authority of the city of Port Elizabeth, to elect a member of the Council, the secretary of the Council shall, by a notice published in those newspapers designated by Council, invite local authorities in the University's student feeder area to apply for registration as voters in the election.

(2) Such application for registration shall be lodged with the secretary of the Council within thirty calendar days of the date of publication of the notice inviting local authorities to apply for registration as voters in the election.

(3) Each application for registration as a voter shall be submitted for approval to a committee constituted by Council.

(4) The secretary of the Council shall, by invitation forwarded by post to those local authorities which have been granted voter status, invite them to nominate a number of persons not exceeding the number of vacancies to be elected as members of the Council.

(5) Each nomination shall be lodged with the secretary of the Council within thirty calendar days after the date on which the invitations to nominate were posted.

(6) If the number of persons nominated is not greater than the number of vacancies, the secretary of the Council shall forthwith declare such person or persons to be duly elected, but if the number of persons nominated is greater than the number of vacancies, the secretary shall conduct a postal ballot involving all voters to elect the required number of members of the Council.

(7) In the postal ballot the ballot papers shall be returned to the secretary of the Council within thirty calendar days after the date on which the ballot papers were posted to voters.

(8) The principal shall, for the purposes of the postal ballot, appoint at least two scrutineers to assist the secretary of the Council with the conducting of the ballot.

(9) The nominee obtaining the highest number of votes shall be declared elected, provided that in the case of a tie in the voting, the issue shall be determined by lot.

9. (1) Wanneer die plaaslike owerhede in die Universiteit se studentvoedingsgebied, uitgesonderd die plaaslike owerheid van die stad Port Elizabeth, 'n lid van die Raad moet verkies, nooi die sekretaris van die Raad by wyse van 'n kennisgewing in daardie koerante soos deur die Raad bepaal, die plaaslike owerhede in die Universiteit se studentvoedingsgebied uit om aansoek te doen om registrasie as kiesers in die verkiesing.

(2) Sodanige aansoek om registrasie moet binne dertig kalenderdae vanaf die datum van publikasie van die kennisgewing wat plaaslike owerhede uitnooi om aansoek te doen om registrasie as kiesers in die verkiesing, by die sekretaris van die Raad ingedien word.

(3) Elke aansoek om registrasie as 'n kieser moet vir goedkeuring aan 'n komitee deur die Raad saamgestel, voorgelê word.

(4) Die sekretaris van die Raad nooi, by wyse van 'n uitnodiging deur die pos gerig, daardie plaaslike owerhede waaraan kieserstatus toegestaan is, uit om hoogstens soveel persone as waarvoor daar vakatures bestaan, vir verkiesing as lede van die Raad te nomineer.

(5) Elke nominasie moet binne dertig kalenderdae vanaf die datum waarop die uitnodigings vir nominasies gepos is, by die sekretaris van die Raad ingedien word.

(6) Indien die getal genomineerdes nie meer is as die aantal vakatures nie, verklaar die sekretaris van die Raad onverwyld dat sodanige persoon of persone behoorlik verkies is, maar indien die aantal genomineerdes meer is as die aantal vakatures, hou die sekretaris 'n posstemming wat alle kiesers betrek, om die vereiste aantal lede van die Raad te verkies.

(7) In 'n posstemming moet die stembriewe binne dertig kalenderdae na die datum waarop die stembriewe aan kiesers gepos is, aan die sekretaris van die Raad teruggestuur word.

(10) A local authority which had been granted voter status in a previous election conducted in terms of the provisions of the Statute, shall retain its voter status for all subsequent elections, unless such a local authority requests withdrawal of its voter status.

*Mode of election:*

- Secondary Schools*
- Country Communities*
- Education-related Non-governmental Organisations and other Organisations*
- Organised Business*
- Organised Labour*

10. Whenever it is necessary for any of the above stakeholders in the University's student feeder area to elect a member of the Council, an election shall be held for which the procedure shall *mutatis mutandis* be the same as that prescribed for an election of a member of the Council by the local authorities in paragraph 9 of the Statute.

*Mode of election: Permanent staff*

11. Whenever it is necessary for permanent staff to elect a member of the Council, an election shall be held for which the procedure shall *mutatis mutandis* be the same as that prescribed for the election of a member of the Council by Convocation in paragraph 7 of the Statute, provided that -

(1) an invitation to submit nominations shall be published in those internal University publications designated by Council;

(2) if a ballot needs to be held, votes may be cast by post or at a ballot station at a time and place determined by the secretary of the Council.

*Mode of appointment: Councillors to be appointed by Council*

12. The Council may, at any time, review its composition and may appoint, by its own resolution, not more than three persons as members of the Council on the grounds as stated in section 9(1)(p) of the Act.

*Term of office of Councillors*

13. (1) A member of the Council other than *ex officio* members and other than a member appointed in terms of section 9(1)(l) of the Act, shall hold office for a period of four years unless, before the expiry of such period, the member submits his or her resignation in writing to the Council or vacates the office for any other reason prescribed by the Statute.

(2) A member of the Council appointed in

*Wyse van verkiesing: Permanente personeel*

11. Wanneer die permanente personeel 'n lid van die Raad moet verkies, word 'n verkiesing gehou waarvoor die prosedure *mutatis mutandis* dieselfde is as dié wat vir die verkiesing van 'n lid van die Raad deur die Konvokasie in paragraaf 7 van die Statuut voorgeskryf word, met dien verstande dat -

(1) 'n uitnodiging om nominasies in te dien, gepubliseer word in daardie interne Universiteitspublikasies deur die Raad bepaal;

(2) indien 'n stemming gehou moet word, stemme deur middel van posstemme of by 'n stembus uitgebring mag word op 'n tyd en plek soos deur die sekretaris van die Raad bepaal.

*Wyse van aanstelling: Raadslede deur die Raad aangestel*

12. Die Raad kan, op enige tydstip, sy samestelling in oënskou neem en kan deur sy eie besluit hoogstens drie persone as lede van die Raad aanstel op die gronde wat in artikel 9(1)(p) van die Wet bepaal word.

*Ampstermyn van Raadslede*

13. (1) 'n Lid van die Raad, met uitsondering van *ex officio* lede of 'n lid wat kragtens artikel 9(1)(l) van die Wet aangestel is, beklee sy of haar amp vir 'n tydperk van vier jaar tensy, voor die verstryking van sodanige tydperk, die lid sy of haar bedanking skriftelik aan die Raad voorlê of die amp ontruim om enige ander rede wat by die Statuut voorgeskryf word.

(2) 'n Lid van die Raad wat kragtens artikel

terms of section 9(1)(l) shall hold office for the term of office of the Student Representative Council of the University, unless, before the expiry of such period, the member submits his or her resignation in writing to the Council or vacates his or her office for any other reason prescribed by the Statute.

(3) A casual vacancy on the Council caused by the death of or the vacation of his or her office by a member shall be filled for the unexpired portion of the period of office of such member.

#### *Gender representivity on Council*

14. Whenever any constituency entitled to elect or appoint more than one member of the Council has to do so, or whenever the Minister has to appoint members of the Council, such constituency or the Minister shall be informed in writing by the secretary of the Council that the University in principle regards substantial representation of both the male and the female gender on Council as desirable and that the constituency or the Minister should give due consideration to this principle in such election or appointment of members.

#### *Election of chairperson and vice-chairperson of the Council*

15. (1) Subject to the provisions of section 9(4)(a) of the Act, a chairperson or vice-chairperson shall be elected by Council in the following manner:

- The chairperson of the Council shall be elected at an ordinary meeting of the Council by a majority of the members present and voting.
- The secretary of the Council shall, whenever it is necessary that a chairperson or vice-chairperson be elected, give all members of the Council notice of such election at least thirty days before the date of the meeting at which the election will take place.
- At the meeting at which the election takes place, the secretary of the Council shall ask for nominations for a chairperson from the floor.
- If only one person is nominated, his or her nomination shall be put to the vote by secret ballot.
- If more than one person is nominated, the secretary of the Council shall conduct an election with the assistance of two scrutineers appointed by the Council.

#### *Gelyke geslagsverteenvoerding in die Raad*

14. Wanneer enige belanggroep wat daarop geregtig is om meer as een lid van die Raad te verkies of aan te stel, lede moet verkies of aanstel, of wanneer die Minister lede van die Raad moet aanstel, word sodanige belanggroep of die Minister skriftelik deur die sekretaris van die Raad verwittig dat die Universiteit in beginsel die wesentlike verteenwoordiging van sowel die manlike as die vroulike geslag in die Raad as wenslik ag en dat die belanggroepes of die Minister in sodanige verkiesing of aanstelling van lede behoorlik op hierdie beginsel ag moet slaan.

#### *Verkiesing van voorsitter en ondervoorsitter van die Raad*

15. (1) Behoudens die bepalings van artikel 9(4)(a) van die Wet word 'n voorsitter of ondervoorsitter van die Raad op die volgende wyse deur die Raad verkies:

- Die voorsitter van die Raad word op 'n gewone vergadering van die Raad deur 'n meerderheid van die lede wat aanwesig is en stem, verkies.
- Die sekretaris van die Raad moet, wanneer dit nodig is dat 'n voorsitter of ondervoorsitter verkies word, alle Raadslede minstens dertig dae voor die datum van die vergadering waarop die verkiesing sal plaasvind, van sodanige verkiesing in kennis stel.
- Op die vergadering waartydens die verkiesing plaasvind, moet die sekretaris van die Raad om nominasies vir 'n voorsitter van die aanwesige lede vra.
- As slegs een persoon genomineer word, word daar by wyse van geheime stemming oor sy of haar nominasie gestem.
- As meer as een persoon genomineer word, moet die sekretaris van die Raad 'n verkiesing hou met die hulp van twee stemopnemers wat deur die Raad aangestel word.

- (f) If a clear majority is not obtained by any nominee at the first ballot, a second ballot shall be held at which only those nominees shall be eligible who together obtained not less than half the total number of votes at the first ballot.
- (g) This procedure shall, if necessary, be repeated until one nominee obtains a clear majority, provided that in the event of an equality in the number of votes, the issue shall be determined by lot.

(2) Subject to the provisions of section 9(4)(a) of the Act, a vice-chairperson of the Council shall be elected immediately after the chairperson has been elected, in which election the procedure shall *mutatis mutandis* be the same as that for the election of the chairperson.

(3) The election of a chairperson and a vice-chairperson shall be held at the first meeting of the Council in a calendar year and the chairperson and vice-chairperson of the Council shall take office at the conclusion of the meeting at which they were elected.

(4) The term of office of the chairperson and vice-chairperson shall be four years and shall run concurrently.

(5) Should a chairperson or vice-chairperson vacate his or her office before the expiry of his or her term of office, a new chairperson or vice-chairperson shall be elected for the unexpired portion of the term of office, which election shall take place at the first Council meeting following on the vacation of the office.

#### *Vacation of office*

16. A member of the Council other than an *ex officio* member, shall be deemed to have vacated office if he or she—

- (a) absents himself or herself from three consecutive ordinary meetings without the leave of the Council;
- (b) becomes insolvent;
- (c) is convicted of a criminal offence involving dishonesty or of any offence for which he or she is sentenced to imprisonment without the option of a fine;
- (d) becomes incapacitated by reason of mental or bodily infirmity or disease;
- (e) in the case of a member of Council elected or appointed in terms of section 9(1)(k), (l) or (m) of the Act, ceases to be a member of the Senate, the Students' Representative Council or the permanent staff of the University respectively.”

(f) Indien 'n volstrekte meerderheid nie in die eerste stemming deur enige genomineerde verkry word nie, word 'n tweede stemming gehou waarvoor slegs daardie genomineerdes sal kwalifiseer wat saam nie minder nie as die helfte van die totale getal stemme in die eerste stemming verkry het.

(g) Hierdie prosedure word, indien nodig, herhaal totdat een genomineerde 'n volstrekte meerderheid verkry, met dien verstaande dat in die geval van 'n staking van stemme, die uitslag by wyse van lotting beslis word.

(2) Behoudens die bepalings van artikel 9(4)(a) van die Wet, word 'n ondervoorsitter van die Raad onmiddellik na die verkiesing van die voorsitter verkies, in welke verkiesing die prosedure *mutatis mutandis* dieselfde sal wees as dié vir die verkiesing van die voorsitter.

(3) Die verkiesing van 'n voorsitter en 'n ondervoorsitter word op die eerste vergadering van die Raad in 'n kalenderjaar gehou en die voorsitter en die ondervoorsitter van die Raad beklee hulle ampte vanaf die afsluiting van die vergadering waarop hulle verkies is.

(4) Die ampstermyn van die voorsitter en ondervoorsitter is vier jaar en val saam.

(5) Indien 'n voorsitter of ondervoorsitter sy of haar amp ontruim voor die verstryking van sy of haar ampstermyn, word 'n nuwe voorsitter of ondervoorsitter vir die onverstrekke gedeelte van die ampstermyn verkies, welke verkiesing tydens die eerste Raadsvergadering na die ontruiming van die amp gehou word.

#### *Ontruiming van amp*

16. Daar word geag dat 'n lid van die Raad, met uitsondering van 'n *ex officio* lid, sy of haar amp ontruim het as hy of sy—

- (a) sonder die toestemming van die Raad van drie agtereenvolgende gewone vergaderings afwesig is;
- (b) insolvent word;
- (c) skuldig bevind word aan 'n strafbare misdryf waarby oneerlikheid betrokke is, of aan enige misdryf waarvoor hy of sy tot gevangenisstraf sonder die keuse van 'n boete gevonnis word;
- (d) weens verstandelike of liggamlike swakheid of siekte onbekwaam word;
- (e) in die geval van 'n Raadslid wat ingevolge artikel 9(1)(k), (l) of (m) van die Wet as 'n lid van die Raad verkies of aangestel is, ophou om onderskeidelik 'n lid van die Senaat, die Verteenwoordigende Studenteraad of die permanente personeel

van die Universiteit te wees.”.

4. The following paragraph is hereby inserted as paragraph 19 of the Statute:

**“SENATE**

*Mode of appointment: Students*

19. The students who are to serve on Senate in terms of section 10(1)(i) of the Act shall be appointed in terms of the rules for student governance at the University.”.

5. The following paragraph is hereby inserted after paragraph 55 of the Statute:

*“Faculties at the University*

56. In addition to the faculties listed in section 13 of the Act, there shall be a faculty of Health Sciences at the University.”.

4. Die volgende paragraaf word hierby ingevoeg as paragraaf 19 van die Statuut:

**“SENAAT**

*“Wyse van aanstelling: Studente*

19. Die studente wat ingevolge artikel 10(1)(i) van die Wet in die Senaat sal dien, word ingevolge die reëls oor studentebestuur by die Universiteit aangestel.”.

5. Die volgende paragraaf word hierby na paragraaf 55 van die Statuut ingevoeg:

*“Fakulteite aan die Universiteit*

56. Benewens die fakulteite genoem in artikel 13 van die Wet, is daar ‘n fakulteit Gesondheidswetenskappe aan die Universiteit.”.
