ROAD TRAFFIC ACT, 1989 (ACT No. 29 OF 1989)

AMENDMENT OF THE ROAD TRAFFIC REGULATIONS

The Minister of Transport has under section 132 of the Road Traffic Act, 1989 (Act No. 29 of 1989), made the regulations in the Schedule.

SCHEDULE

Definition

1. In this Schedule, unless the context otherwise indicates, the expression "the Regulations" means the Road Traffic Regulations published by Government Notice No. R. 910 of 26 April 1990, as amended by Government Notices Nos. R. 1312 of 13 June 1990, R. 1954 of 17 August 1990, R. 2066 of 31 August 1990, R. 2982 of 14 December 1990, R. 125 of 14 February 1991, R. 1059 of 4 June 1991, R. 2694 of 15 November 1991, R. 1695 of 15 June 1992, R. 2803 of 1 October 1992, R. 2895 of 8 October 1992, R. 3172 of 20 November 1992, R. 766 of 30 April 1993, R. 1214 of 1 July 1993, R. 1767 of 20 September 1993, R. 1878 of 18 October 1993, R. 2448 of 24 December 1993, R. 792 of 29 April 1994, R. 1048 of 3 June 1994, R. 1081 of 7 June 1994, R. 1447 of 26 August 1994, R. 1835 of 28 October 1994, R. 352 of 28 February 1995, R. 926 of 30 June 1995, R. 1036 of 14 July 1995, R. 1135 of 28 July 1995, R. 1930 of 15 December 1995, R. 228 of 16 February 1996, R. 832 of 17 May 1996, R. 1076 of 28 June 1996, R. 1448 of 26 August 1996 and R. 2112 of 27 December 1996.

Amendment of regulation 175 of the Regulations

2. Regulation 175 of the Regulations is hereby amended by the insertion of the following definition after the definition of "motor vehicle licence":

"personalised registration number" means a registration number which may be issued upon application under regulation 199A (3);".

Amendment of regulation 181 of the Regulations

3. Regulation 181 of the Regulations is hereby amended by the substitution for paragraph (d) of subregulation (2) of the following paragraph:

- (d) if the motor vehicle is registered, the registration certificate concerned: Provided that the provisions of this paragraph shall not apply to an applicant—
 - (i) if the motor vehicle concerned has been repossessed and the person who obtained the registration certificate before the coming into operation of these Regulations, refuses to hand over the registration certificate to the applicant, and the provisions of regulation 185 have been complied with; or
 - (ii) if the registration certificate is lost and the applicant can prove that a notification of change of title holder or change of owner was given in terms of regulation 237 (2) or (3), and such applicant submits a South African Police clearance of the motor vehicle as well as an affidavit explaining the circumstances under which the registration certificate was lost;".

Amendment of regulation 194 of the Regulations

4. Regulation 194 of the Regulations is hereby amended by the insertion after paragraph (b) of the following paragraph:

- "(bA) on which a personalised registration number is allocated under regulation 199A (5);".

Amendment of regulation 195 of the Regulations

5. Regulation 195 of the Regulations is hereby amended by the insertion after paragraph (b) of subregulation (1) of the following paragraph:

- "(bA) on which a personalised registration number is allocated under regulation 199A (5);".

Insertion of regulation 199A in the Regulations

6. The following regulation is hereby inserted in the Regulations after regulation 199:

"Personalised registration number system"

199A. (1) The Administrator may by notice in the *Provincial Gazette* establish a personalised registration number system for the province concerned.

(2) The provisions of the Act which are applicable to registration numbers shall *mutatis mutandis* be applicable to personalised registration numbers.

(3) Personalised registration numbers shall, notwithstanding anything to the contrary contained in these regulations, be issued to a person upon application and subject to such conditions and upon payment of such fees or charges as are determined by the Administrator concerned.

(4) The Administrator concerned may, subject to regulation 206, by notice in the *Provincial Gazette* determine a logo or landscape, a colour for the letters and figures, and the colour of the retro-reflective surface to be displayed on a registration plate denoting the personalised registration numbers for the province concerned.

(5) The person referred to in subregulation (3) may apply to the appropriate registering authority for the allocation of the personalised registration number issued under subregulation (3), to a motor vehicle of which he or she is the owner."

Amendment of regulation 214 of the Regulations

7. Regulation 214 of the Regulations is hereby amended by the substitution for subregulation (1) of the following subregulation:

- "(1) An application—

- (a) for the licensing of a motor trade number shall be made simultaneously with and on the same form referred to in regulation 210 (1); or

- (b) for the renewal of a motor trade number licence shall be made within 21 days after the date of liability referred to in regulation 213 on the form referred to in paragraph (a), by the holder of such motor trade number.

Short title

8. These regulations shall be called the **Thirtieth Amendment of the Road Traffic Regulations**.

WYSIGING VAN DIE PADVERKEERSREGULASIES

Die Minister van Vervoer het kragtens artikel 132 van die Padverkeerswet, 1989 (Wet No. 29 van 1989), die regulasies in die Bylae uitgevaardig.

BYLAE

Woordomskrywing

1. In hierdie Bylae, tensy uit die samehang anders blyk, beteken die uitdrukking "die Regulasies" die regulasies uitgevaardig by Goewermentskennisgewing No. R. 910 van 26 April 1990, soos gewysig by Goewermentskennisgewings Nos. Wysiging van regulasie 175 van die Regulasies

2. Regulasie 175 van die Regulasies word hierdeur gewysig deur die volgende definisie na die definisie van "tydelike permit" in te voeg:

"persoonlike registrasienommer" 'n registrasienommer wat op aansoek ingevolge regulasie 199A (3); uitgereik kan word".

Wysiging van regulasie 181 van die Regulasies

3. Regulasie 181 van die Regulasies word hierby gewysig deur paragraaf (d) van subregulasie (2) deur die volgende paragraaf te vervang:

- (d) indien die motorvoertuig geregistreer is, die betrokke registrasiesertifikaat: Met dien verstande dat die bepalings van hierdie paragraaf nie van toepassing op 'n aansoeker is nie—
- (i) indien die betrokke motorvoertuig herinbesit geneem is en die persoon wie die registrasiesertifikaat verkry het voor die inwerkingtreding van hierdie Regulasies, weier om die registrasiesertifikaat aan die aansoeker te oorhandig, en die bepalings van regulasie 185 nagekom is; of
 - (ii) indien die registrasiesertifikaat verlore is en die aansoeker kan bewys dat 'n kennisgewing van verandering van titelhouer of verandering van eienaar gegee is ingevolge regulasie 237 (2) of (3), en daardie aansoeker lê 'n Suid-Afrikaanse Polisieklaring sowel as 'n beëdigde verklaring wat 'n verduideliking van die omstandighede waaronder die registrasiesertifikaat verlore gegaan het, bevat, voor;".

Wysiging van regulasie 194 van die Regulasies

4. Regulasie 194 van die Regulasies word hierby gewysig deur die volgende paragraaf na paragraaf (b) in te voeg:

"(bA) waarop 'n persoonlike registrasienommer toegeken word kragtens regulasie 199A (5);".

Wysiging van regulasie 195 van die Regulasies

5. Regulasie 195 van die Regulasies word hierby gewysig deur die volgende paragraaf na paragraaf (b) van subregulasie (1) in te voeg:

"(bA) waarop 'n persoonlike registrasienommer toegeken word kragtens regulasie 199A (5);".

Invoeging van regulasie 199A in die Regulasies

6. Die volgende regulasie word in die Regulasies na regulasie 199 ingevoeg:

"Persoonlike registrasienommerstelsel"

199A. (1) Die Administrateur kan by kennisgewing in die *Provinsiale Koerant* 'n persoonlike registrasienommerstelsel vir die betrokke provinsie instel.

(2) Die bepalings van die Wet wat van toepassing is op registrasienommers is *mutatis mutandis* van toepassing op persoonlike registrasienommers.

(3) Persoonlike registrasienommers word, ondanks enige andersluidende bepaling in hierdie regulasies, uitgereik aan 'n persoon op aansoek en behoudens sodanige voorwaardes en teen betaling van sodanige gelde of heffings as wat deur die betrokke Administrateur bepaal word.

(4) Die betrokke Administrateur kan, behoudens regulasie 206, by kennisgewing in die *Provinsiale Koerant* 'n logo of landskap, 'n kleur vir die letters en syfers, en die kleur van die trukaatsoppervlak bepaal wat op die registrasieplaat vertoon moet word, en wat die persoonlike registrasienommers van die betrokke provinsie aandui.

(5) Die persoon bedoel in subregulasie (3) kan by die toepaslike registrasieowerheid aansoek doen om die toekenning van 'n persoonlike registrasienommer, uitgereik kragtens subregulasie (3), aan 'n motorvoertuig waarvan hy of sy die eienaar is.".

Wysiging van regulasie 214 van die Regulasies

7. Regulasie 214 van die Regulasies word hierby gewysig deur subregulasie (1) deur die volgende subregulasie te vervang:

"(1) 'n Aansoek—

- (a) om die lisensiëring van 'n motorhandelnommer word terselfdertyd en op dieselfde vorm bedoel in regulasie 210 (1), gedoen; of
- (b) om hernuwing van 'n motorhandelnommer lisensie word binne 21 dae na die datum van aanspreeklikheid bedoel in regulasie 213 op die vorm bedoel in paragraaf (a) gedoen, deur die houer van sodanige motorhandelnommer.".

Kort titel

8. Hierdie regulasies heet die **Dertigste Wysiging van die Padverkeersregulasies**.

ROAD TRAFFIC ACT, 1989 (ACT NO. 29 OF 1989)

ESTABLISHMENT UNDER REGULATION 199A (1) OF THE ROAD TRAFFIC REGULATION, 1990, OF A PERSONALISED REGISTRATION NUMBER SYSTEM FOR THE PROVINCE OF KWAZULU-NATAL

I, Sathyandranath Ragunanan Maharaj, Minister of Transport, acting under regulation 199A (1) of the Road Traffic Regulations, hereby establish the following personalised registration number system for the Province of KwaZulu-Natal:

The personalised registration number allocated to any motor vehicle on or after 1 March 1997 at a registering authority in the Province of KwaZulu-Natal, shall consist of—

- (a) a maximum of six letters, followed by the letters "ZN";
- (b) a combined maximum of six letters and figures, followed by the letters "ZN"; or
- (c) a maximum of six figures, followed by the letters "ZN";

Provided that such a personalised registration number shall not consist of three consecutive letters, followed by three consecutive figures, followed by the letters "ZN".

INSTELLING INGEVOLGE REGULASIE 199A (1) VAN DIE PADVERKEERSREGULASIES, 1990, VAN 'N PERSOONLIKE REGISTRASIENOMMERSTELSEL VIR DIE PROVINSIE KWAZULU-NATAL

Ek, Sathyandranath Ragunanan Maharaj, Minister van Vervoer, handelende kragtens regulasie 199A (1) van die Padverkeersregulasies, stel hierby die volgende persoonlike registrasienommerstelsel in vir die provinsie KwaZulu-Natal:

Die persoonlike registrasienommer wat toegeken word aan enige motorvoertuig wat op of na 1 Maart 1997 by 'n registrasie-owerheid in die provinsie KwaZulu-Natal gelisensieer word, moet bestaan uit—

- (a) 'n maksimum van ses letters, gevvolg deur die letters "ZN";
- (b) 'n gekombineerde maksimum van ses letters en syfers, gevvolg deur die letters "ZN"; of
- (c) 'n maksimum van ses syfers, gevvolg deur die letters "ZN".

Met dien verstande dat sodanige persoonlike registrasienommer nie mag bestaan uit drie agtereenvolgende letters, gevvolg deur drie agtereenvolgende syfers, gevvolg deur die letters "ZN" nie.

DETERMINATION UNDER REGULATION 199A (4) OF THE ROAD TRAFFIC REGULATIONS, 1990, REGARDING A REGISTRATION PLATE FOR THE PROVINCE OF KWAZULU-NATAL

I. Sathyandranath Ragunanan Maharaj, Minister of Transport, acting under regulation 199A (4) of the Road Traffic Regulations, 1990, hereby determine that a registration plate displaying a personalised registration number issued by a registering authority in the Province of KwaZulu-Natal on or after 1 March 1997, shall display the words "KWAZULU-NATAL" underneath the personalised registration number, within a break in the middle of the line which frames the personalised registration number, which words shall be 10 millimetres in size and be printed in the "Helvetica medium" letter type.

REGARDING A REGISTRATION PLATE FOR THE FREE STATE PROVINCE**

I, Sathyandranath Ragunanan Maharaj, Minister of Transport, acting under regulation 199 (2) of the Road Traffic Regulations, hereby determine that—

- (a) the determination of the colour of the letters and figures and the colour of the retro-reflective surface of a registration plate displaying a registration number or motor trade number issued by a registering authority in the Free State Province, as set out in *Government Gazette* No. 17690, Notice No. R. 2118 of 27 December 1996, shall come into operation on 1 March 1997; and
- (b) a registration plate displaying a registration number or motor trade number issued by a registering authority in the Free State Province after 1 March 1997, may be as prescribed in paragraph (a): Provided that a registration plate displaying black letters and figures on a yellow retro-reflective surface, shall be valid for a period of two years from that date.



